(57) **CLAIM**

The ornamental design for a ceramic wear plate, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of the first embodiment of the ceramic wear plate.

FIG. 2 is a back-side view of the first embodiment of the ceramic wear plate shown in FIG. 1, the front-side being a mirror image thereof.

FIG. 3 is a right-side view of the first embodiment of the ceramic wear plate shown in FIG. 1, the left-side being a mirror image thereof.

FIG. 4 is a bottom view of the first embodiment of the ceramic wear plate shown in FIG. 1.

FIG. 5 is a side perspective view as seen from the top of the first embodiment of the ceramic wear plate shown in FIG. 1.

FIG. 6 is a side perspective view as seen from the bottom of the first embodiment of the ceramic wear plate shown in FIG. 1.

FIG. 7 is a detailed partial view of the corner of the ceramic wear plate shown in circle 7 of FIG. 5.

FIG. 8 is a top view of the second embodiment of a ceramic wear plate in accordance with my new design.

FIG. 9 is a back-side view of the second embodiment of the ceramic wear plate shown in FIG. 8, the front-side being a mirror image thereof.

FIG. 10 is a right-side view of the second embodiment of the ceramic wear plate shown in FIG. 8, the left-side being a mirror image thereof.

FIG. 11 is a bottom view of the second embodiment of the ceramic wear plate shown in FIG. 8.




FIG. 12 is a side perspective view as seen from the top of the second embodiment of the ceramic wear plate shown in FIG. 8.

FIG. 13 is a detailed partial view of the corner of the second embodiment of the ceramic wear plate shown in circle 13 of FIG. 12.

FIG. 14 is a side perspective view as seen from the bottom of the second embodiment of the ceramic wear plate shown in FIG. 8.

FIG. 15 is a top view of the third embodiment of a ceramic wear plate in accordance with my new design.

FIG. 16 is a back-side view of the third embodiment of the ceramic wear plate shown in FIG. 15, the front-side view being a mirror-image thereof.

FIG. 17 is a right-side view of the third embodiment of the ceramic wear plate shown in FIG. 15, the left-side view being a mirror image thereof.

FIG. 18 is a bottom view of the third embodiment of the ceramic wear plate shown in FIG. 15.

FIG. 19 is a side perspective view as seen from the top of the third embodiment of the ceramic wear plate shown in FIG. 15.

FIG. 20 is a detailed partial view of the corner of the second embodiment of the ceramic wear plate shown in circle 20 of FIG. 19; and,

FIG. 21 is a side perspective view as seen from the bottom of the third embodiment of the ceramic wear plate shown in FIG. 15.

The broken line shown in FIG. 21 is a contour line.
































