(57) **CLAIM**

We claim the ornamental design for a vehicle outside door handle, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vehicle outside door handle showing our new design;

FIG. 3 is an opposite end view thereof;

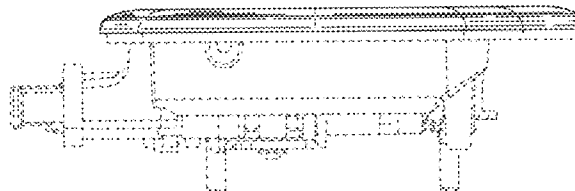
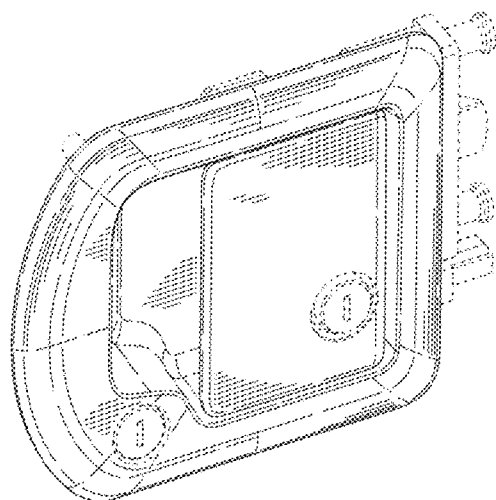
FIG. 4 is a side elevational view thereof;

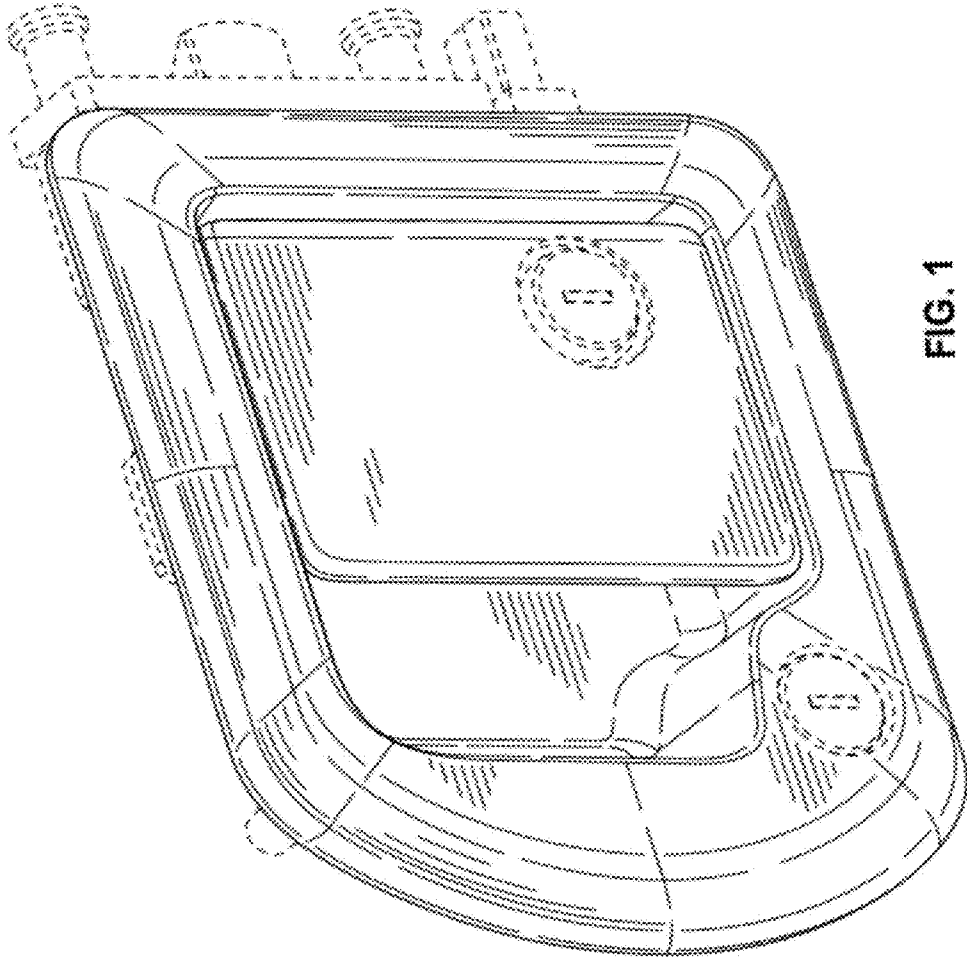

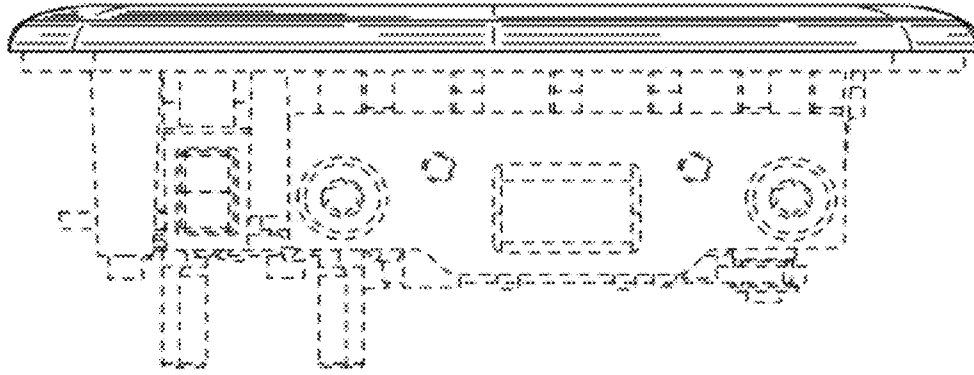

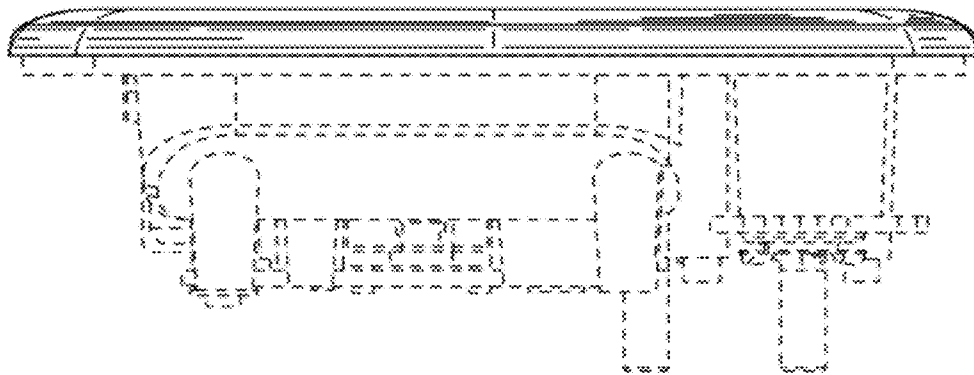

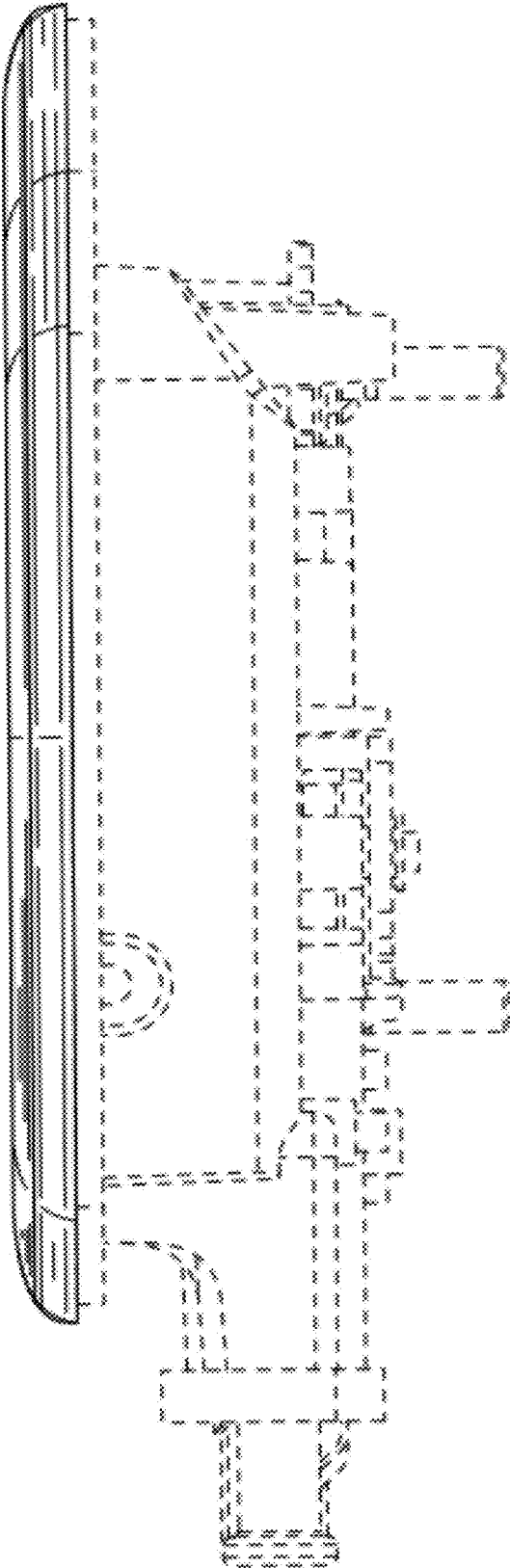

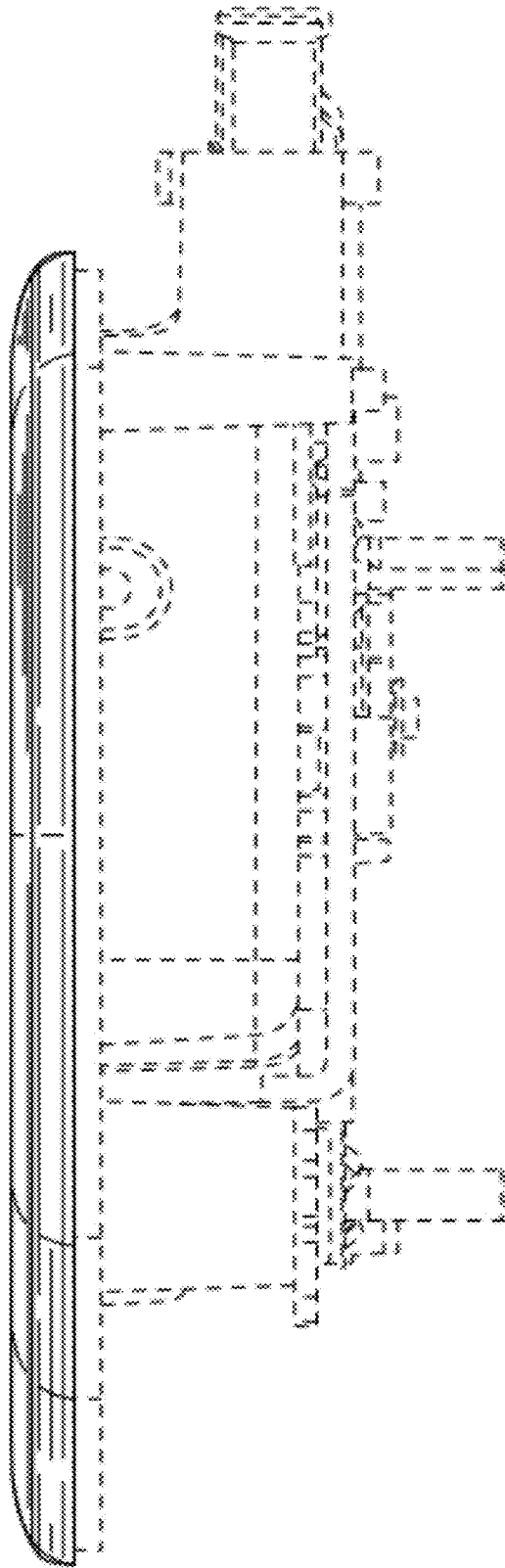

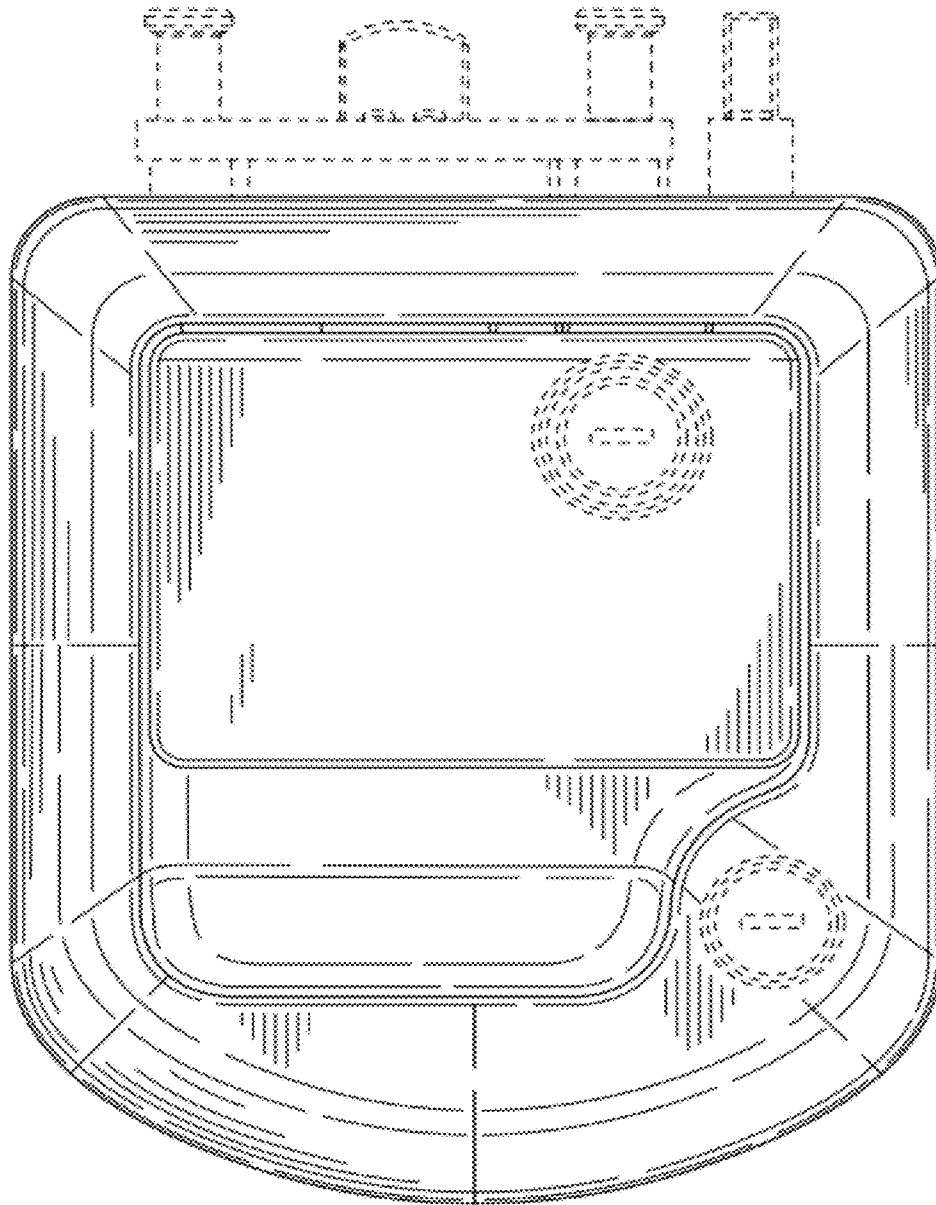
