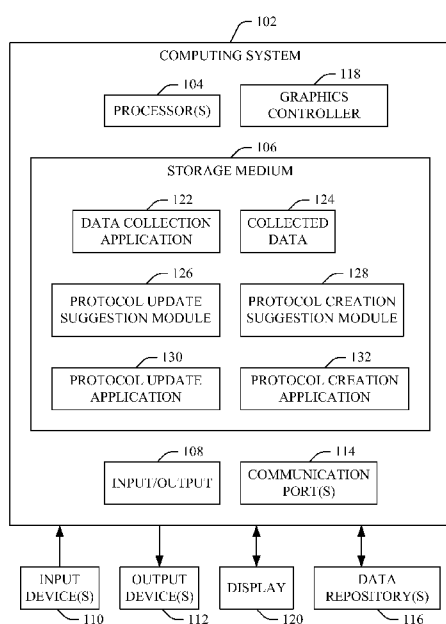

(57) **Abstract:** A method includes obtaining electronically formatted information about previously performed imaging procedures, classifying the information into groups of protocols based on initially selected protocols for the previously performed imaging procedures and generating data indicative thereof, identifying deviations between the classified information and the corresponding initially selected protocols for the previously performed imaging procedures, and generating a signal indicative of the deviations. A method includes recommending at least one of a plurality of protocols for an imaging procedure based on at least one of a score, a probability, or a pre-determined rule, which is based on extracted medical concepts from patient information and extracted medical concepts from previously imaged patient information, and generating a signal indicative of the recommendation.
