(57) **CLAIM**

The ornamental design for a side element of a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 2 is a side view of the side element of a shoe upper shown in FIG. 1;

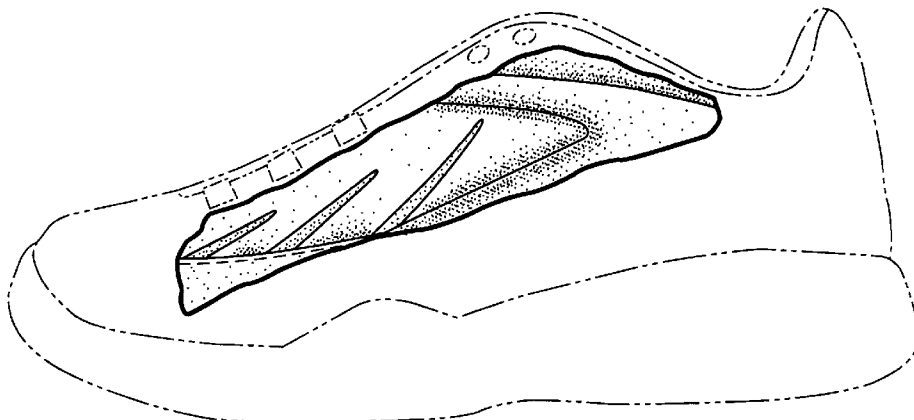
FIG. 3 is a rear view of the side element of a shoe upper shown in FIG. 1;

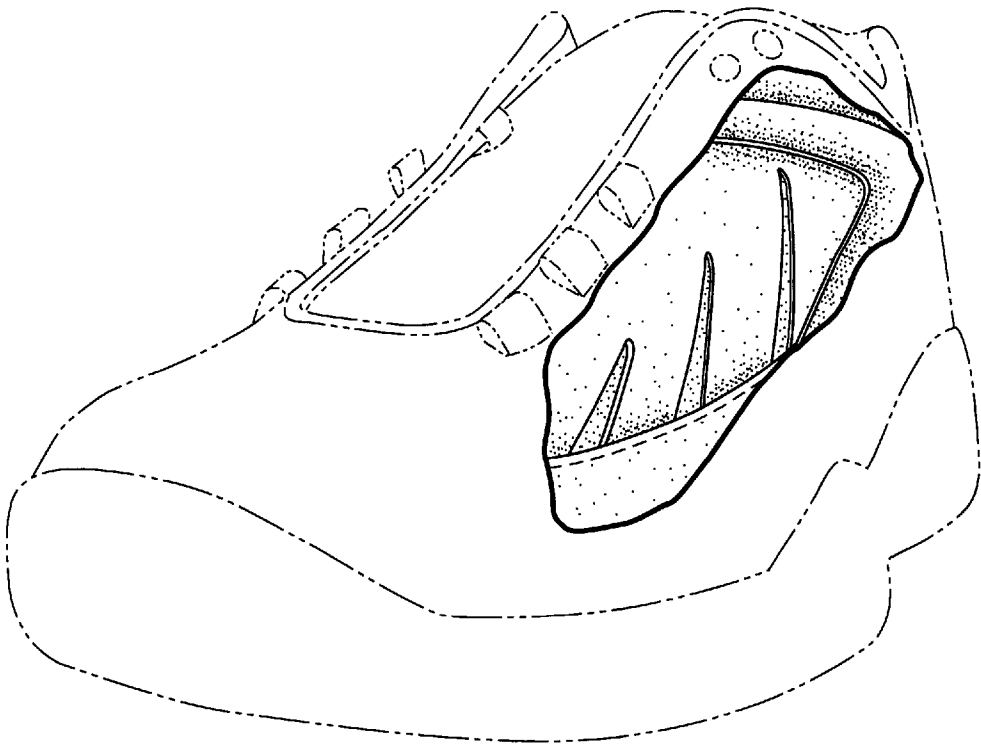
FIG. 4 is a front view of the side element of a shoe upper shown in FIG. 1; and,

FIG. 5 is a top view of the side element of a shoe upper shown in FIG. 1.

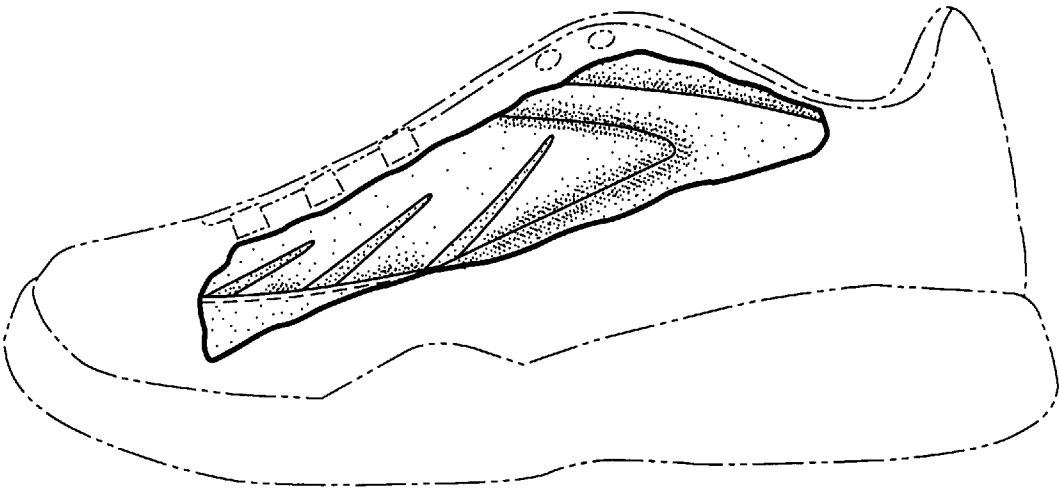
The phantom lines showing portions of a shoe in FIGS. 1–5 are for illustrative purposes only and form no part of the claimed design.

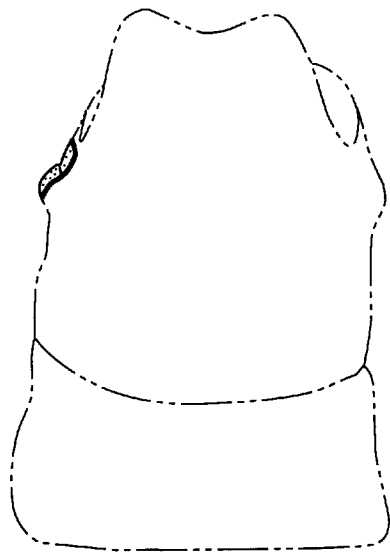




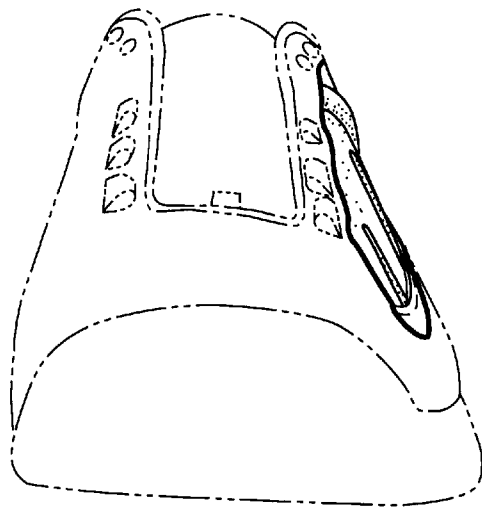

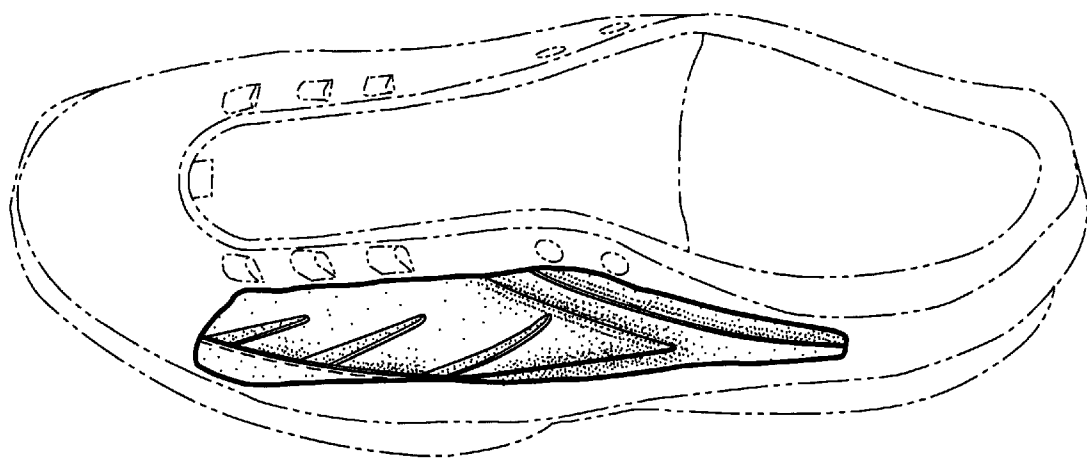
