[57] **CLAIM**

The ornamental design for a nail implement with detachable brush, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a nail implement with detachable brush showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a side elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is an exploded rear perspective view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a top view taken in the direction of line 8—8 of FIG. 5; and, FIG. 9 is a bottom view taken in the direction of line 9—9 of FIG. 5.

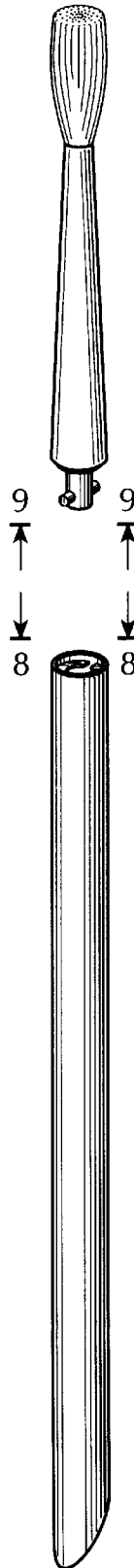
