
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an isometric view of a nut in accordance with the present invention;  
 FIG. 2 is an end view of the nut of FIG. 1;  
 FIG. 3 is a top plan view of the nut of FIG. 1;  
 FIG. 4 is a bottom plan view of the nut of FIG. 1;  
 FIG. 5 is a side elevational view of a first side of the nut of FIG. 1; and,  
 FIG. 6 is a side elevational view of a second side of the nut of FIG. 1.







