(57) **CLAIM**

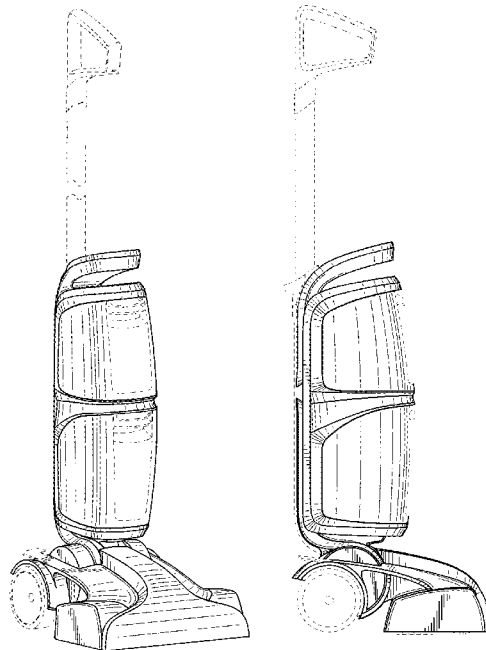
We claim the ornamental design for an upright vacuum cleaner, as shown and described.

DESCRIPTION

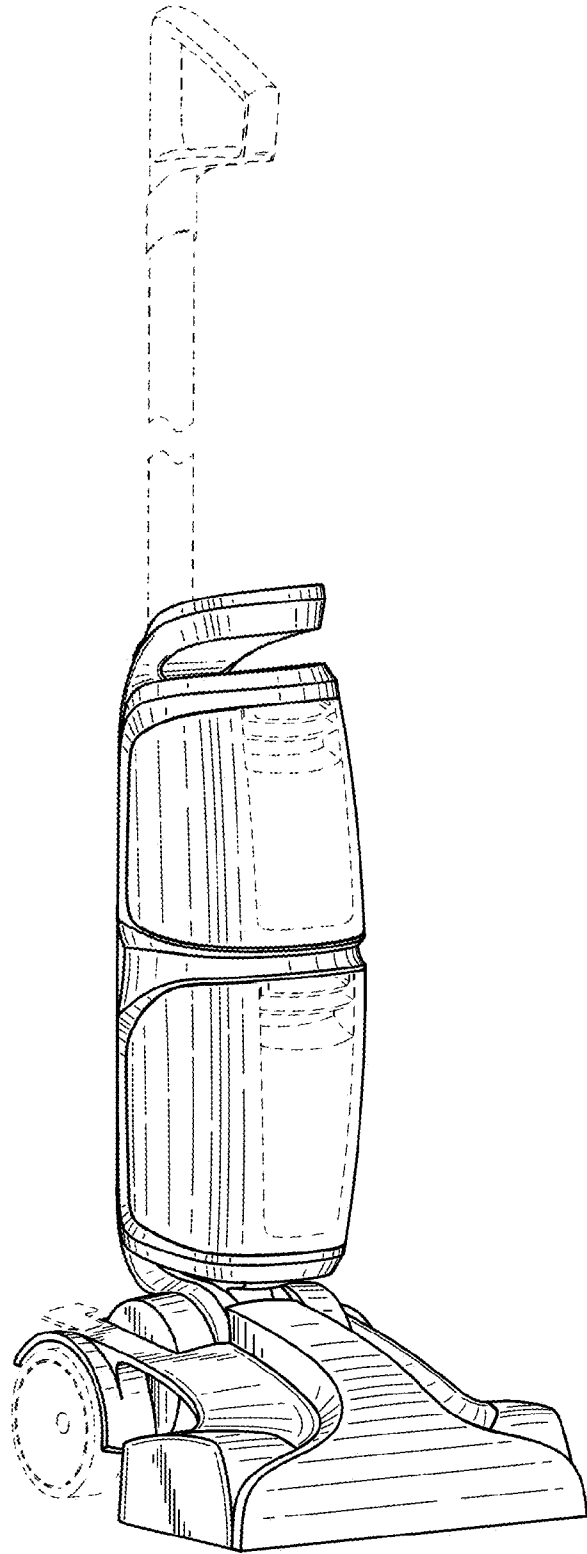

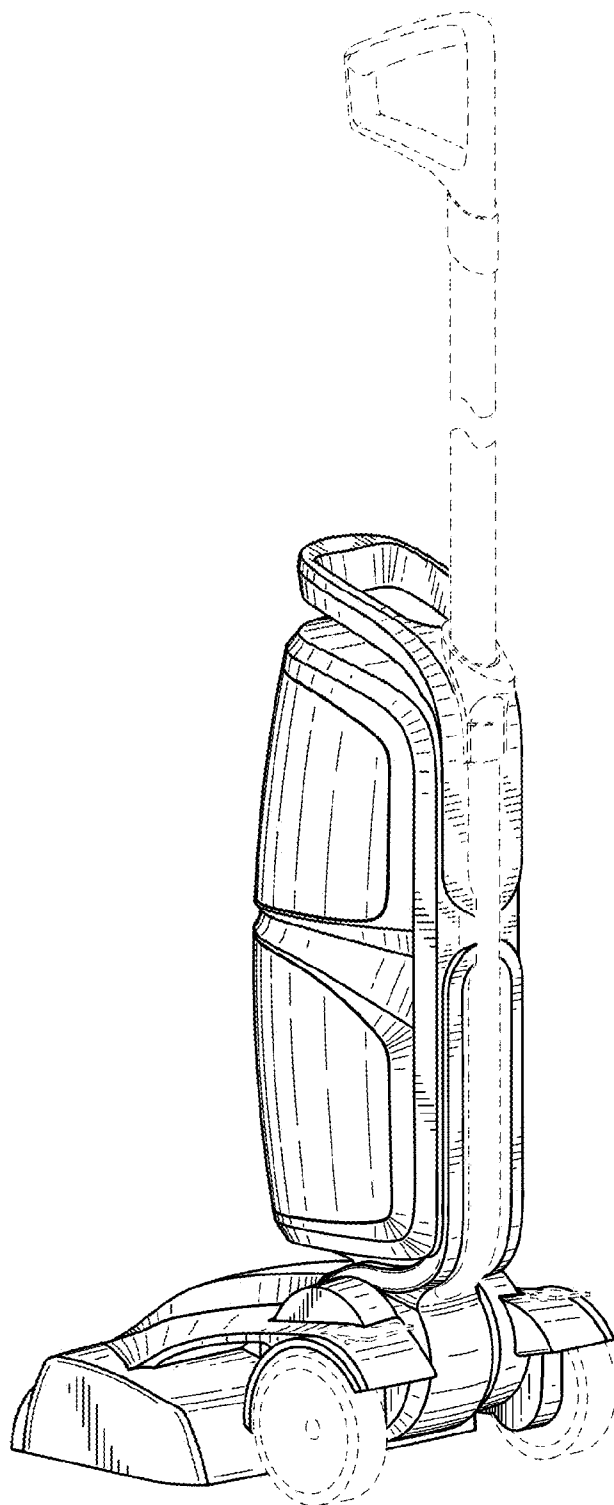

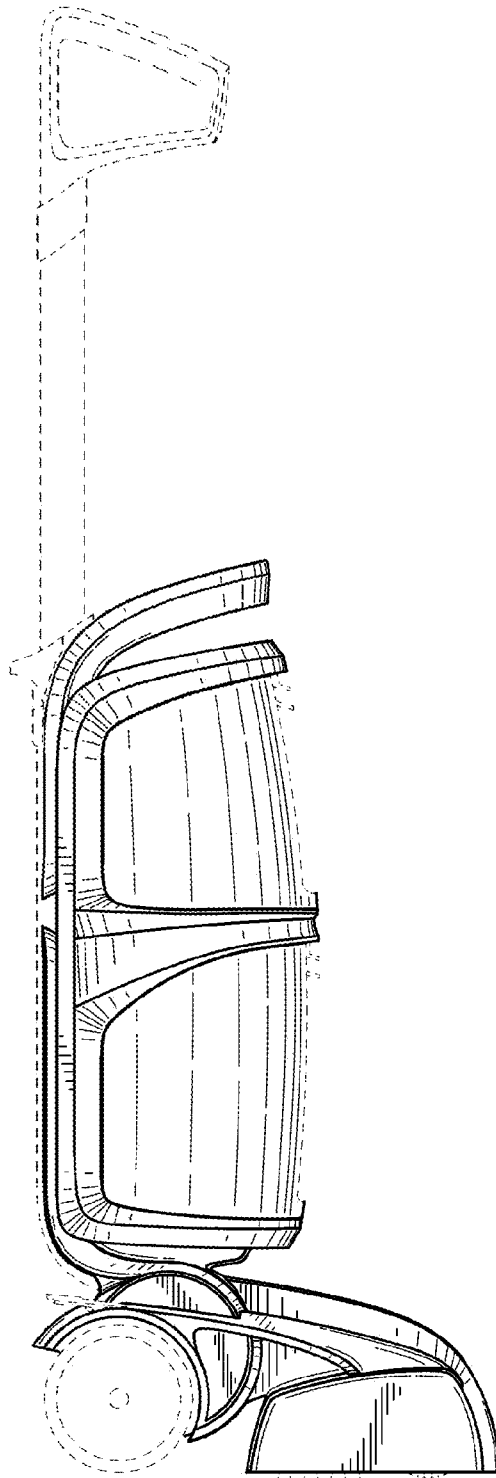

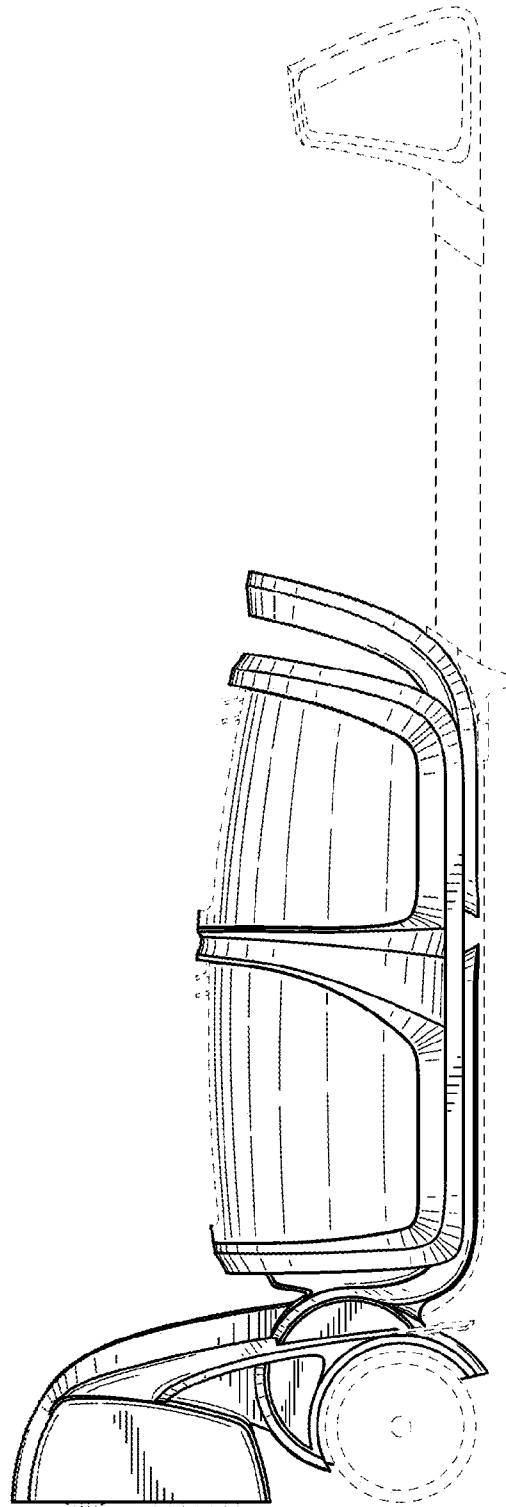

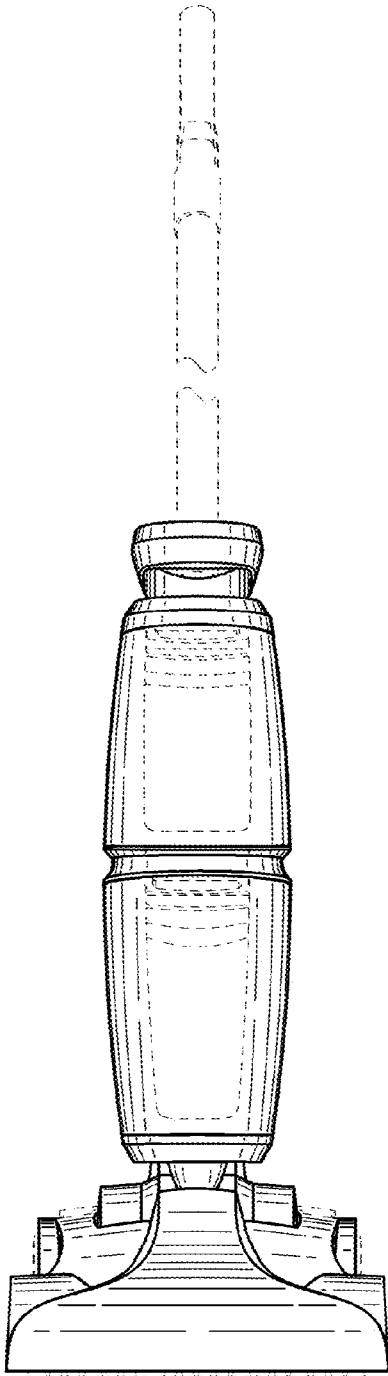

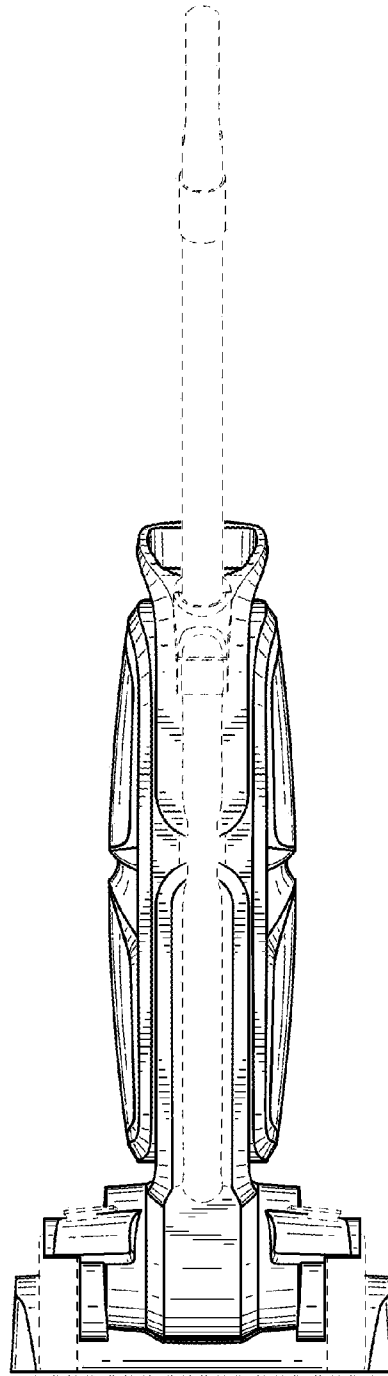

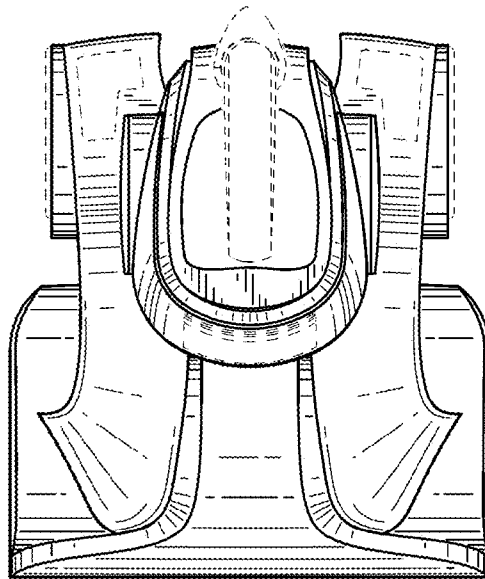
