
The ornamental design for a water cooler, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a water cooler of the present invention;
 FIG. 2 is a front elevation view thereof, the rear elevation view not shown, as it contains no claimed ornamental features;
 FIG. 3 is a right-side elevation view thereof;
 FIG. 4 is a left side elevation thereof;
 FIG. 5 is a top plan view thereof; and,












