(57) **CLAIM**

The ornamental design of a bottle-shaped pouch, as shown and described.

DESCRIPTION

The sole FIGURE is a front view of a bottle-shaped pouch, showing my new and ornamental design. The bottle-shaped pouch stores snack food including nuts. The entirety of the bottle-shaped pouch is the color brown. The sole FIGURE is lined for the color brown, as indicated by the diagonal lines traversing the bottle-shaped pouch. In the drawings, the features shown in broken lines form no part of the claimed design.
