The ornamental design for a point-of-sale terminal, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, top perspective view of a point-of-sale terminal showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a rear, right side, top perspective view thereof;

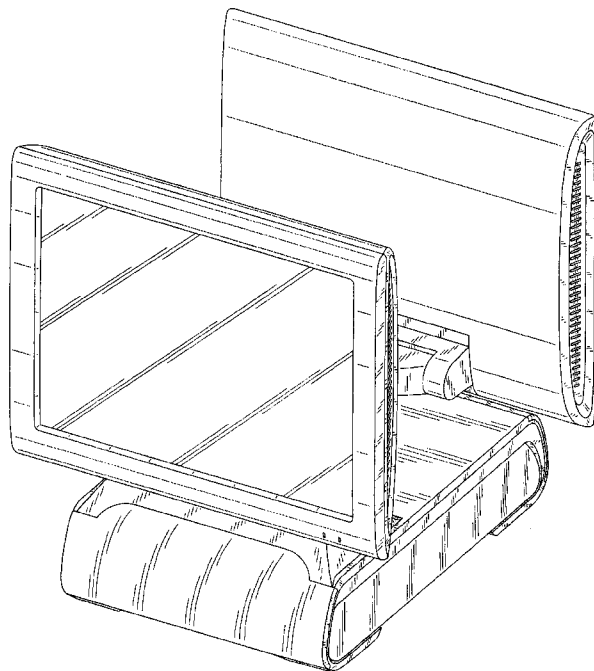
FIG. 9 is a right side view thereof in which display portions are moved;

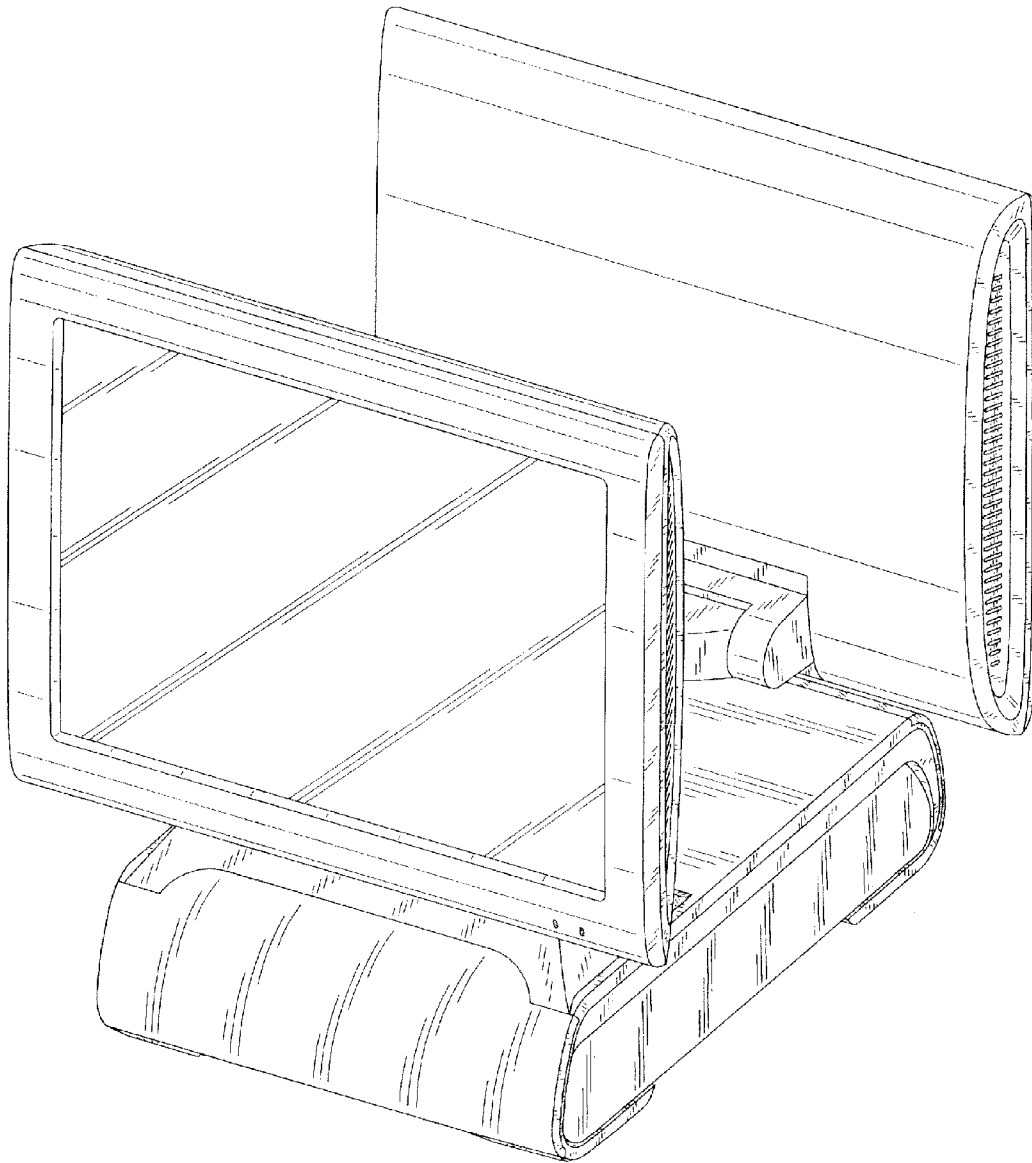

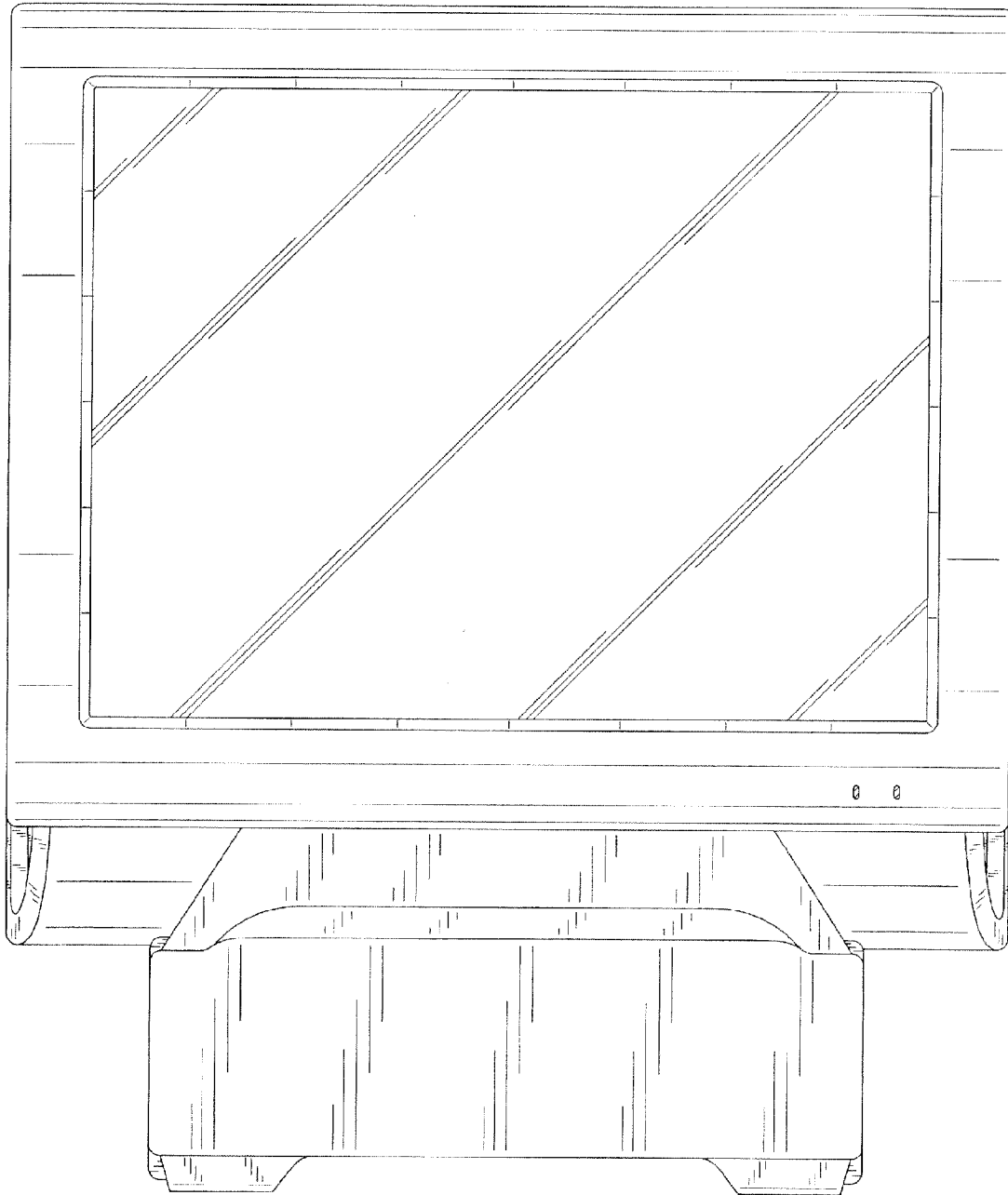

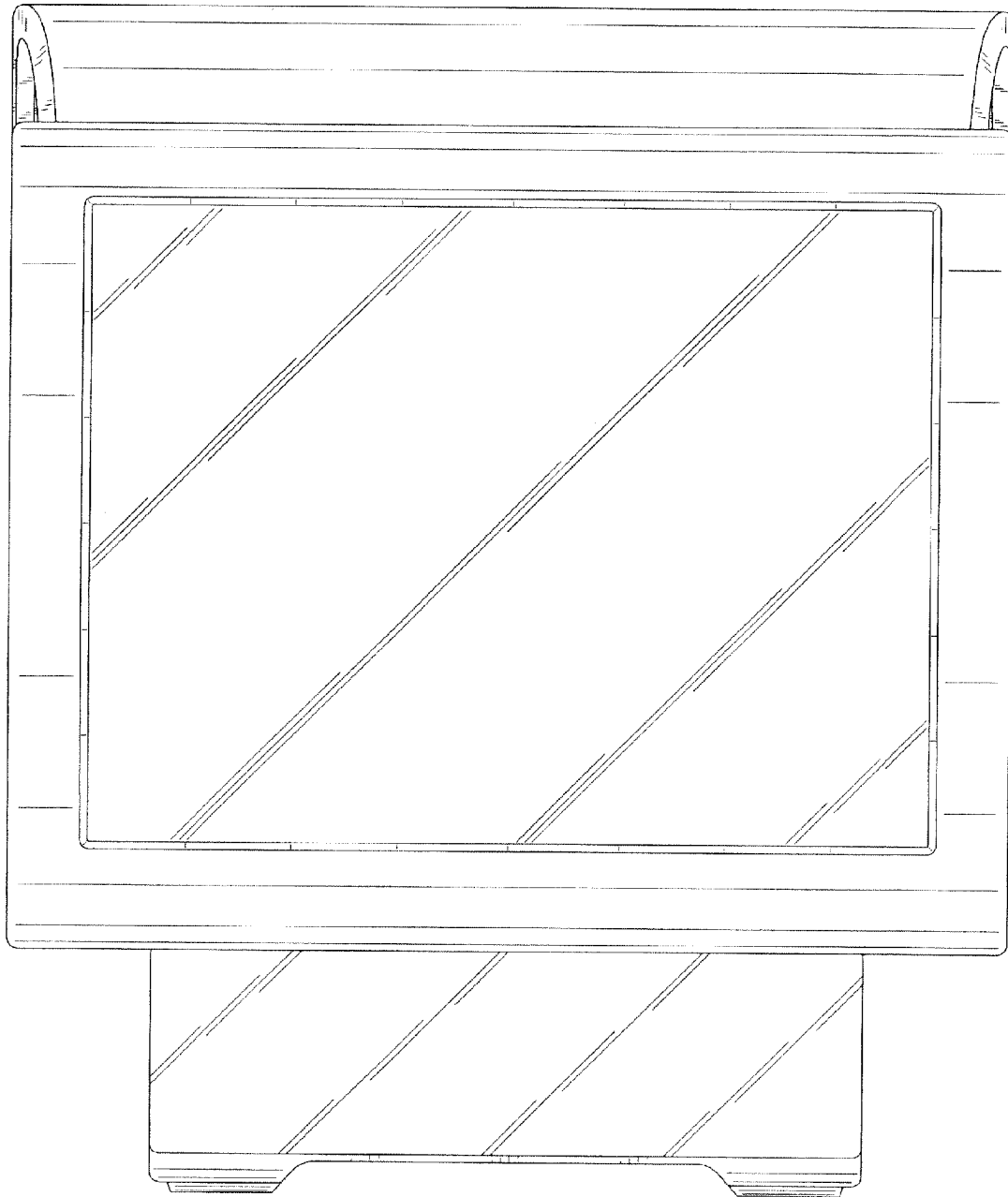

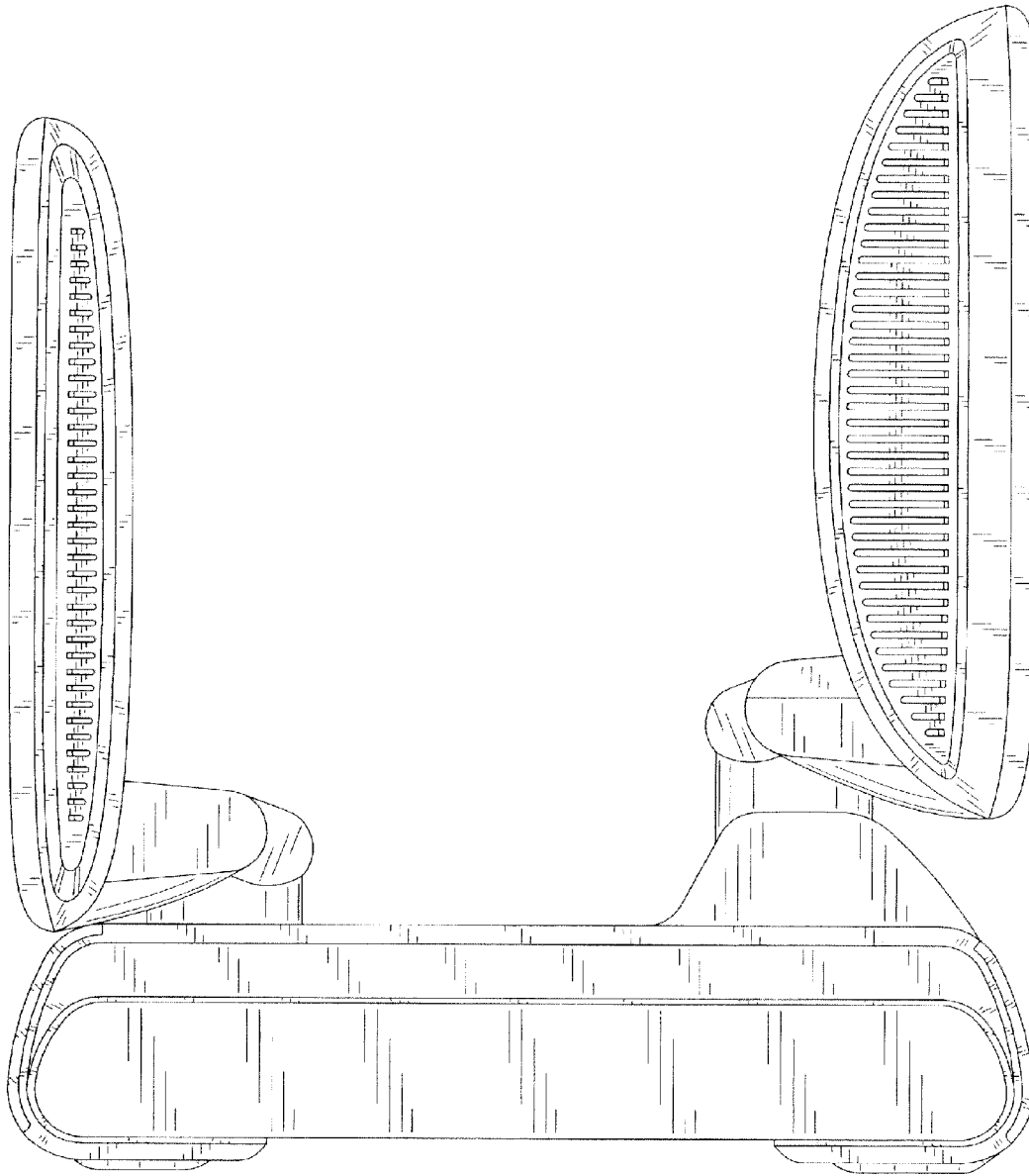

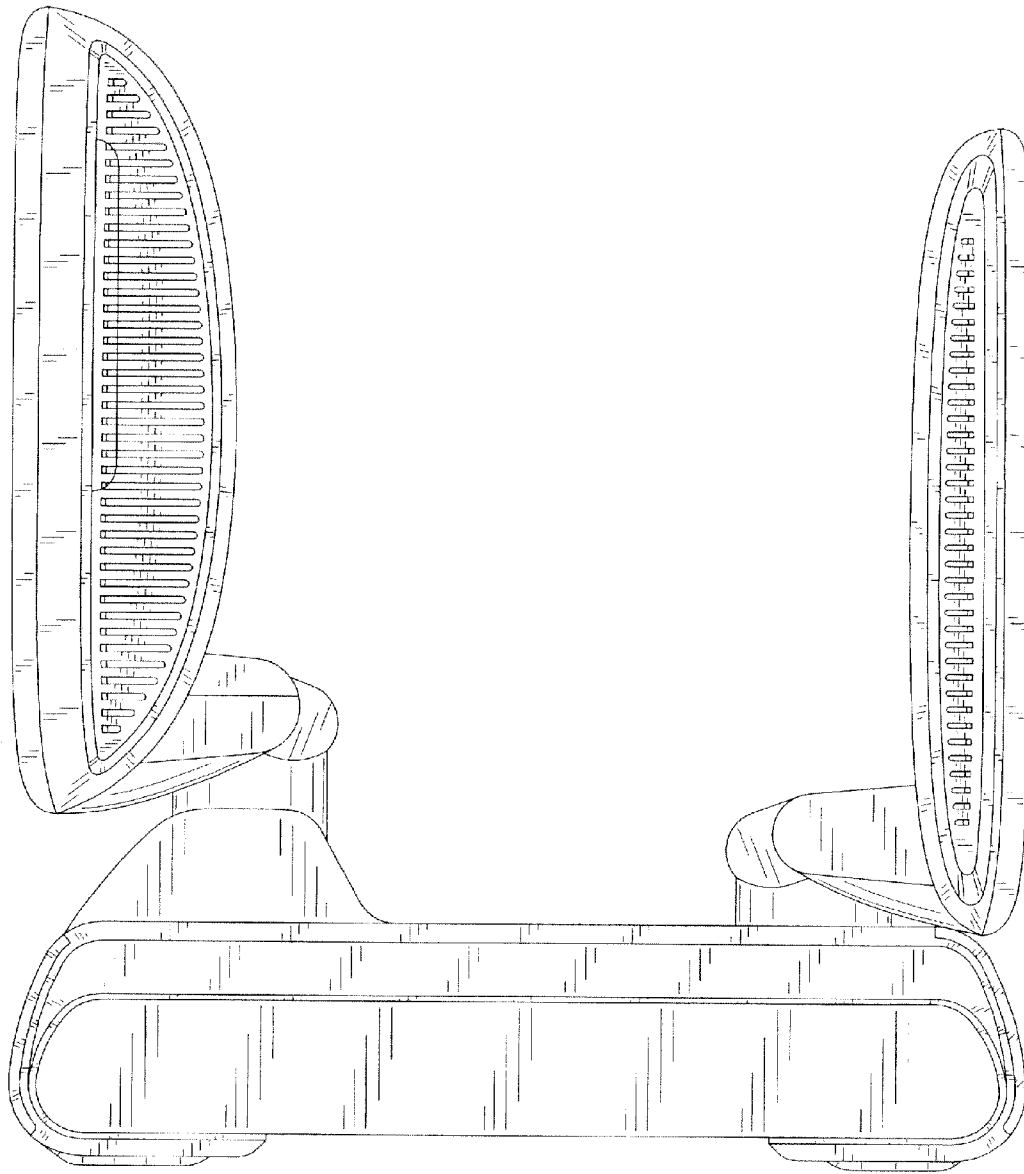

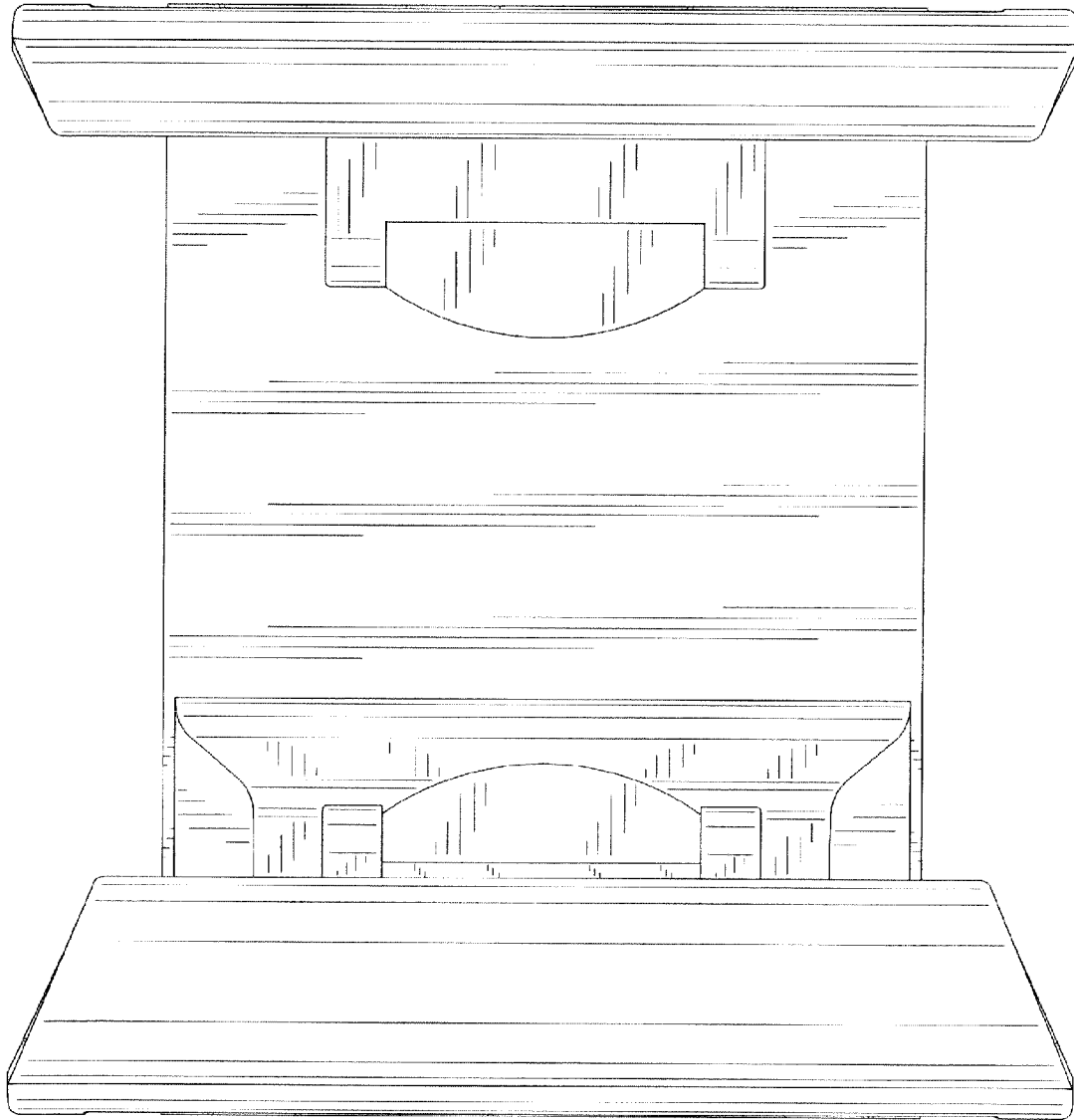

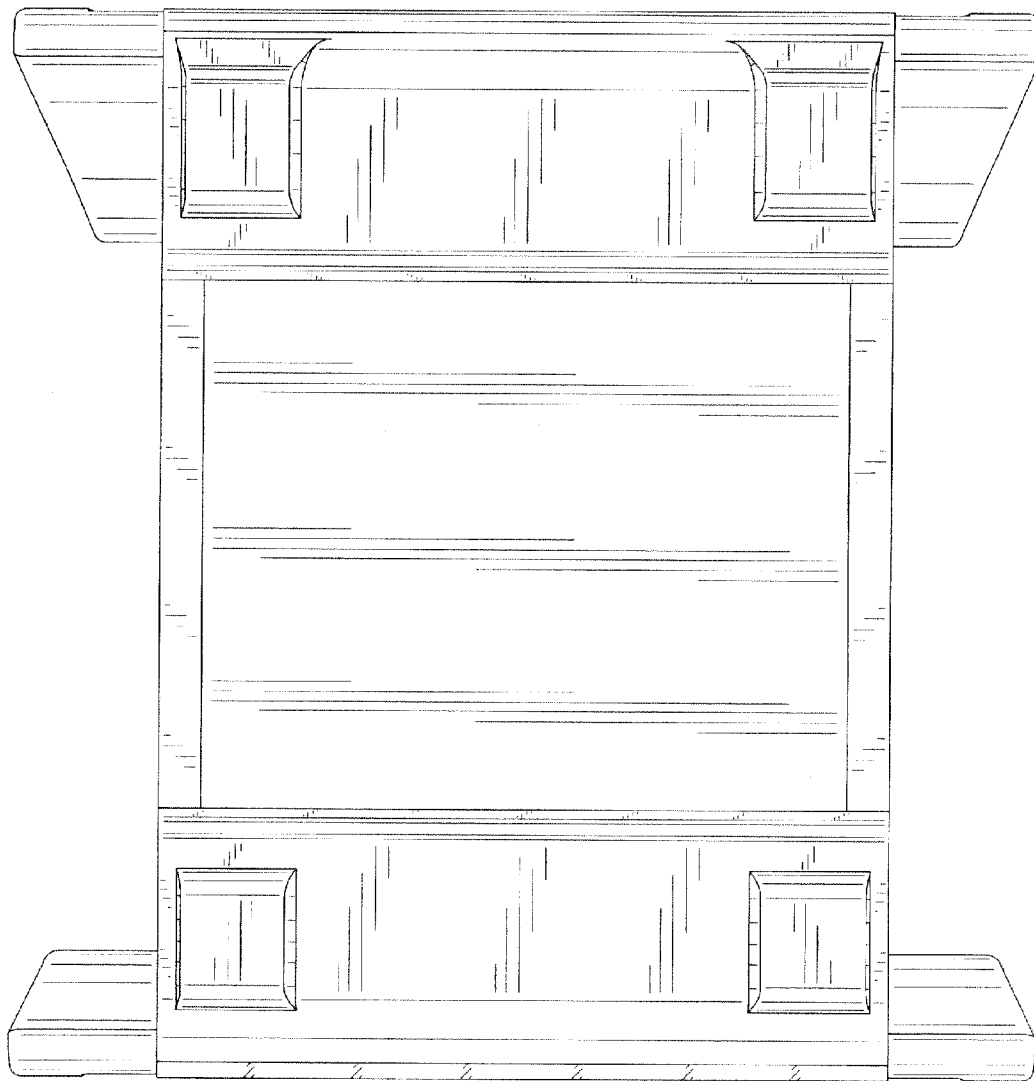

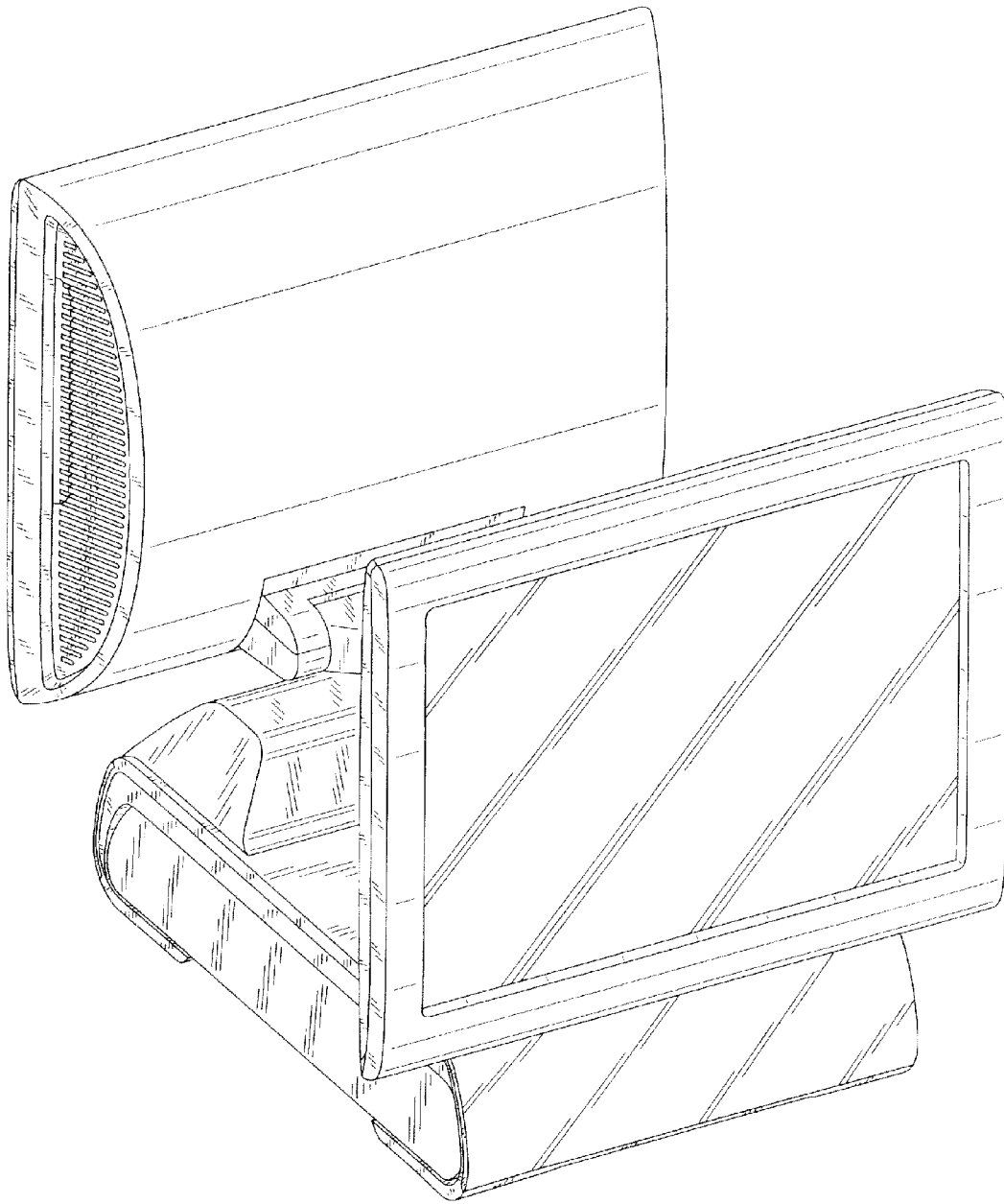

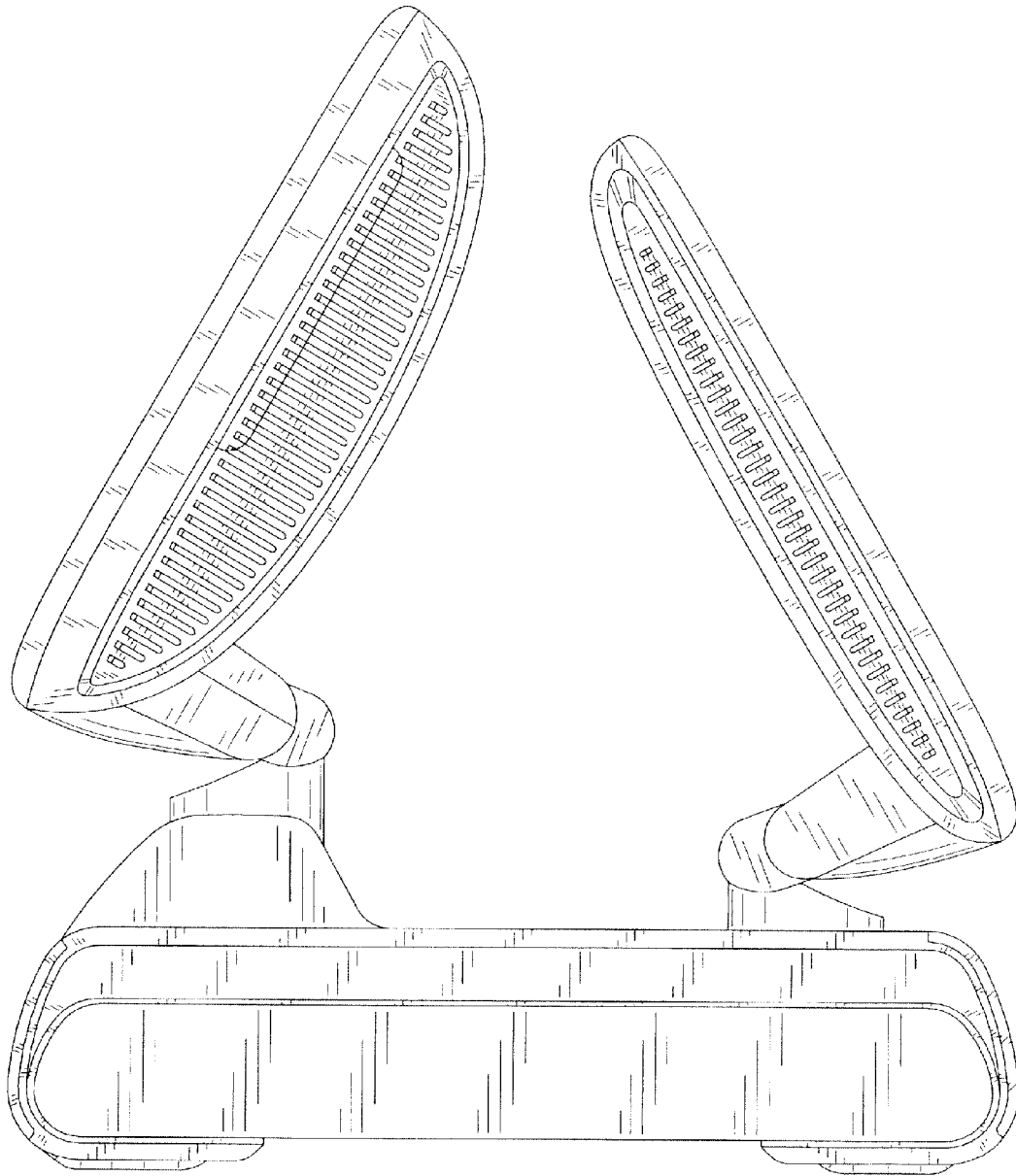

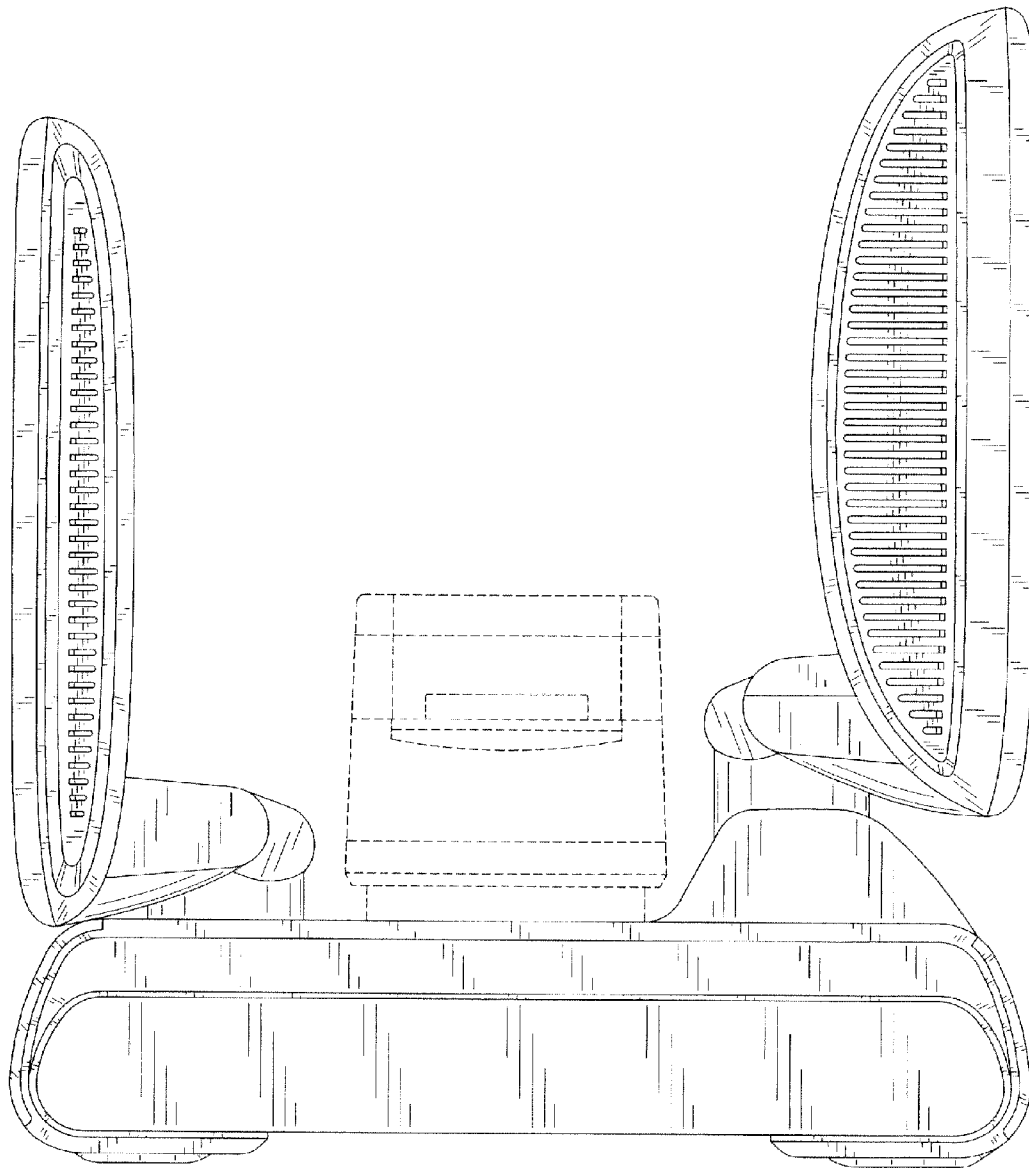

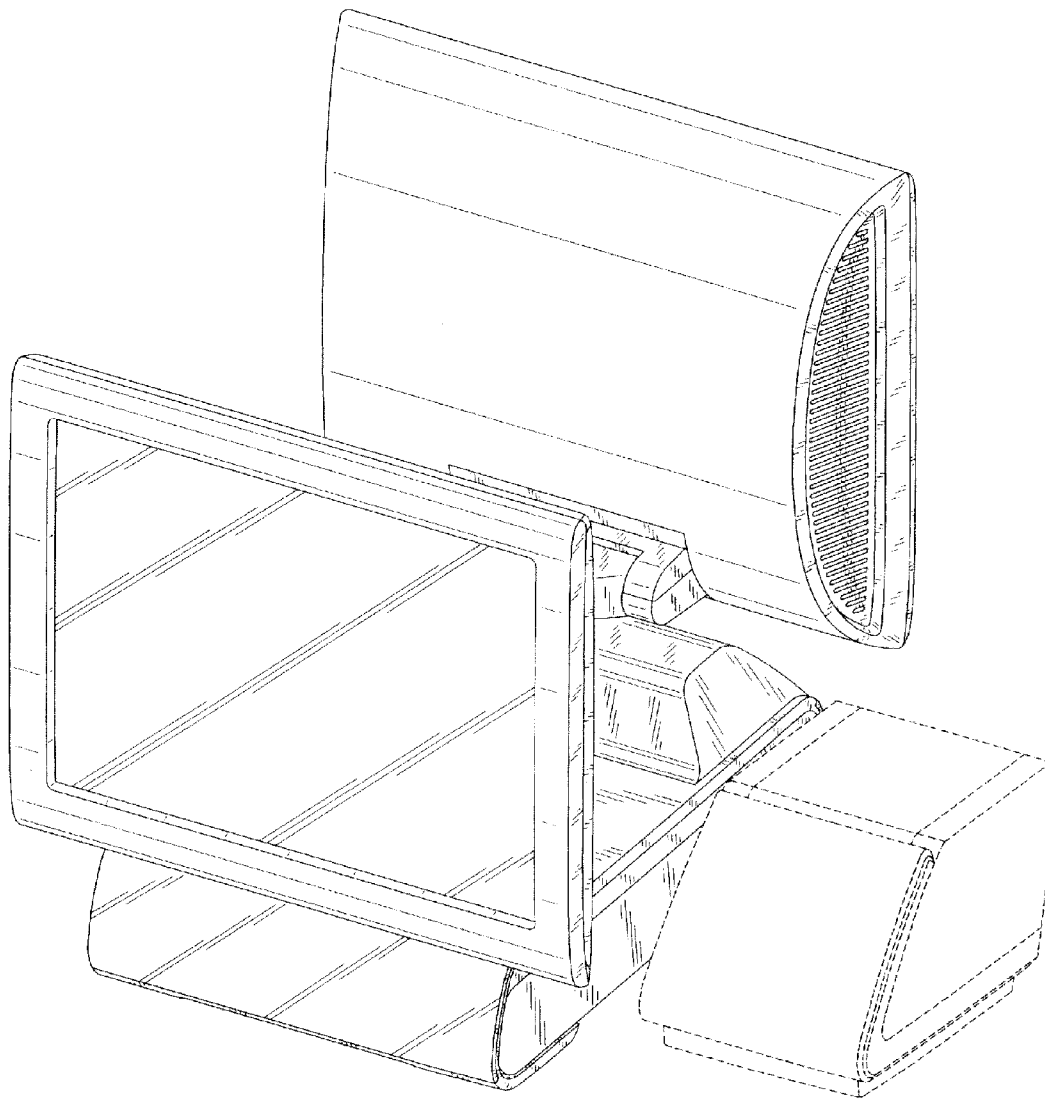
