**DESCRIPTION**

FIG. 1 is a perspective view of a mobile phone showing our new design;

FIG. 4 is a left side view thereof where the right side view is a mirror image;

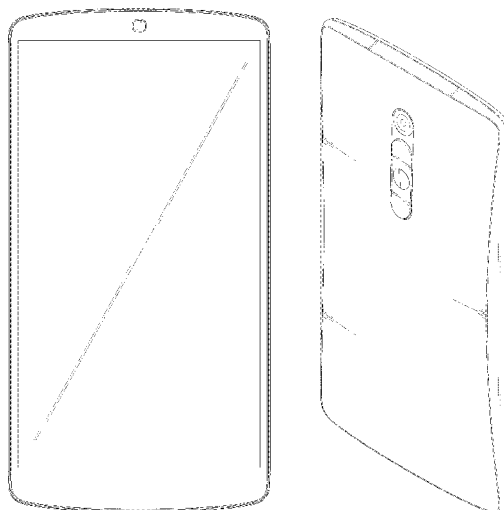
FIG. 5 is a top plan view thereof;

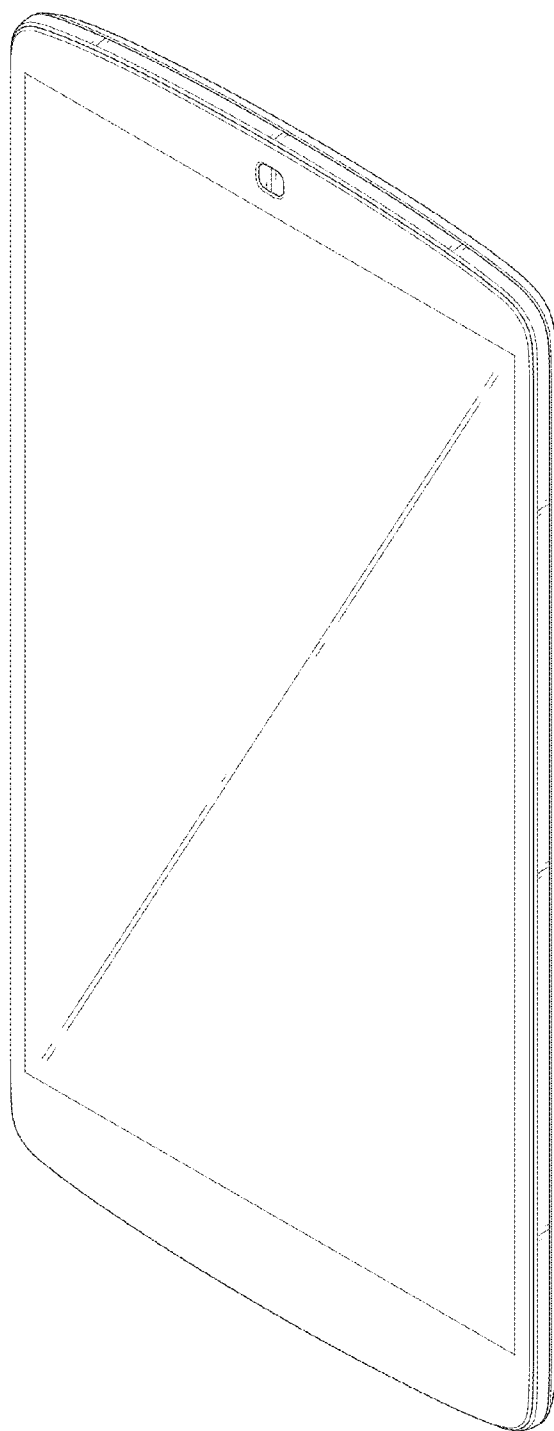

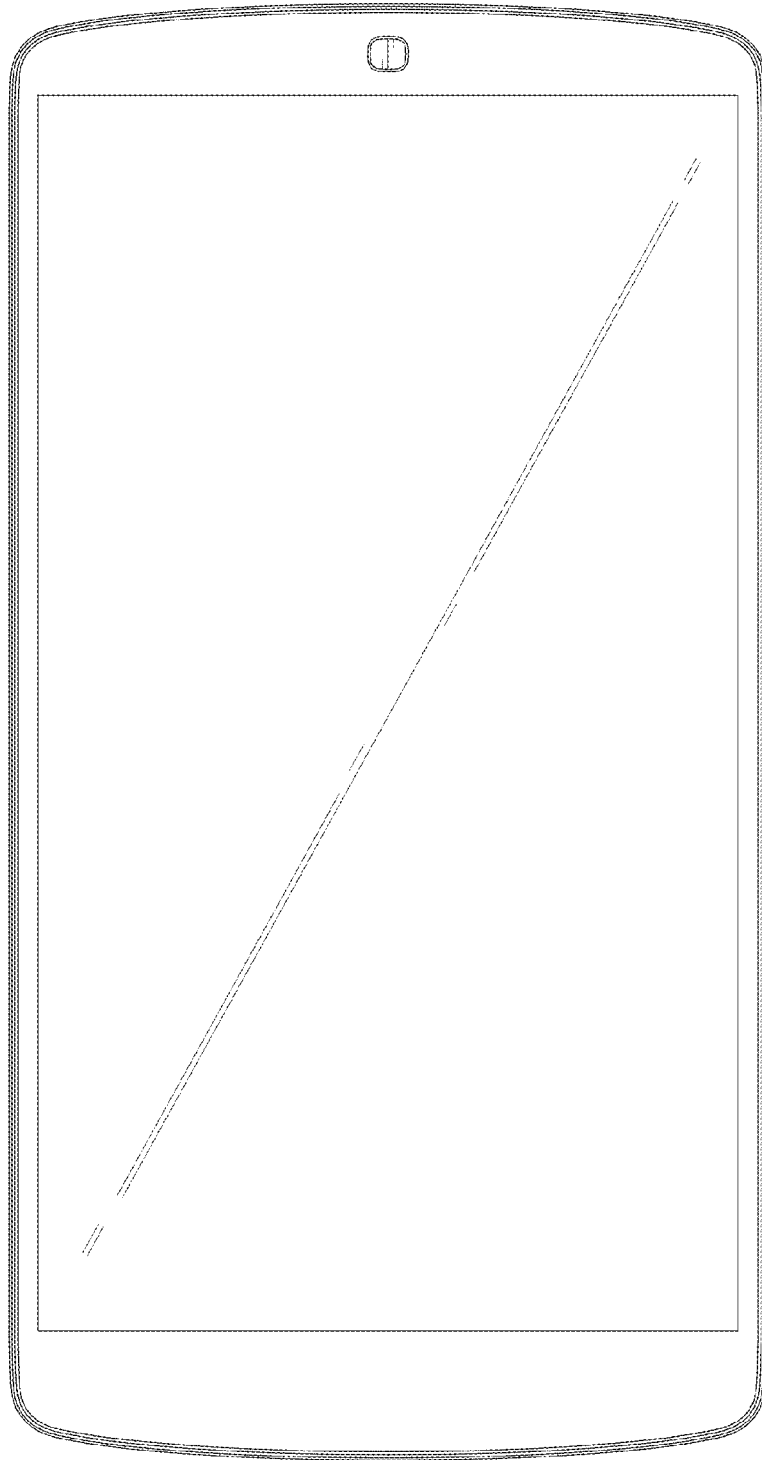

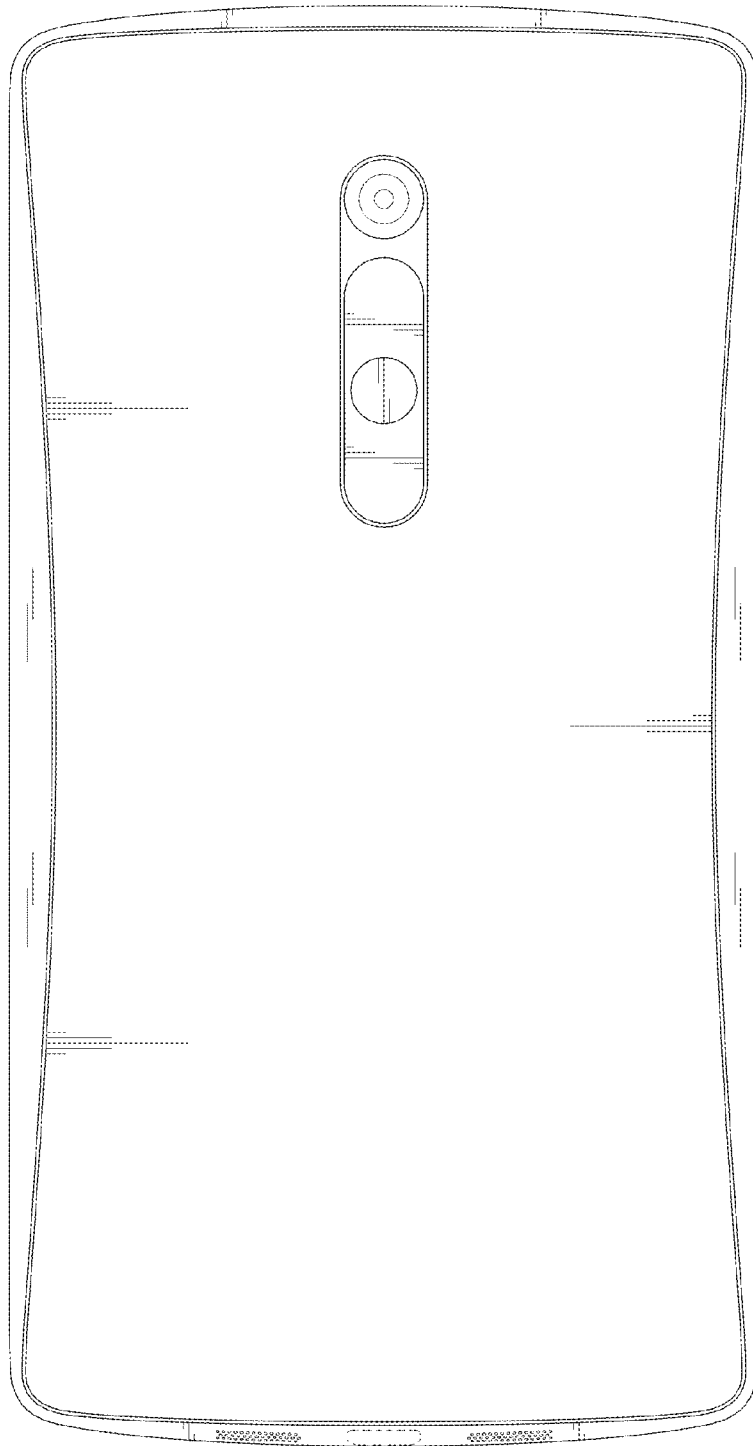

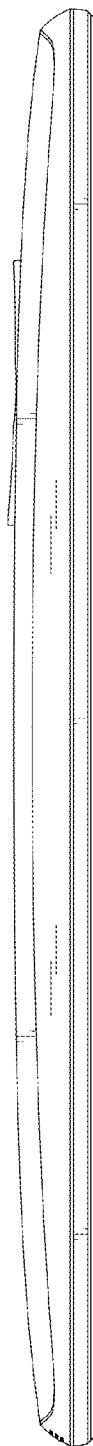

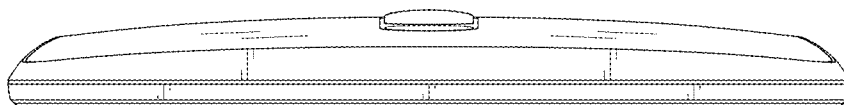
