We claim the ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 4 is a front side elevation view thereof;

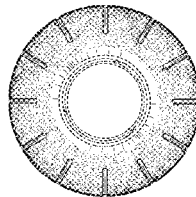
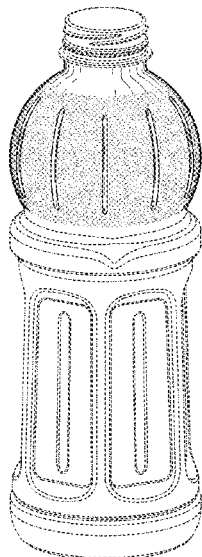
FIG. 5 is a rear elevation view thereof;

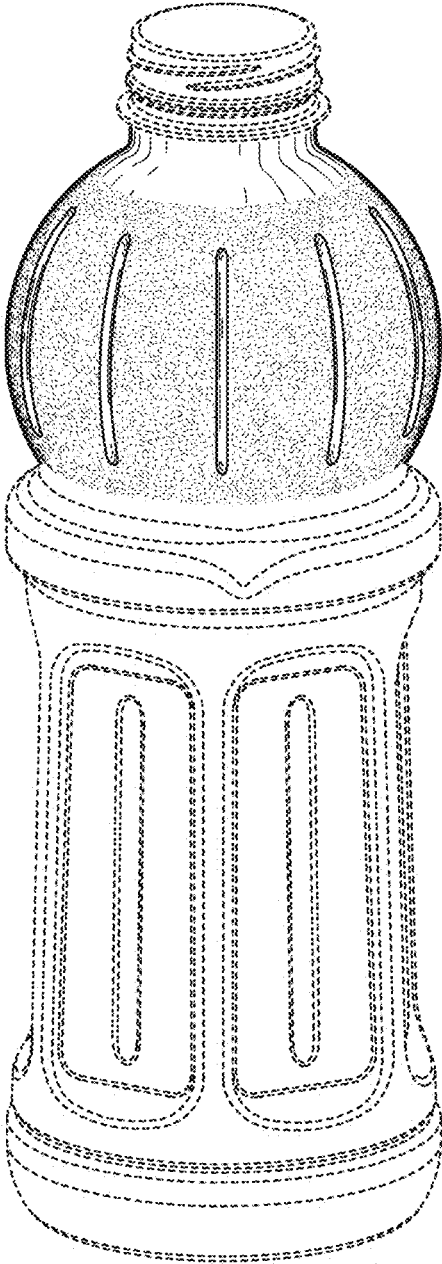

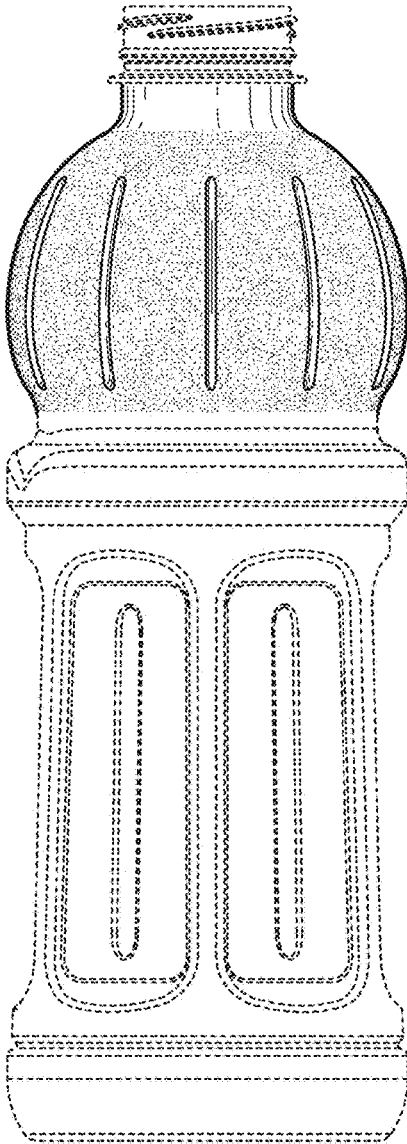

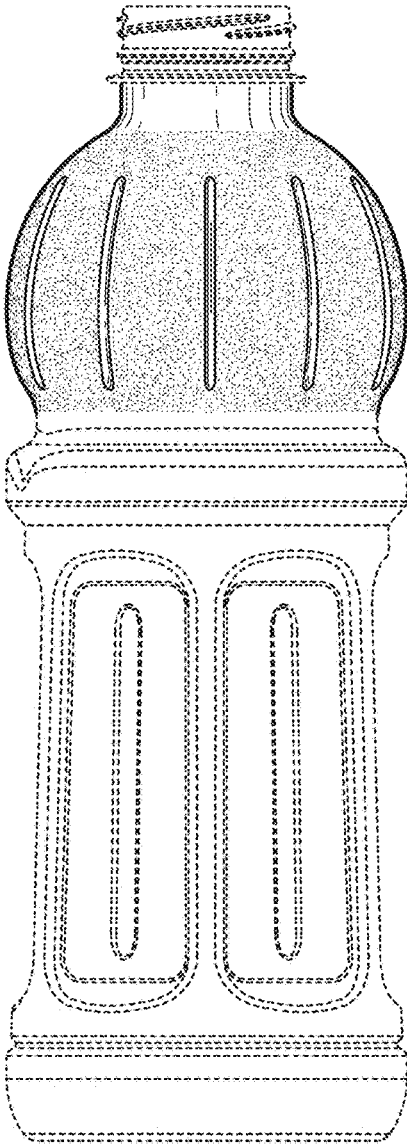

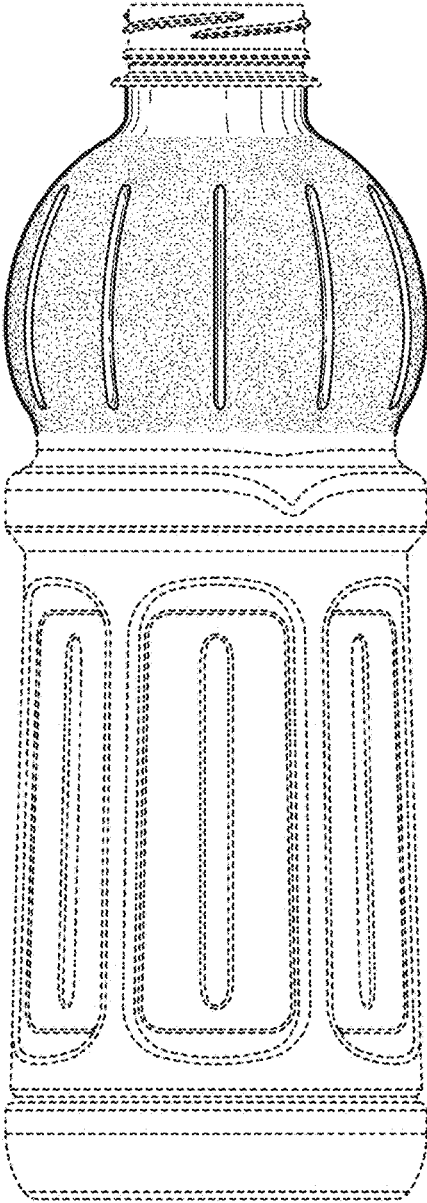

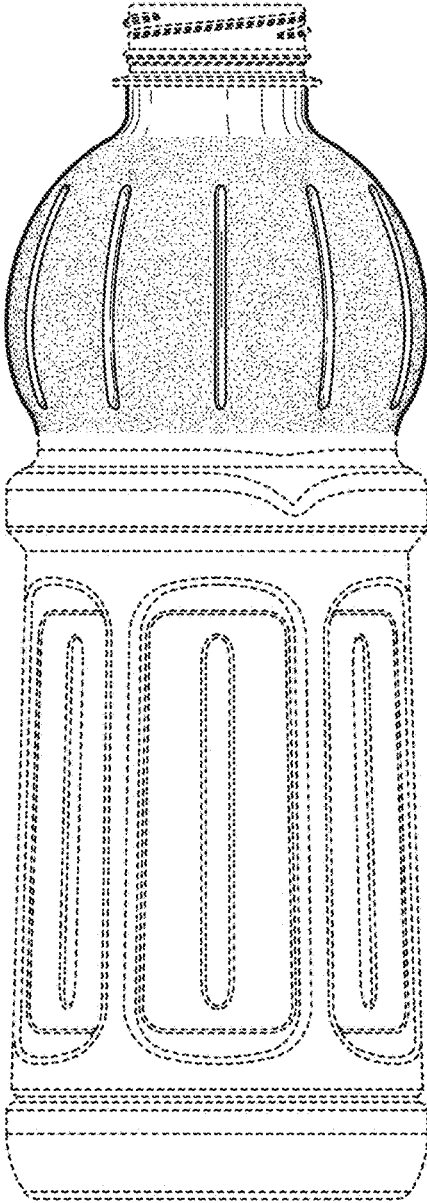
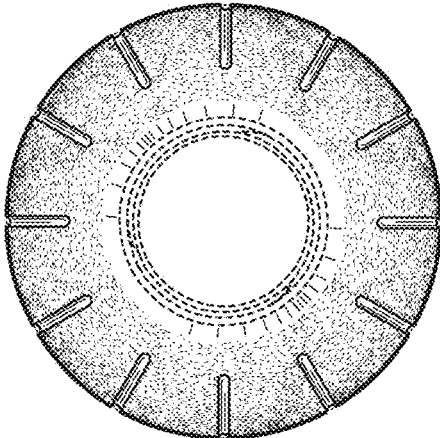
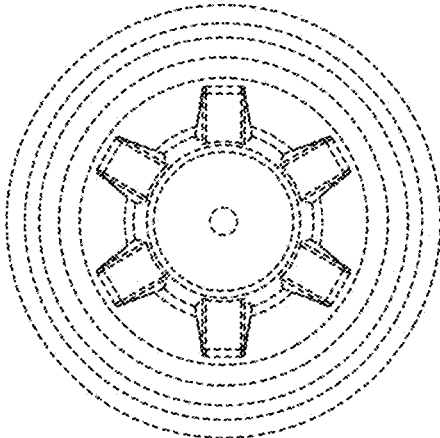
