DESCRIPTION

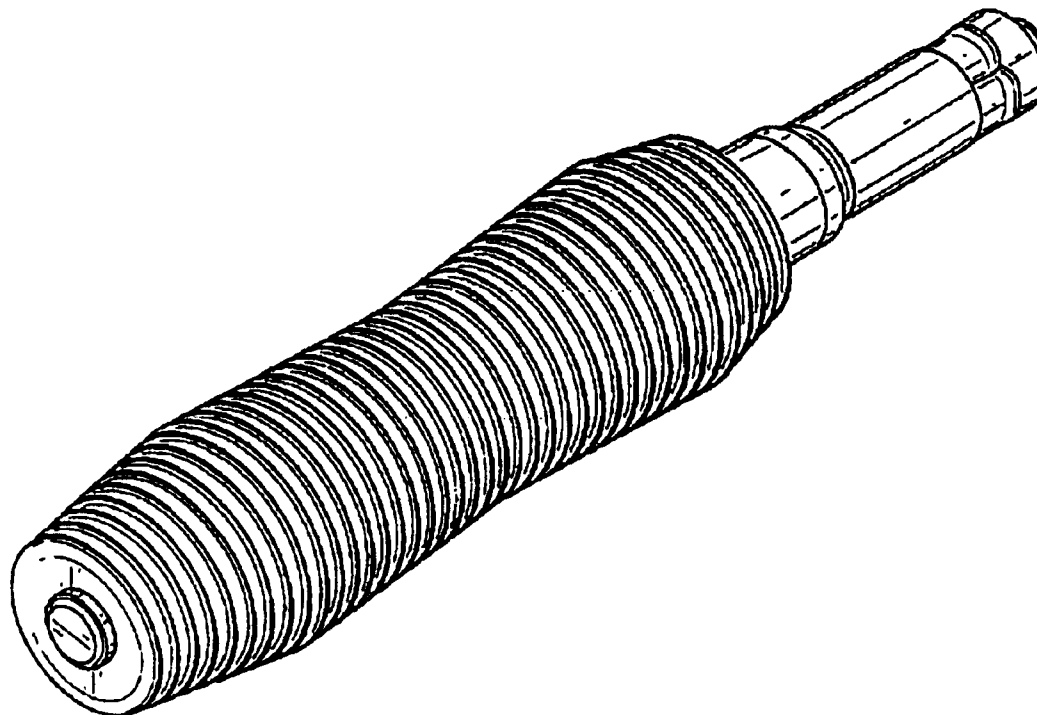
FIG. 1 is a top plan view of a cosmetic brush, showing our new design;

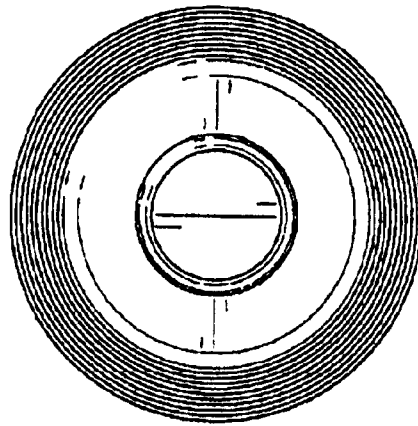

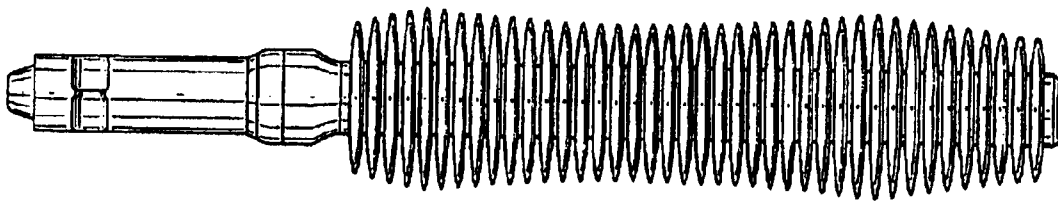

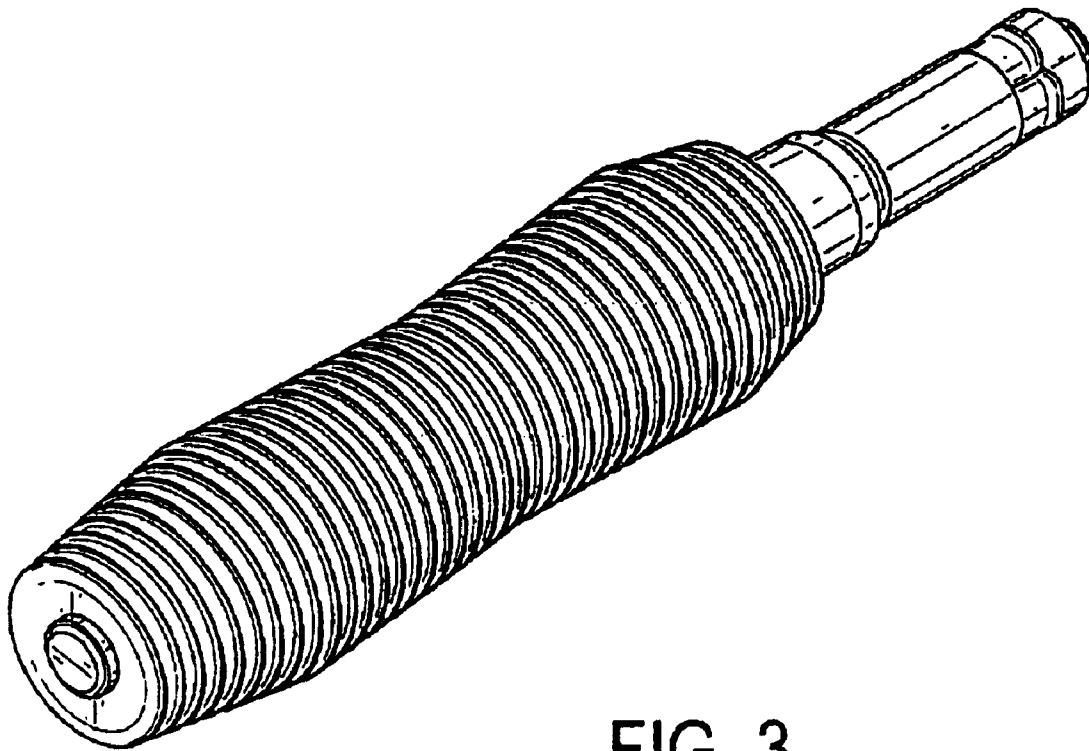
