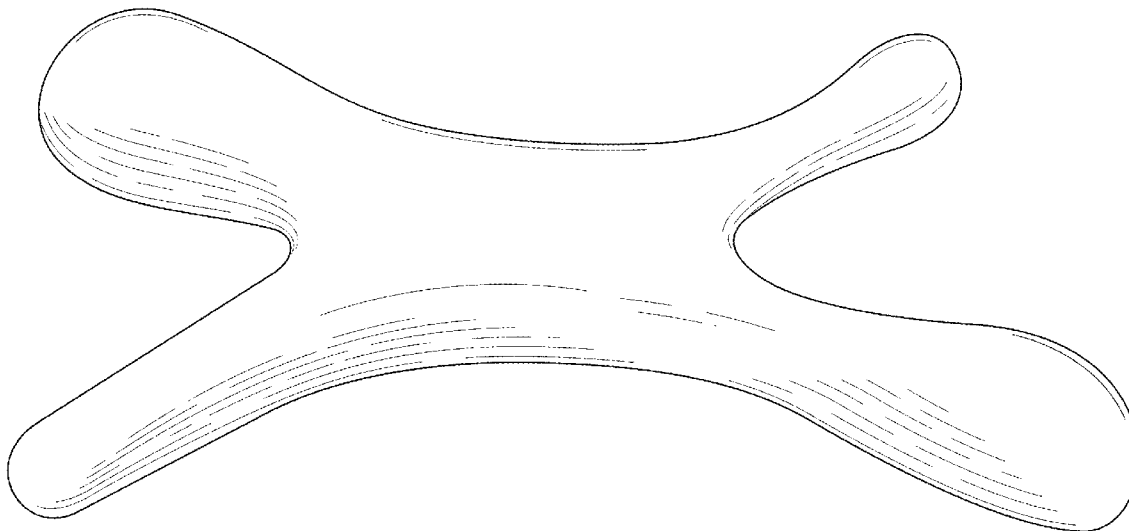
The ornamental design for a hand-held massage tool, as

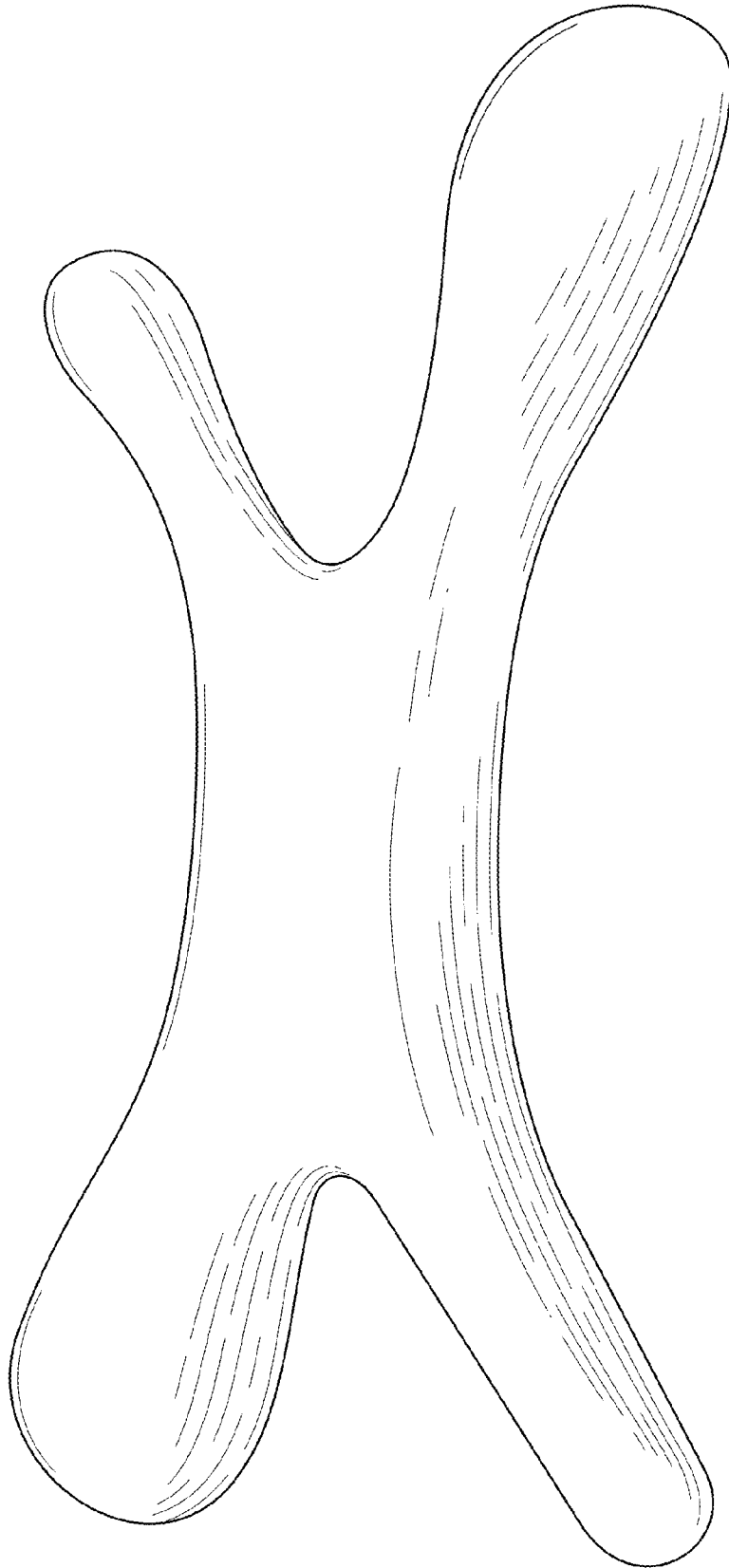

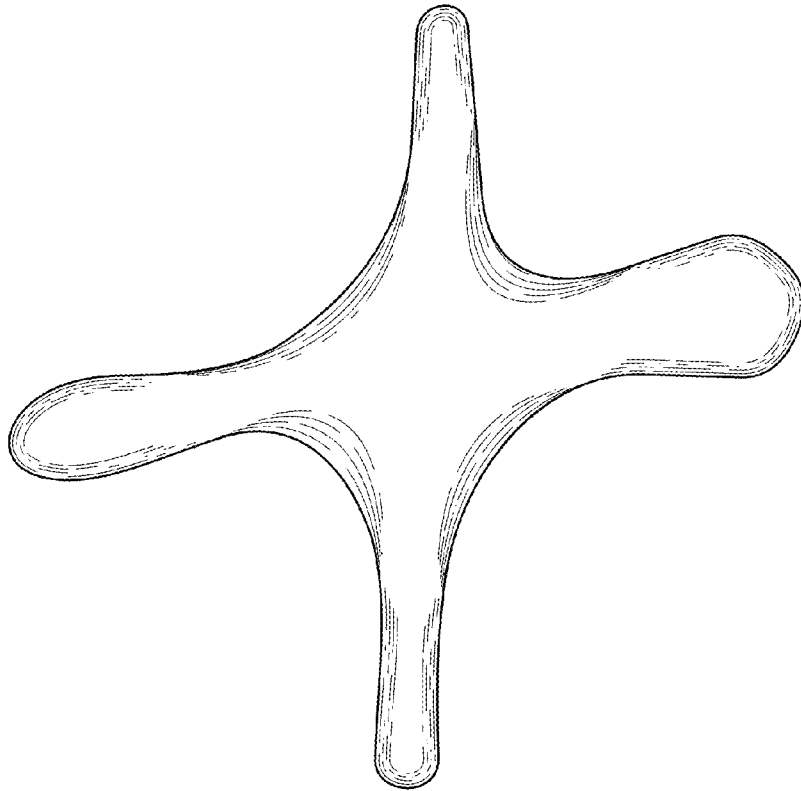

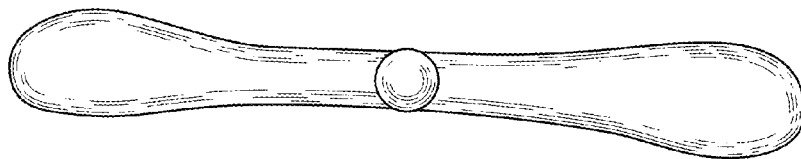

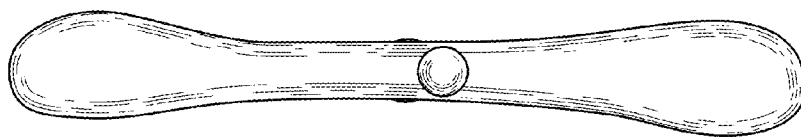

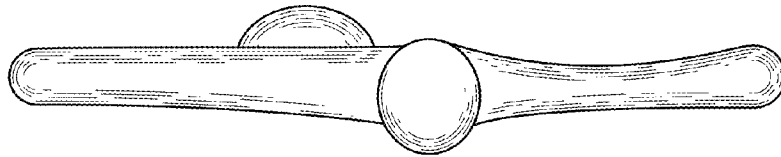

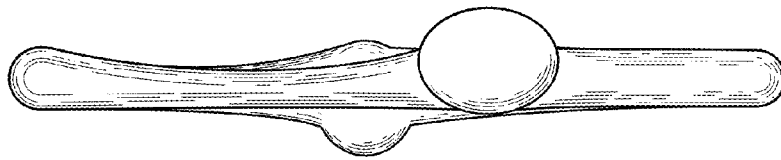

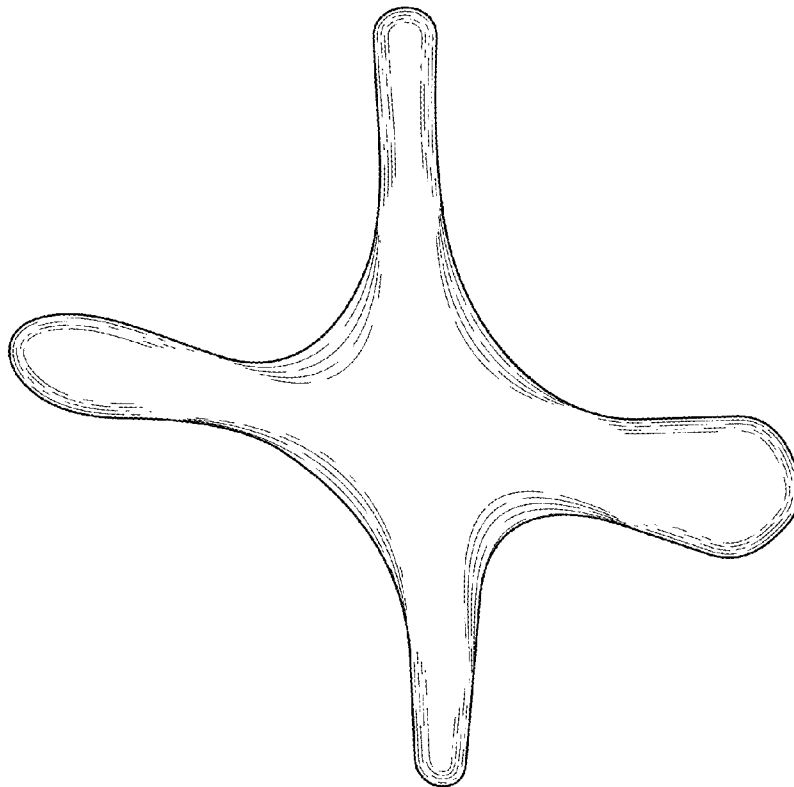
