(57) **CLAIM**

The ornamental design for a handle for an upright extractor, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of a handle for an upright extractor showing my new design;

FIG. 2 is a front view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a rear view thereof; and,

FIG. 6 is a top plan view thereof.












