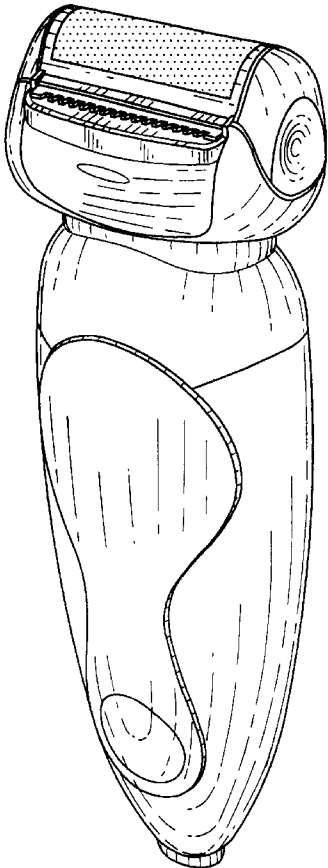
The ornamental design for a shaver, as shown.

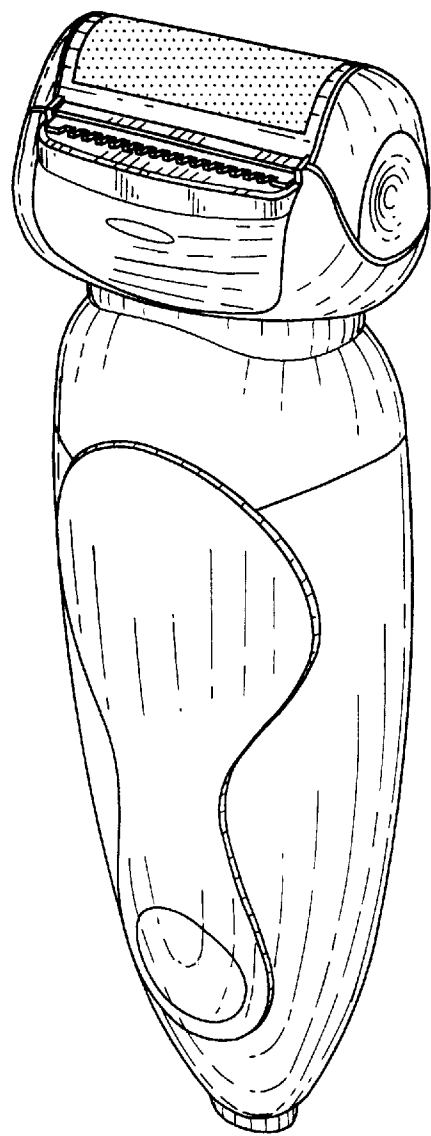

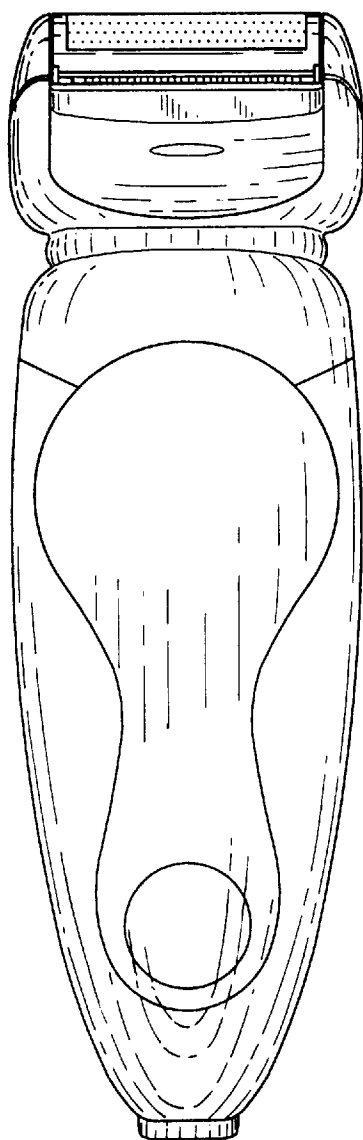

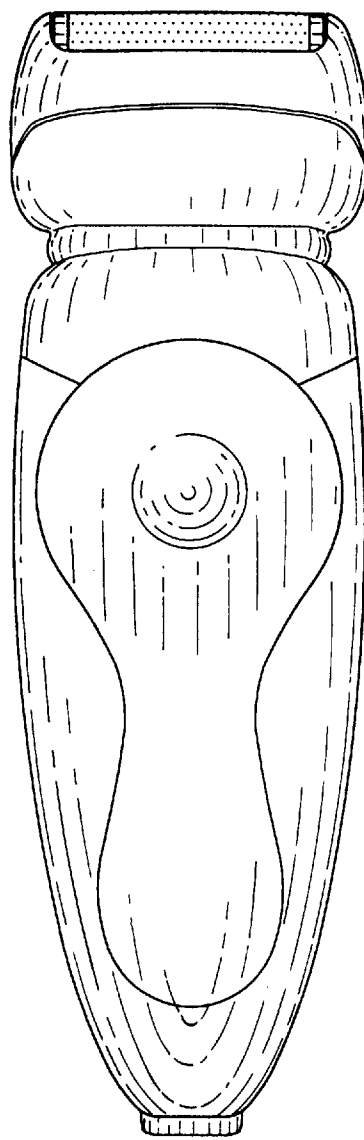

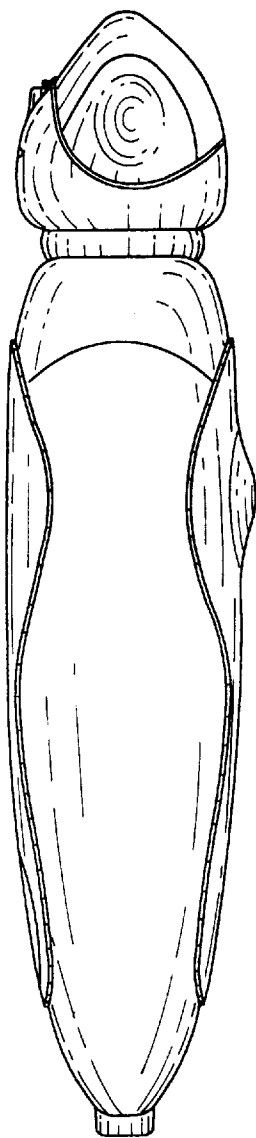

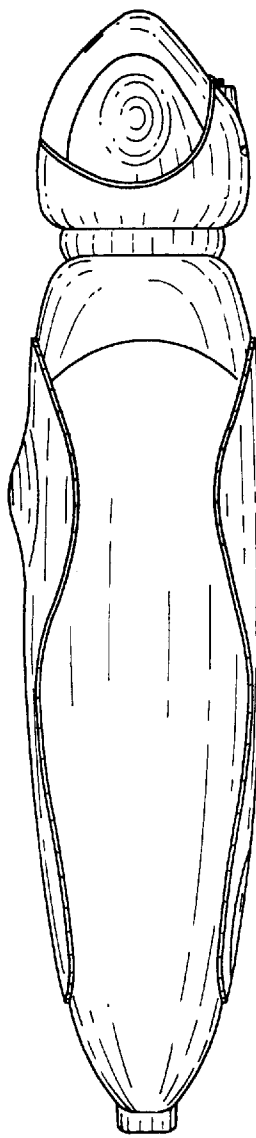

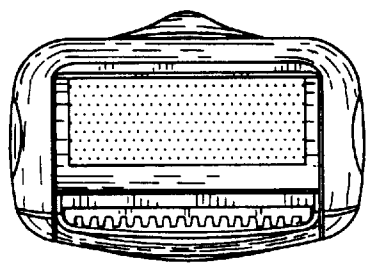

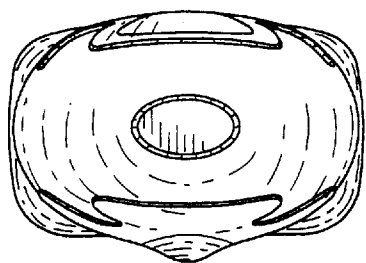
