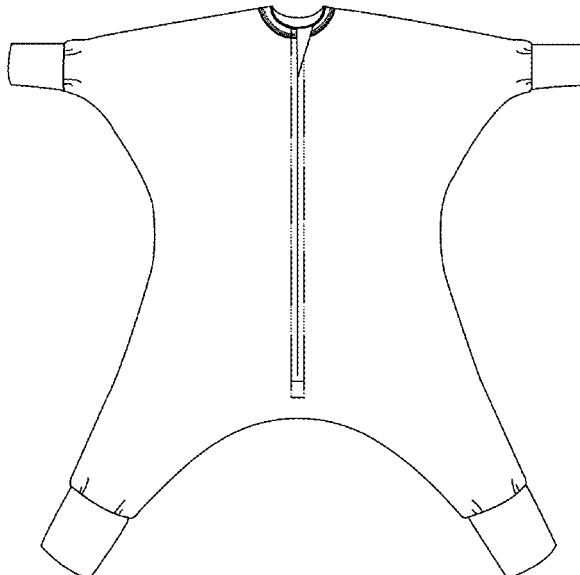
(57) **CLAIM**

The ornamental design for a one piece baby garment with zipper, as shown and described.

DESCRIPTION

FIG. 1 is a front plan view of the one piece baby garment with zipper in accordance with my new design;
FIG. 2 is a front plan view with zipper detail exposed;
FIG. 3 is a front plan view with garment fully unzipped;
FIG. 4 is a back plan view thereof;
FIG. 5 is a front plan view with closed cuffs;
FIG. 6 is a back plan view with closed cuffs;
FIG. 7 is a bottom perspective view of open cuffs; and,
FIG. 8 is a top perspective view of open cuffs.

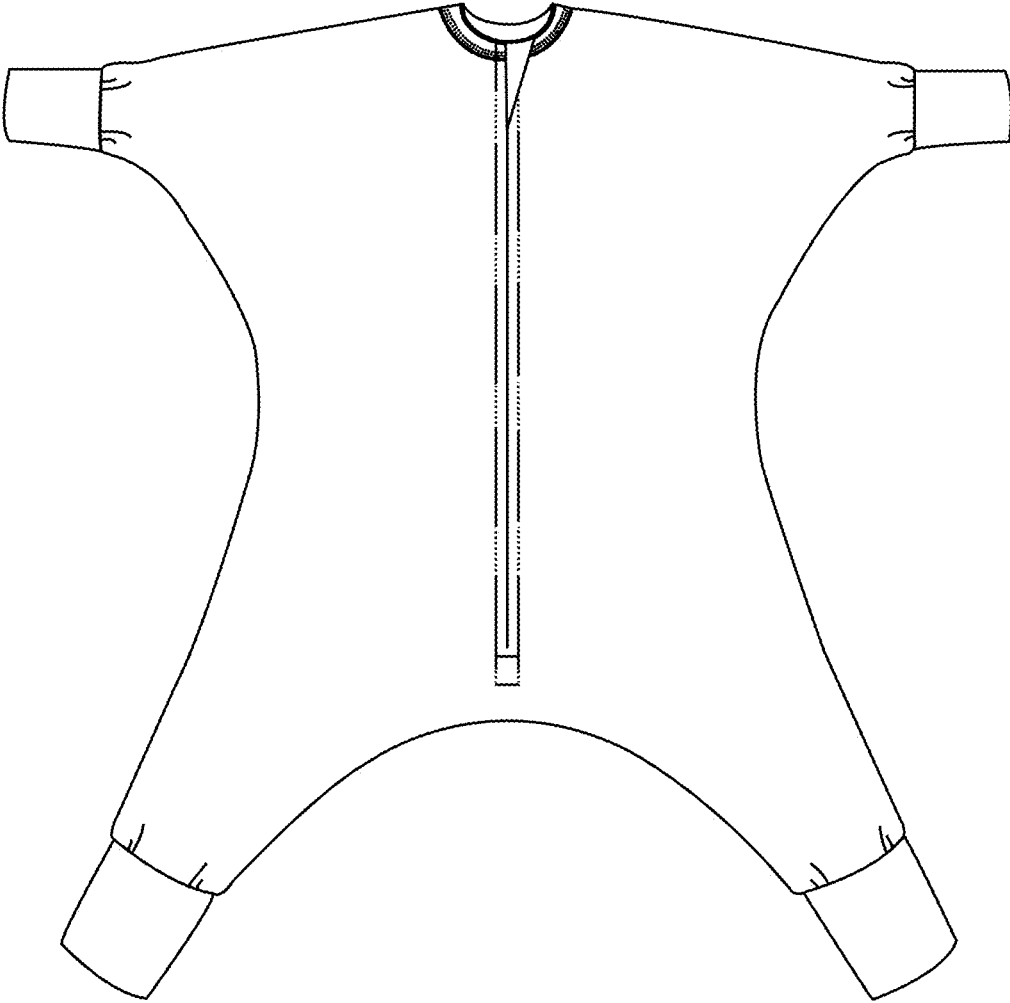

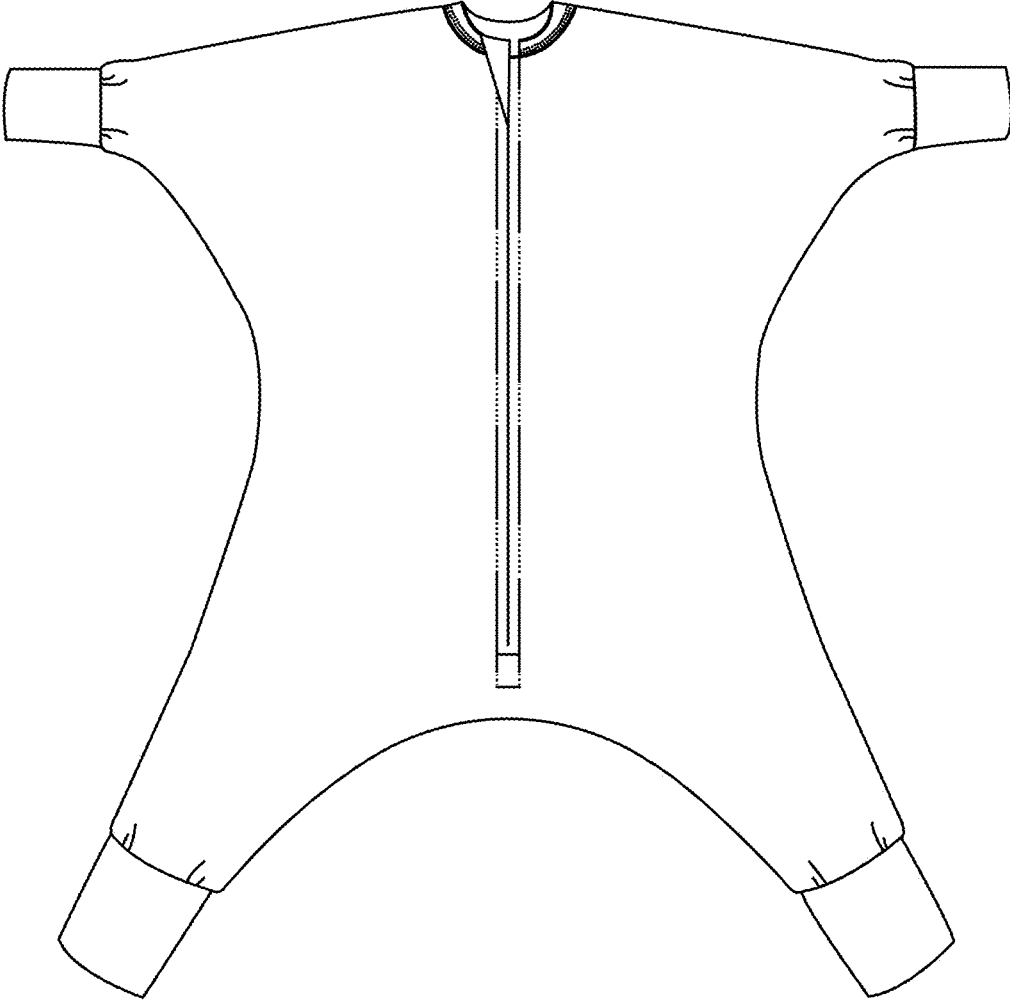

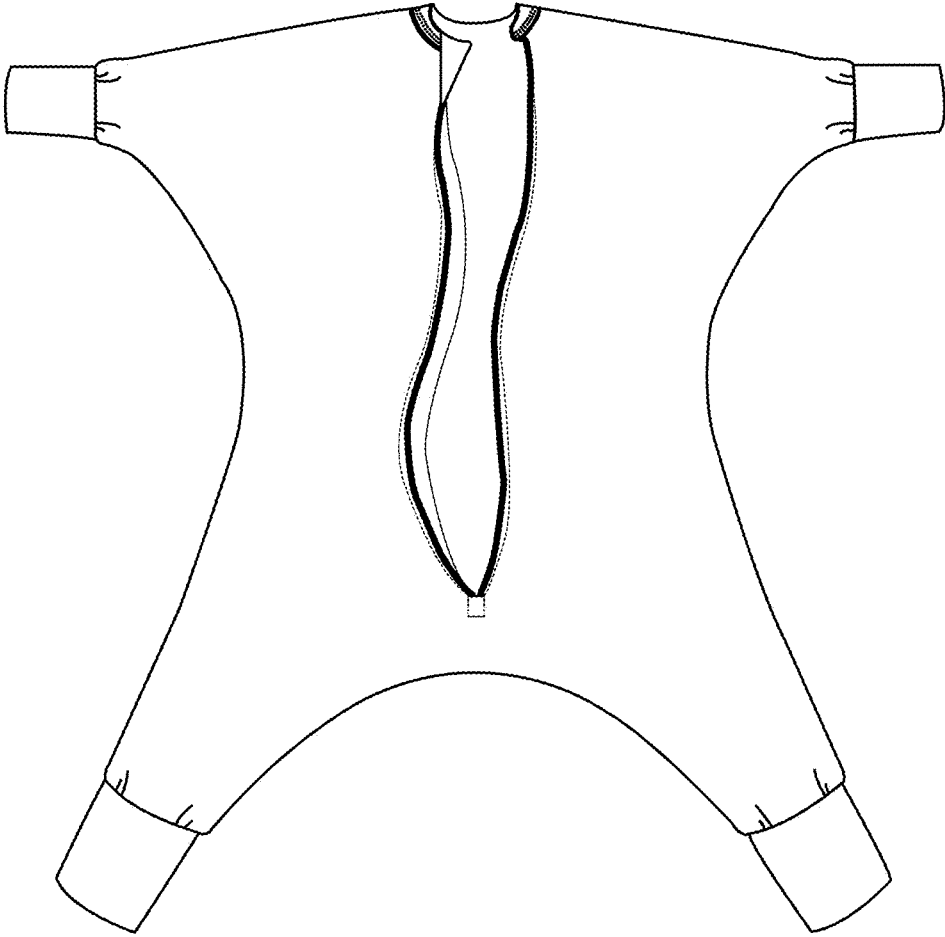

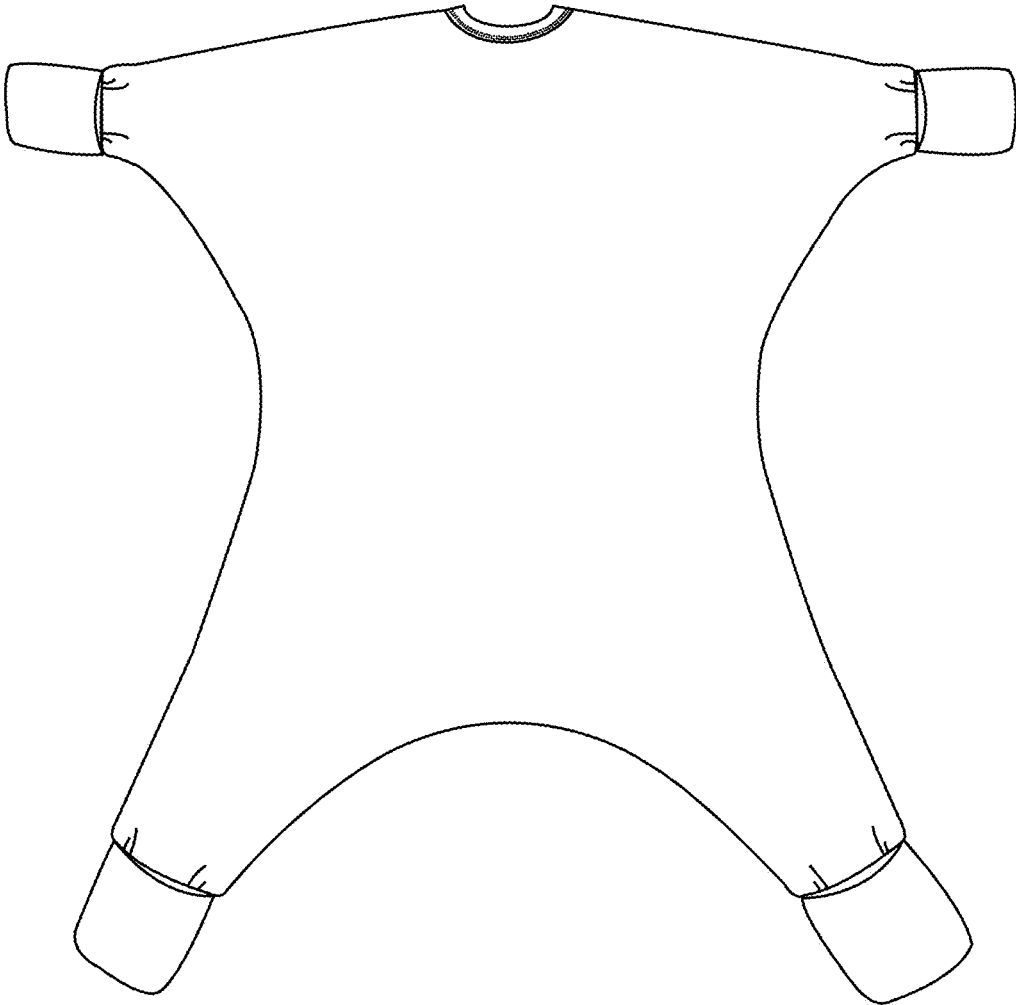

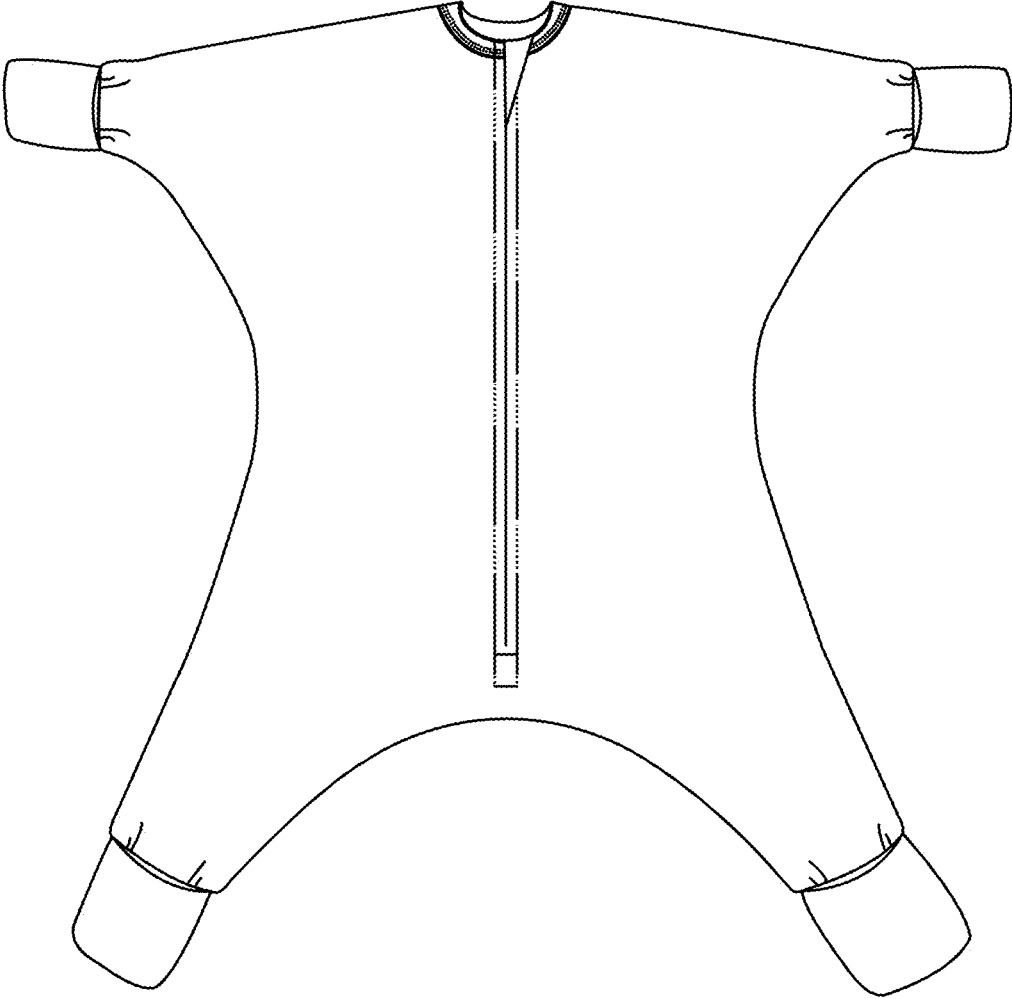

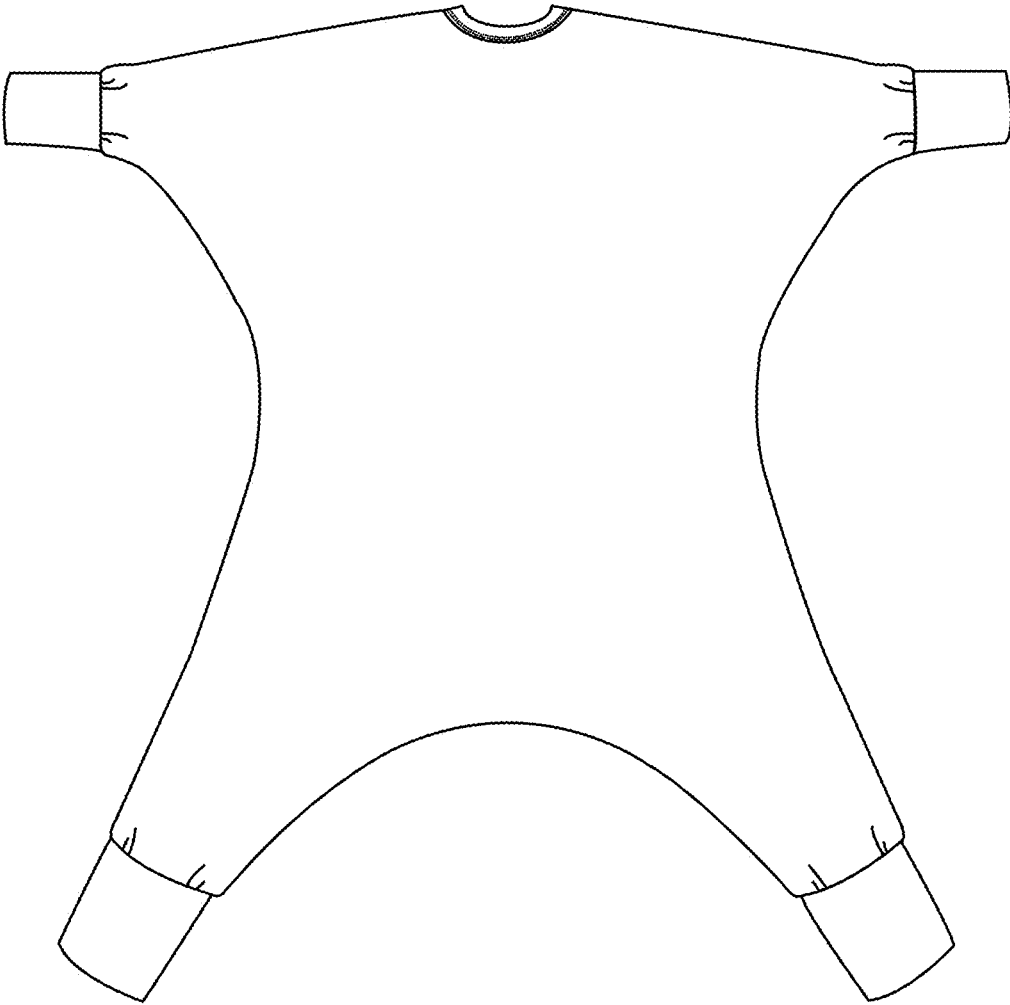
