

(57) Abstract: A hand-held printer is disclosed. The disclosed hand-held printer includes a printer housing defining an interior and includes a print head. The hand-held printer further includes an ink reservoir configured to fluidly connect with the print head when carried within the interior. The ink reservoir includes a flexible housing, a printing substrate carried by the flexible housing and configured to cooperate with the print head, and a fluid port carried within the flexible housing.
