The ornamental design for a shoe drying rack, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of a shoe drying rack showing my new design,

FIG. 2 is a left rear perspective view thereof,

FIG. 3 is an enlarged scale left top front perspective view thereof,

FIG. 4 is a right top front perspective view thereof,

FIG. 5 is a further enlarged scale front elevational view thereof,


FIG. 6 is a top plan view thereof,


















