

(57) Abstract: In an embodiment, a filter chain object comprising an association of a starting set of data items and two or more filter links is created and stored in computer memory. Each of the filter links comprises a component object that associates a set operation and a membership criterion. Each of the filter links is associated with a particular filter view among a plurality of filter views. Each particular filter view comprises a graphical representation of a state of applying the membership criterion of the associated filter link to a subset of data resulting from filtering the starting set of data items according to zero or more preceding filter links.
