DESCRIPTION

FIG. 1 is a perspective view of a drawstring tool showing our new design;

FIG. 2 is a right side elevational view thereof;

FIG. 4 is a top plan view thereof;

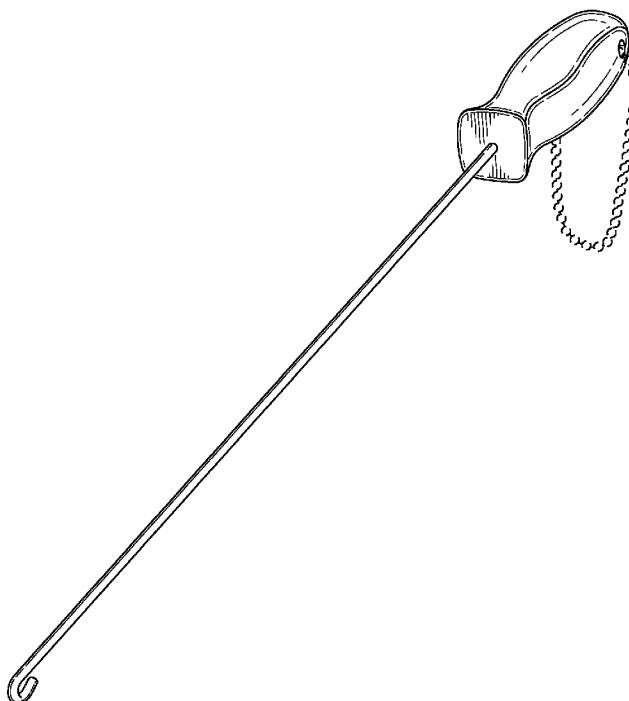
FIG. 5 is a bottom plan view thereof;

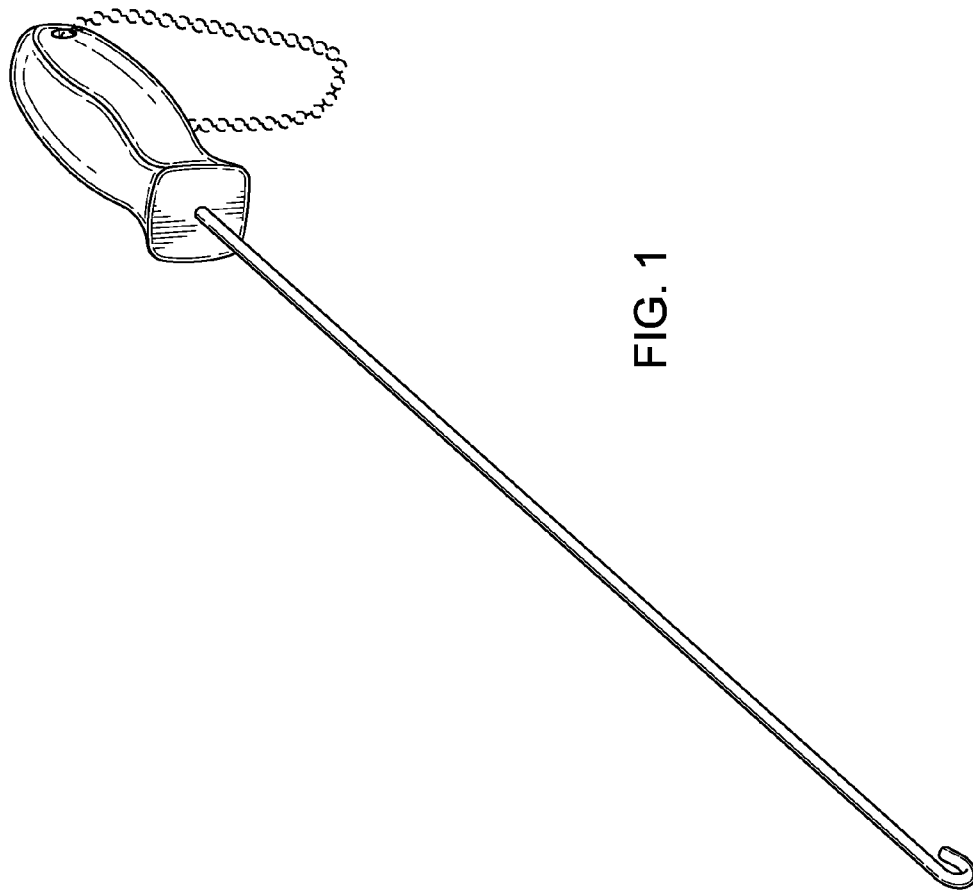

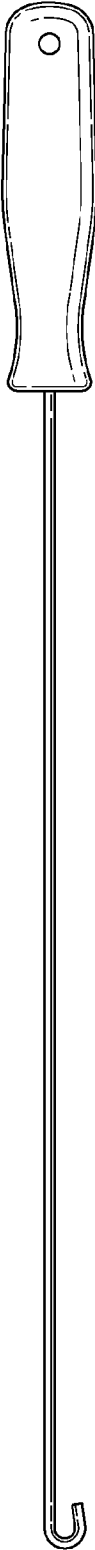

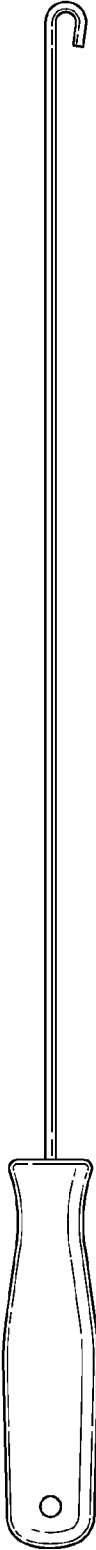

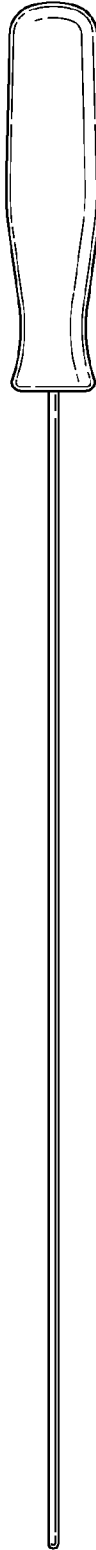

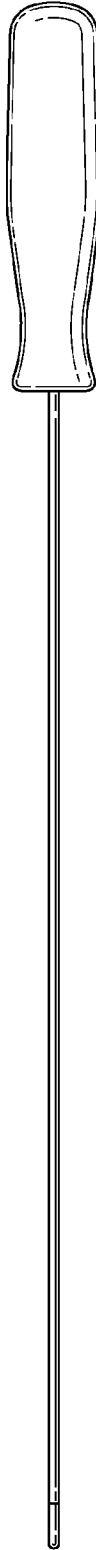
