The ornamental design for a sealing apparatus, as shown and described.

**DESCRIPTION**


FIG. 1 is a front isometric view of an ornamental design for a sealing apparatus in closed condition;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a sectional view thereof, taken along a section A-A in FIG. 2;  
FIG. 4 is a rear elevation view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom view thereof;  
FIG. 7 is a right side view thereof;  
FIG. 8 is a left side view thereof;  
FIG. 9 is a front isometric view of the sealing apparatus in an open condition;  
FIG. 10 is a front elevation view of the sealing apparatus in the open condition; and,  
FIG. 11 is a front isometric view of the sealing apparatus, showing bags sealed between adjoining elongate clip members of the sealing apparatus.  
The broken line showing of the bags in FIG. 11 is for the purpose of illustrating environment and forms no part of the claimed design.














