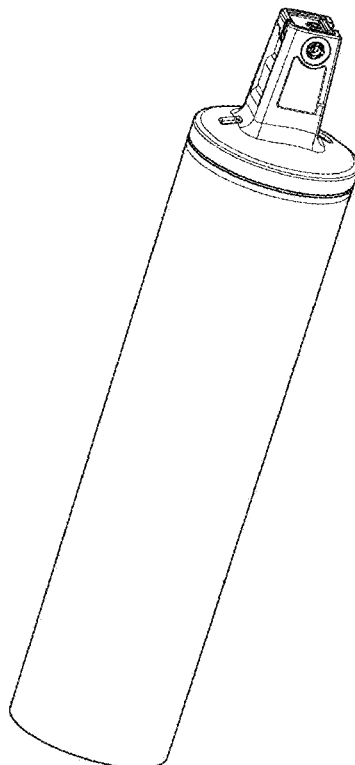

FIG. 1 is a right rear perspective view of a filter cartridge showing my new design;
FIG. 2 is a right side view thereof;

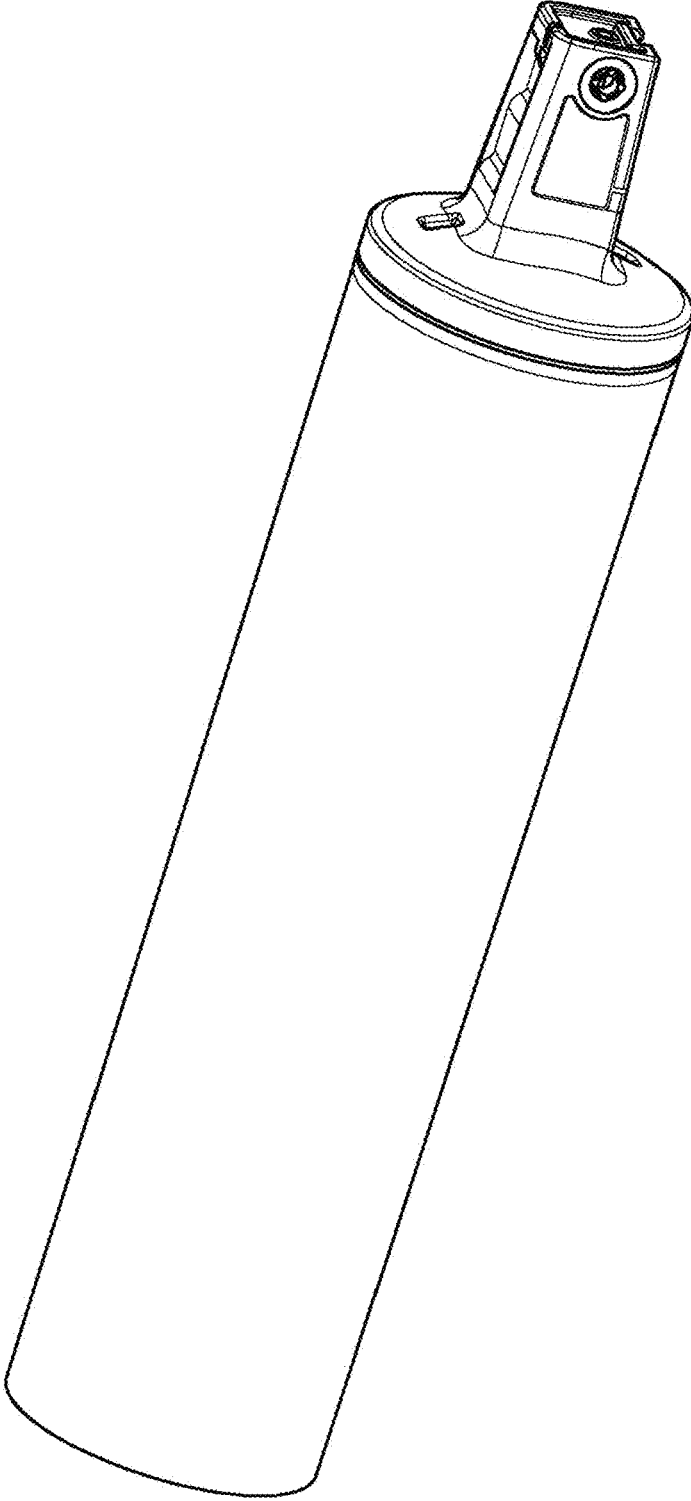

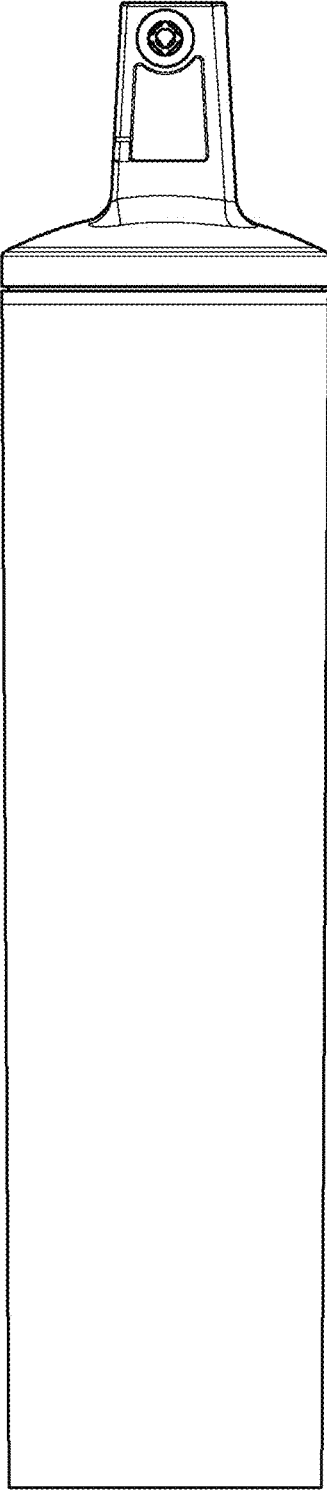

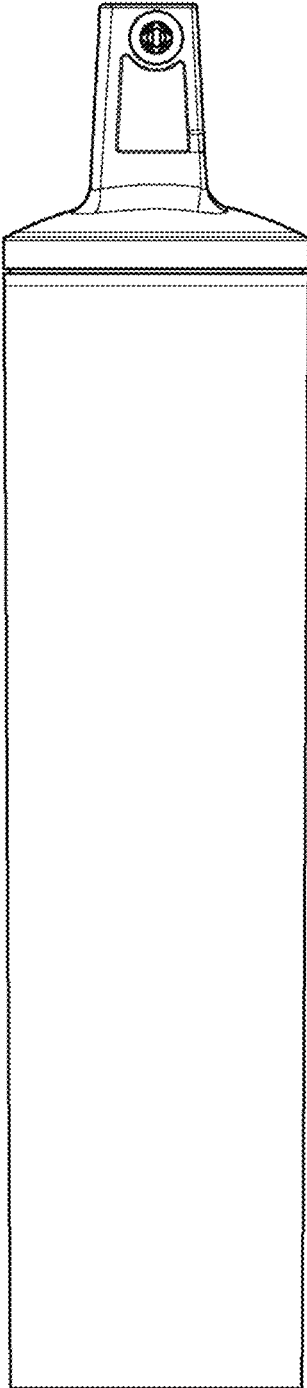

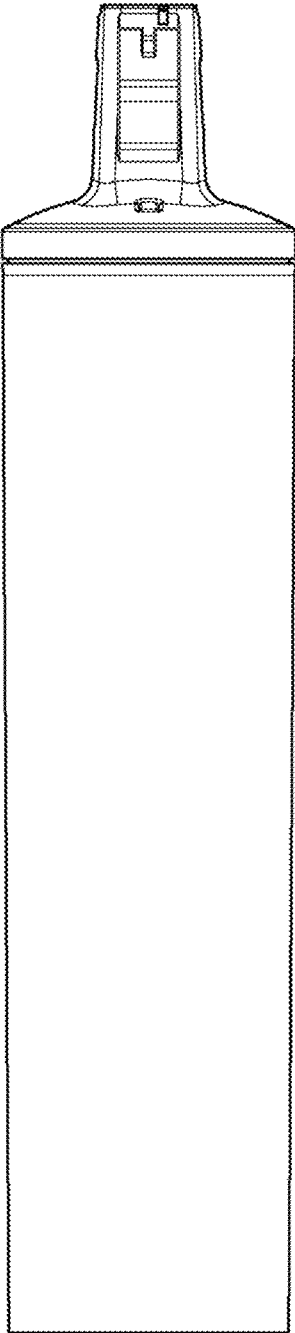

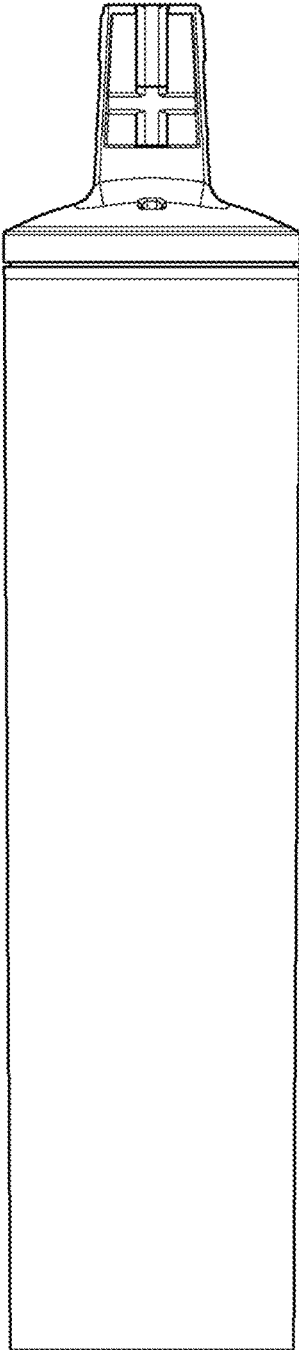

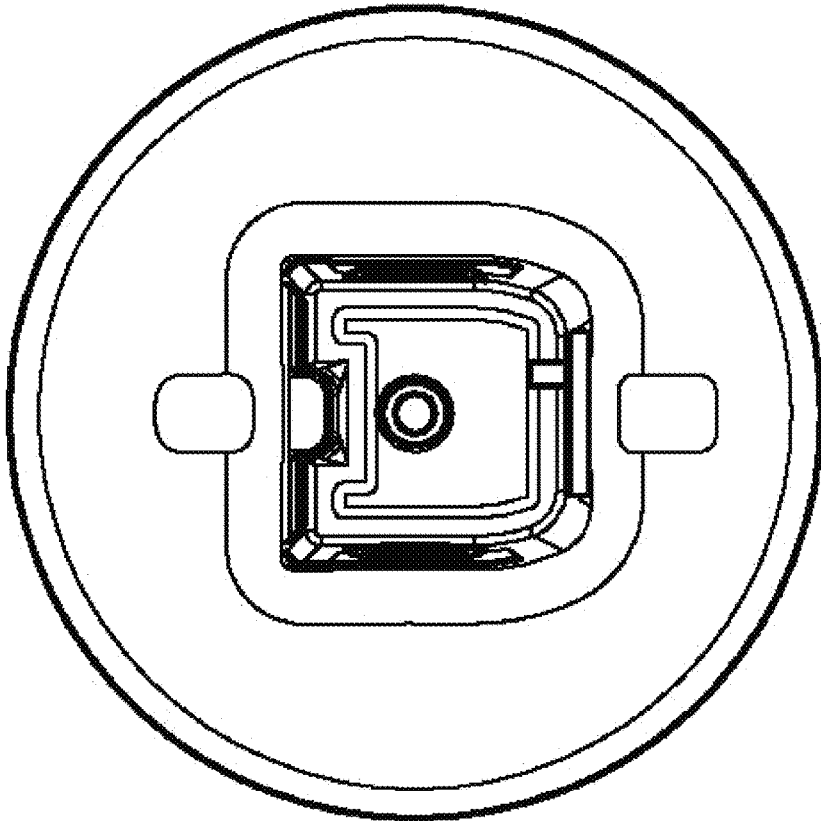

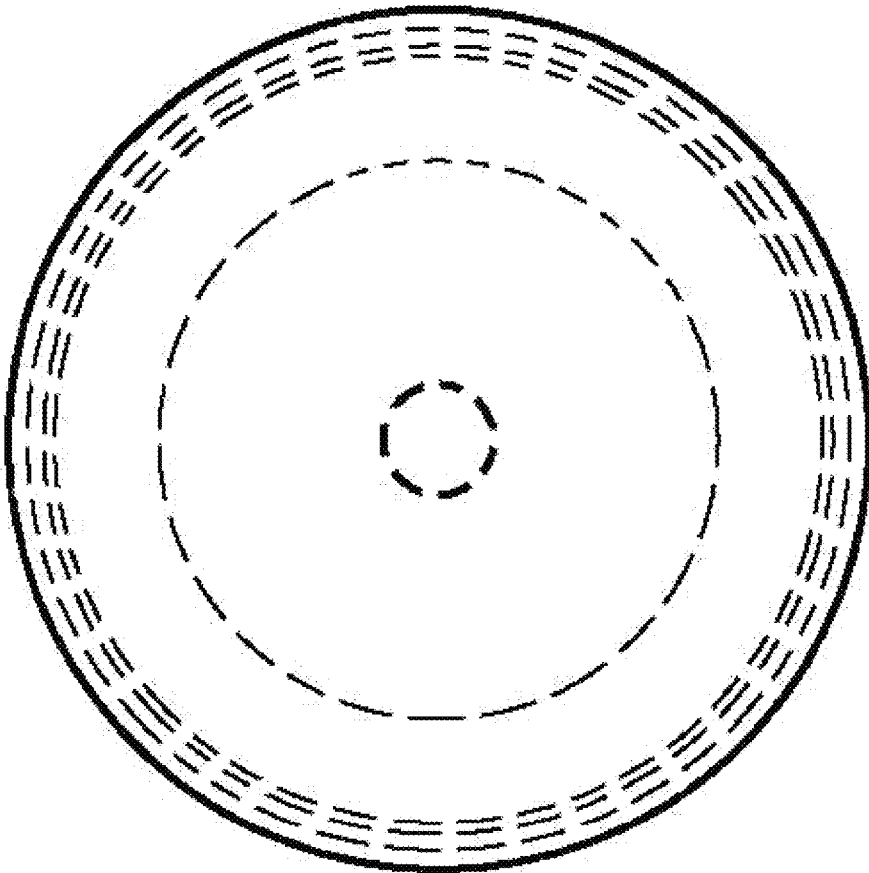
