DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the container, showing our new design;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a perspective view of a second embodiment of the container;


FIG. 8 is a left side elevational view of the second embodiment, the right side elevational view being a mirror image thereof;




















