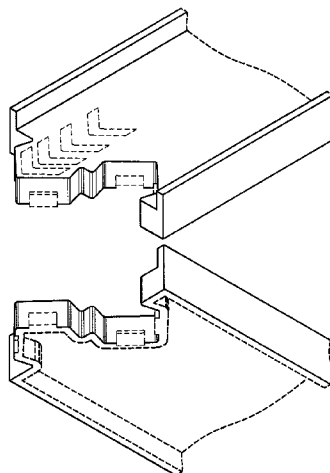

(57) **CLAIM**
The ornamental design for a toy vehicle track portion, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a toy vehicle track portion according to an embodiment of the present invention; FIG. 2 is a bottom perspective view of the toy vehicle track portion of FIG. 1; FIG. 3 is a top view of the toy vehicle track portion of FIG. 1; FIG. 4 is a bottom view of the toy vehicle track portion of FIG. 1; FIG. 5 is a right side view of the toy vehicle track portion of FIG. 1; FIG. 6 is a left side view of the toy vehicle track portion of FIG. 1; FIG. 7 is a front view of toy vehicle track portion of FIG. 1; FIG. 8 is a rear view of the toy vehicle track portion of FIG. 1; and, FIG. 9 is a top view of a first toy vehicle track portion of FIG. 1 engaging a second toy vehicle track portion in accordance with FIG. 1.

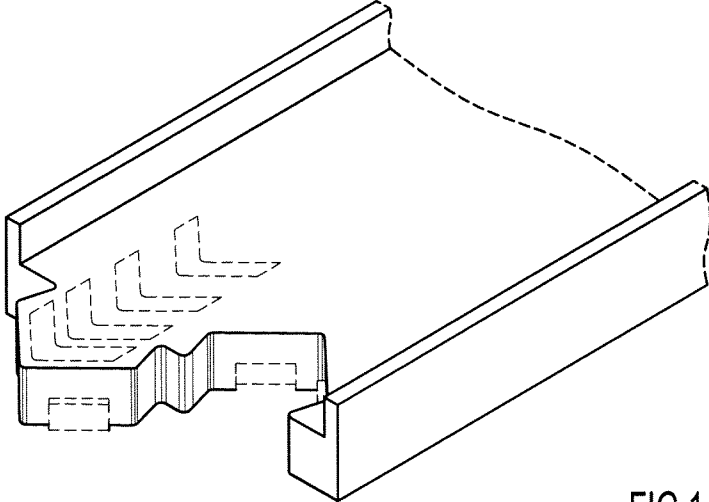

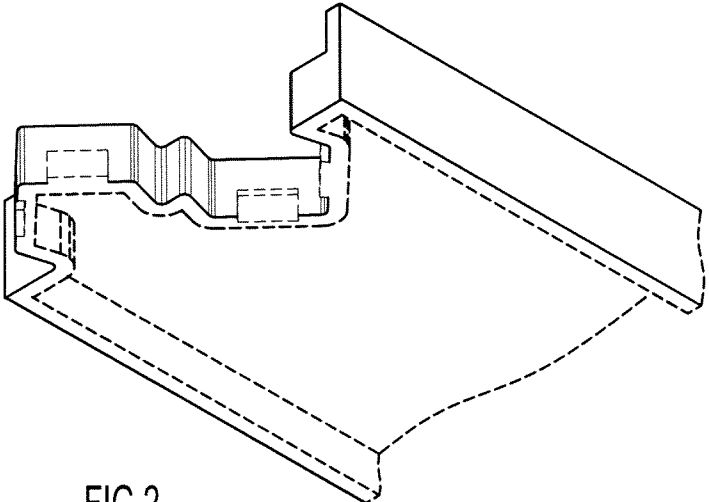

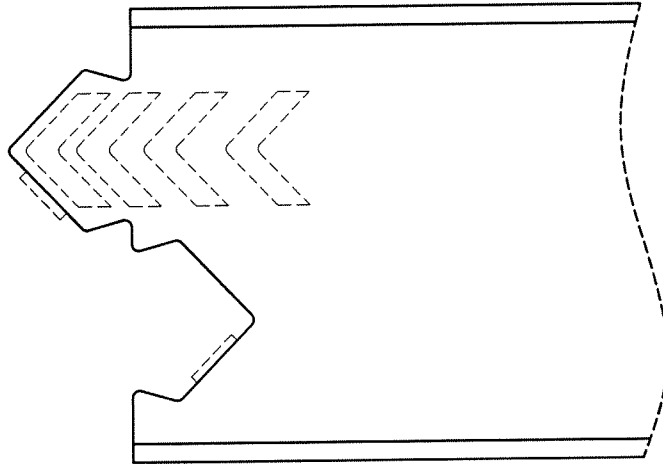

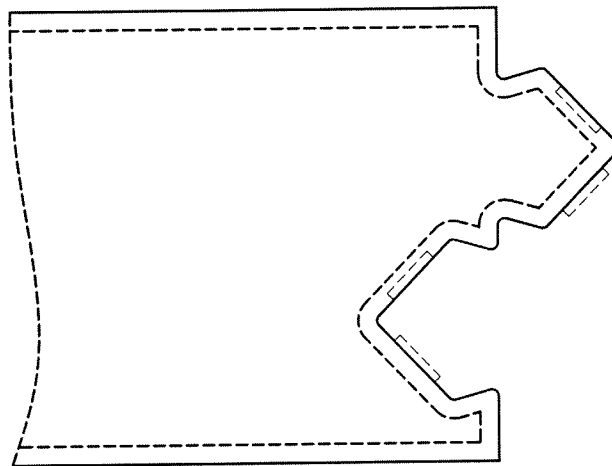

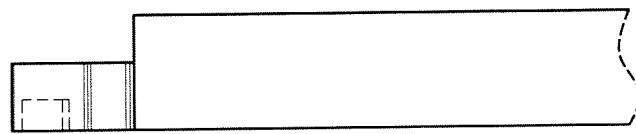

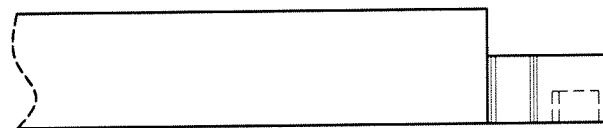

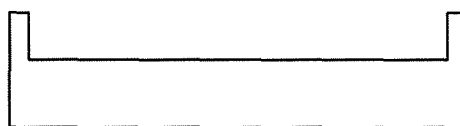

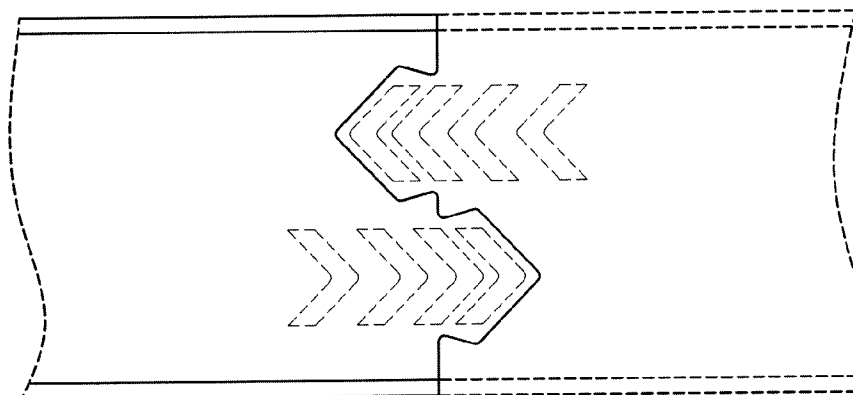
