mation terminal, as shown and described.


DESCRIPTION

FIG. 1 is a first image in a sequence for a display screen or
portion thereof with animated graphical user interface for a
portable information terminal showing our new design;
FIG. 2 is a second image thereof;
FIG. 3 is a third image thereof; and,
FIG. 4 is a fourth image thereof.

The appearance of the animated image sequentially transi-
tions between FIGS. 1 to 4. The process or period in which
one image transitions to another image forms no part of the
claimed design.








