(57) **CLAIM**

We claim the ornamental design for a mist and sip handpiece, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the mist and sip handpiece according to a first preferred embodiment of the present design;

FIG. 2 is a right side view of the present design, a corresponding left side view being a mirror image thereof;


FIG. 3 is a bottom view of the present design;










