(57) **CLAIM**

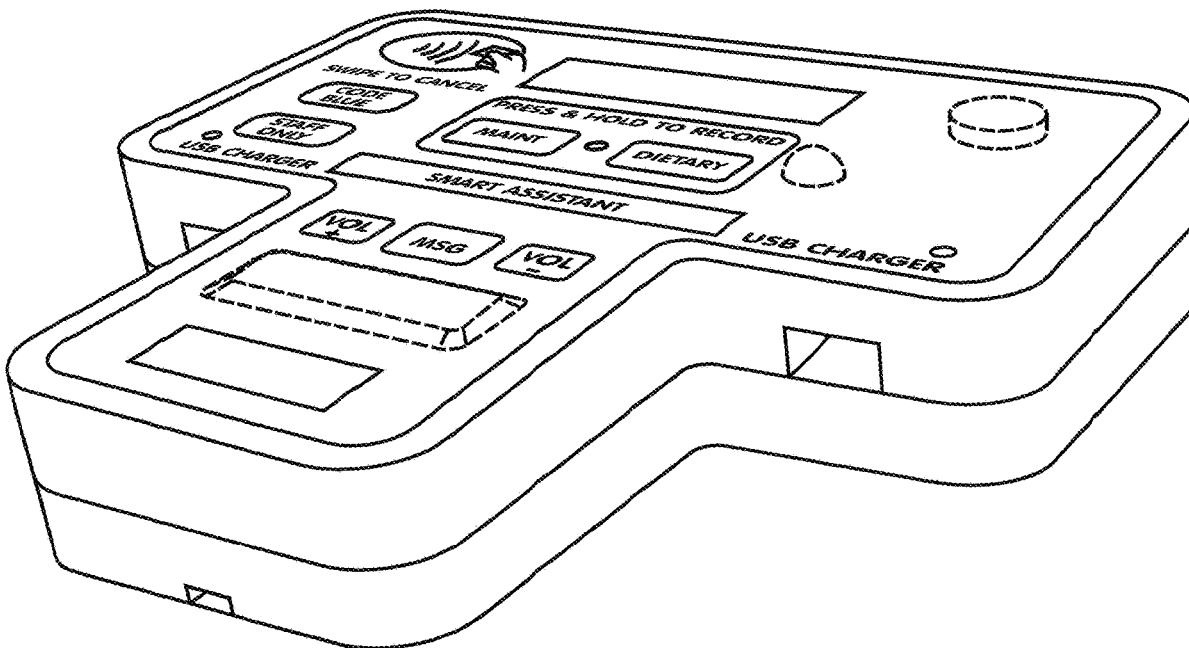
I claim the ornamental design for a nurse call light box, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a nurse call light box; FIG. 2 is a top view of the nurse call light box; FIG. 3 is a bottom view of the nurse call light box; FIG. 4 is a left view of the nurse call light box; FIG. 5 is a right view of the nurse call light box; FIG. 6 is a back view of the nurse call light box; and, FIG. 7 is a right perspective view of the nurse call light box. The broken lines in the drawings depict portions of the nurse call light box that form no part of the claimed design.

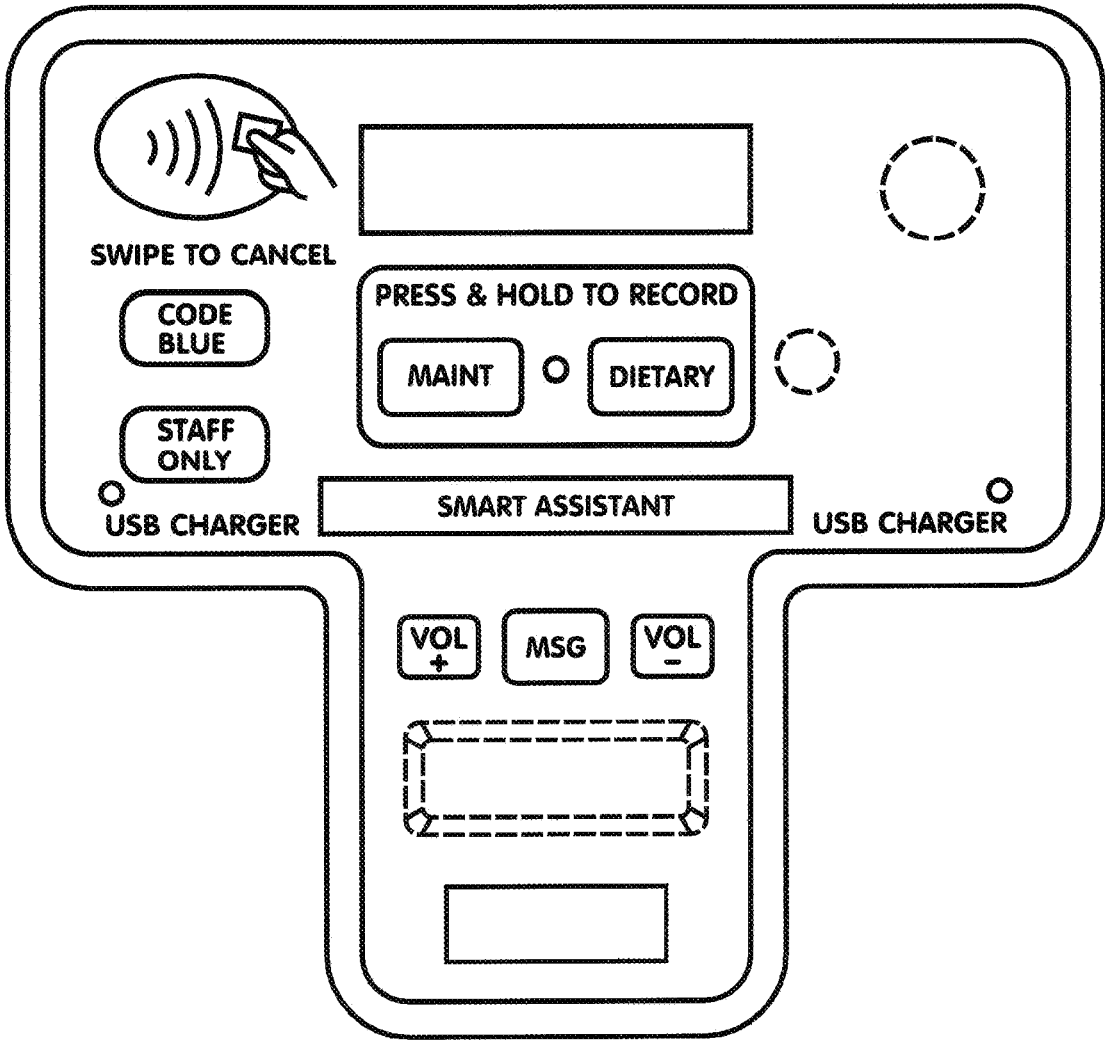

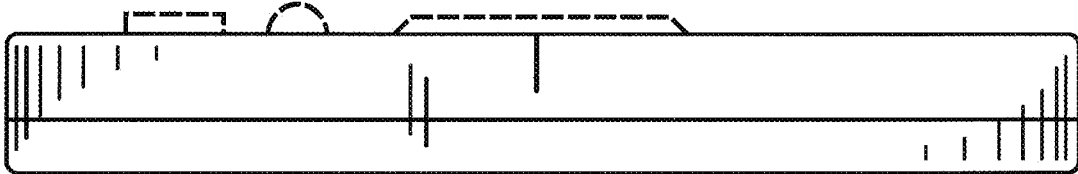

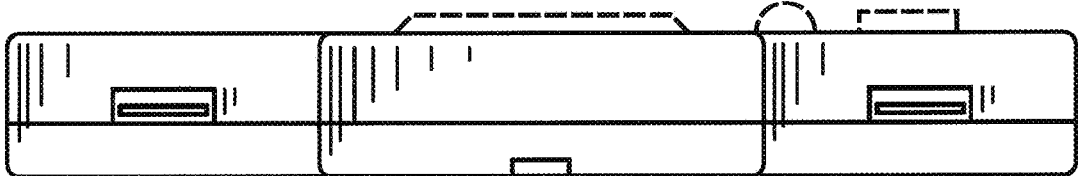

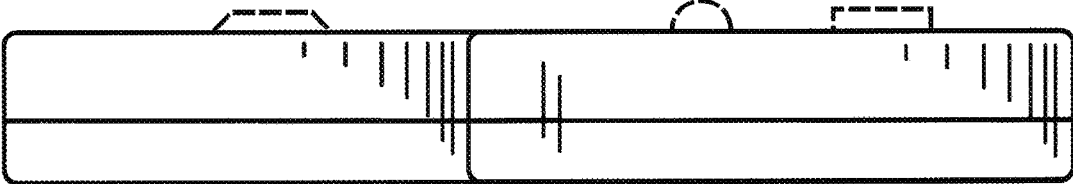

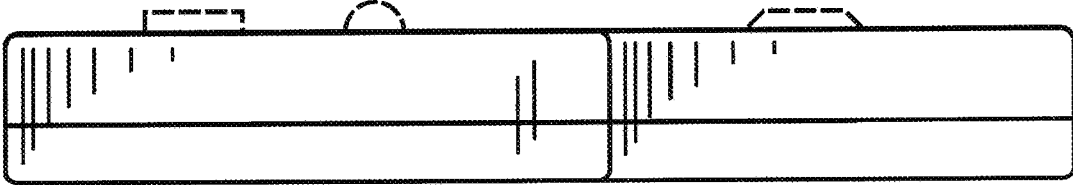

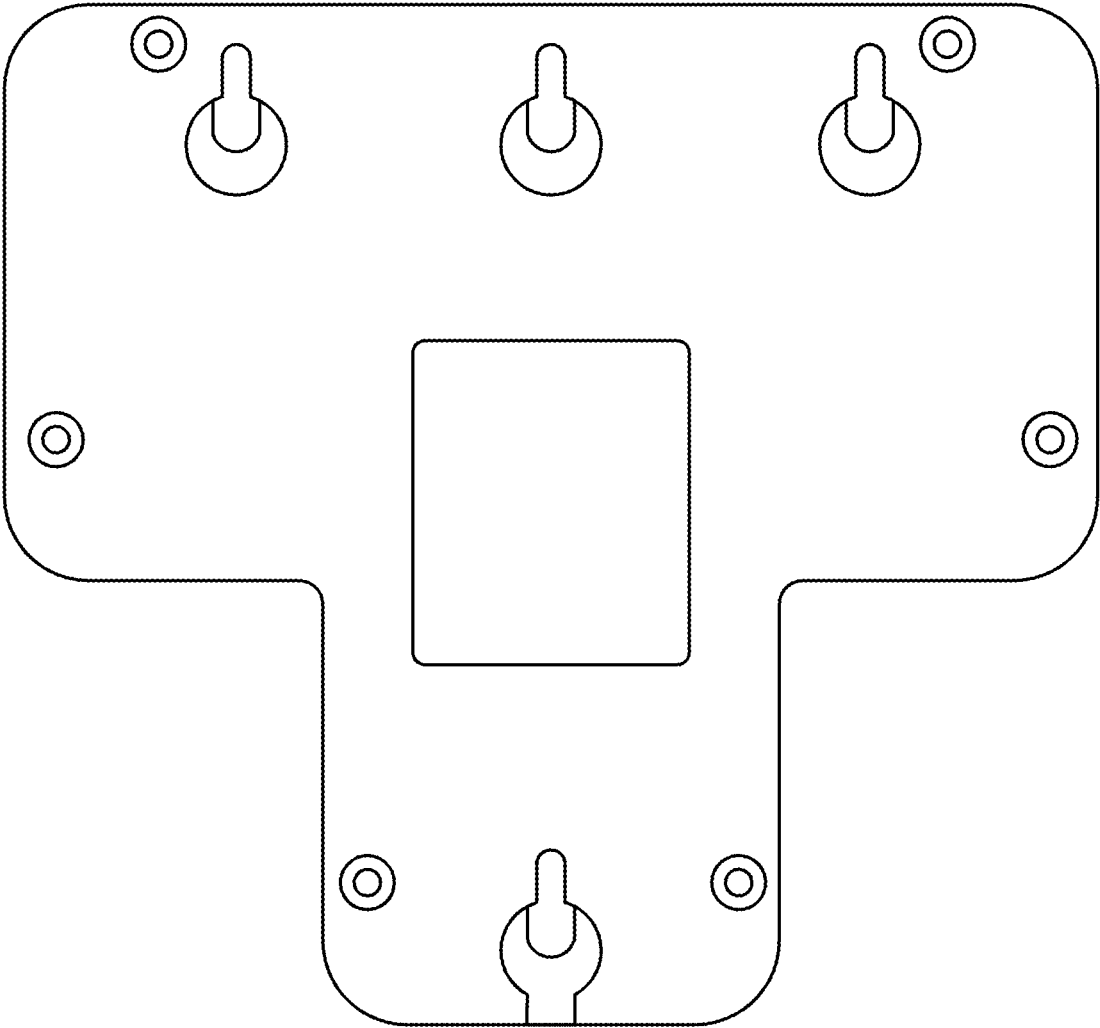

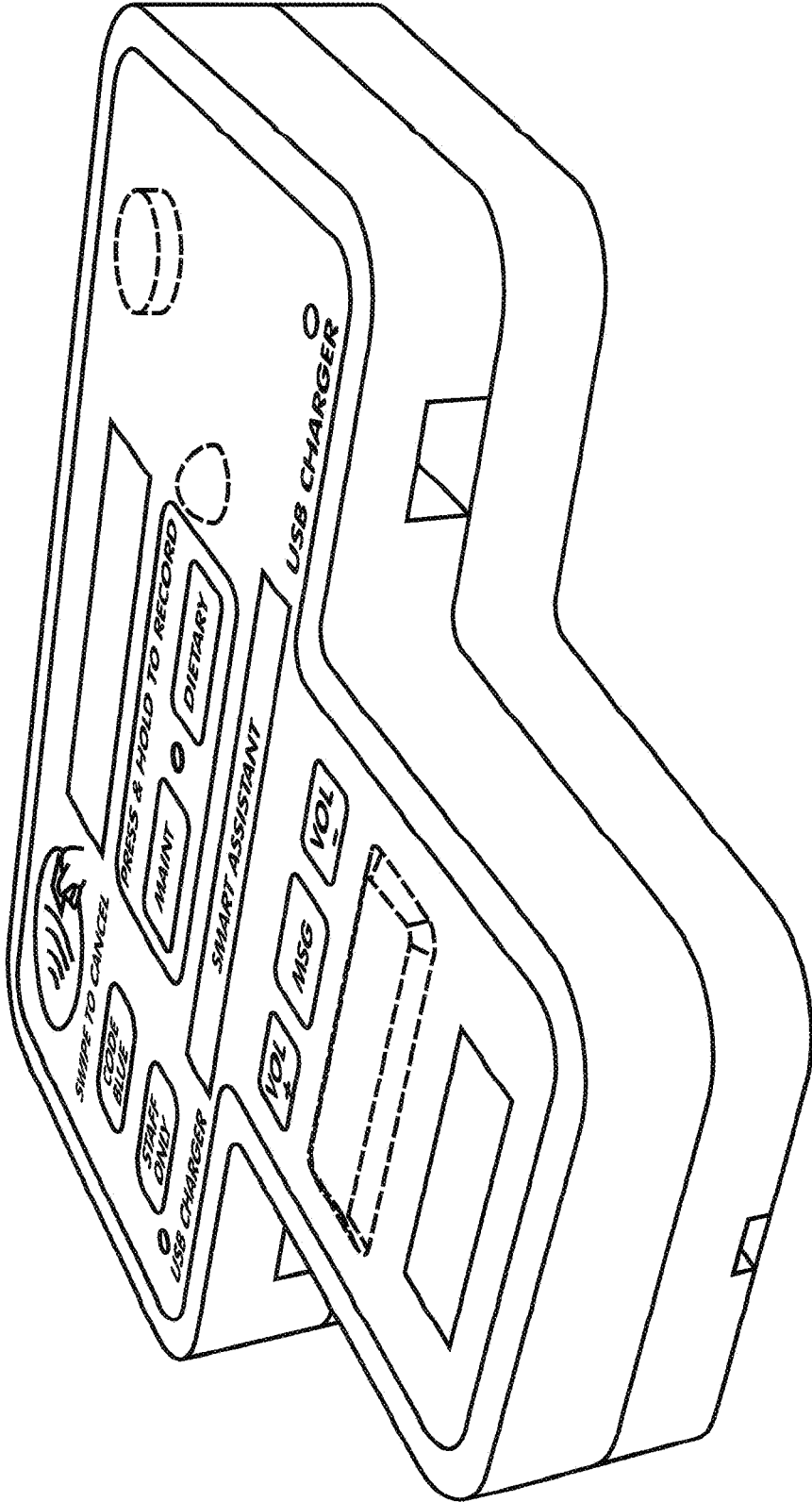
