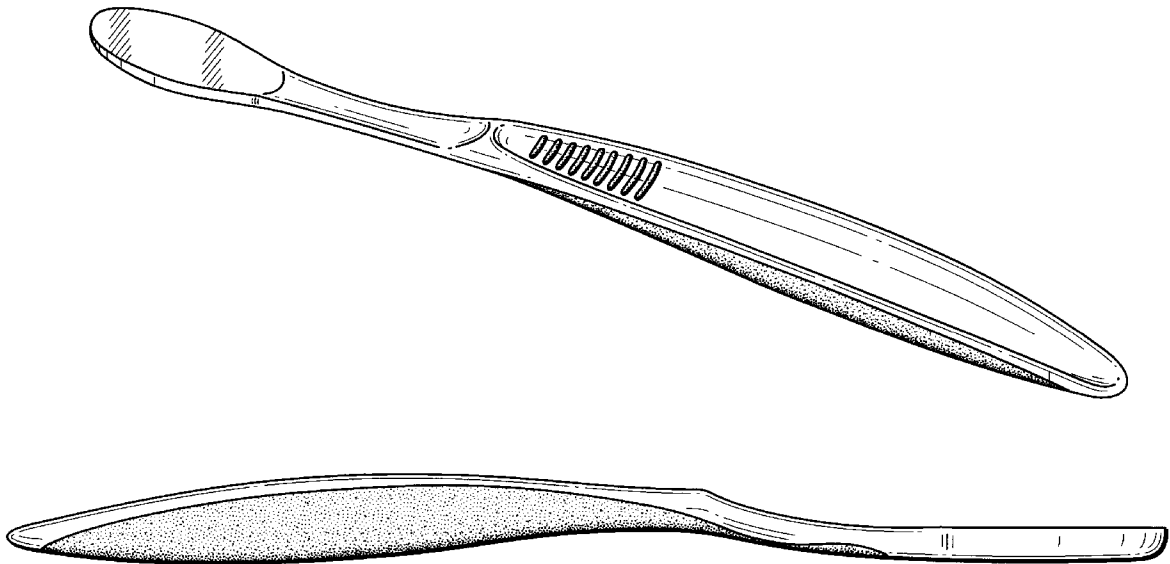
The ornamental design for a toothbrush handle, as shown and described.

### DESCRIPTION

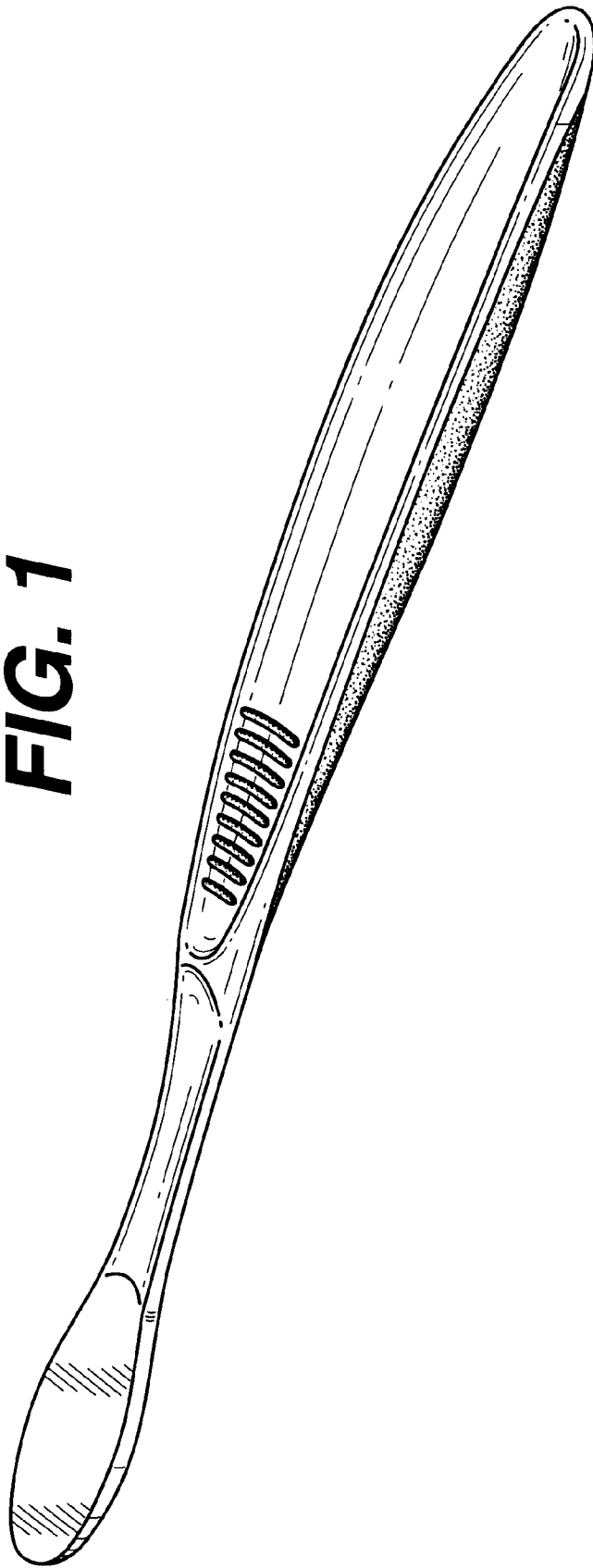
FIG. 1 is a perspective view of a toothbrush handle showing my new design;

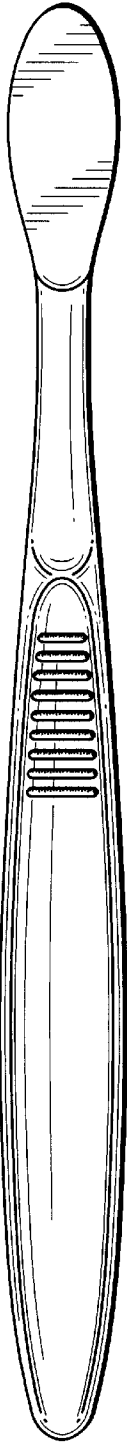

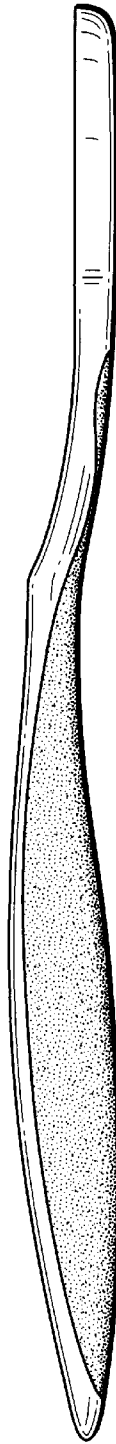

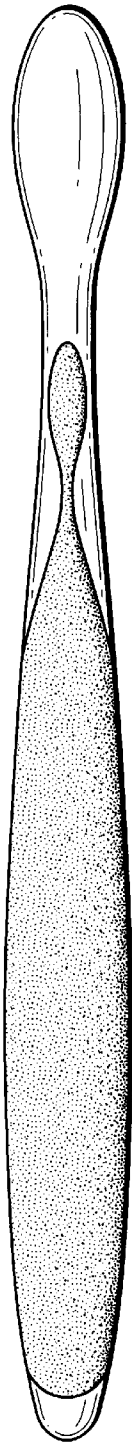

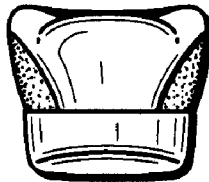
