(57) **CLAIM**

We claim the ornamental design for a vacuum cleaner, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right-side isometric view of a vacuum cleaner showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a right-side elevation view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a left-side elevation view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a top, front and right-side isometric view thereof, the only difference is in the unclaimed structure shown in broken lines;

FIG. 8 is a front elevation view of FIG. 7;

FIG. 9 is a right-side elevation view of FIG. 7;

FIG. 10 is a rear elevation view of FIG. 7;

FIG. 11 is a left-side elevation view of FIG. 7; and,


FIG. 12 is a top plan view of FIG. 7.

The claimed structure in FIGS. 1-6 is identical to the solid line structure in FIGS. 7-12.

The bottom of the vacuum cleaner forms no part of the claimed design.

The details shown in broken lines form no part of the claimed design. The dash-dot lines show the boundary of the claimed design.
























