

(57) **CLAIM**

The ornamental design for a loudspeaker box, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side and top perspective view of a loudspeaker box showing the new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; and, FIG. 6 is a top plan view thereof. The portions of the design shown in broken lines show unclaimed subject matter.












