(57) **CLAIM**

The ornamental design for an earphone, as shown and described.

DESCRIPTION

FIG. 1 is a rear, left perspective view of a first embodiment of an earphone showing our new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof; and FIG. 5 is a top plan view thereof. FIG. 6 is a rear, left perspective view of a second embodiment of an earphone showing our new design; FIG. 7 is a rear elevational view thereof; FIG. 8 is a left side elevational view thereof; FIG. 9 is a right side elevational view thereof; FIG. 10 is a top plan view thereof; and FIG. 11 is a bottom plan view thereof. FIG. 12 is a rear, left perspective view of a third embodiment of an earphone showing our new design; FIG. 13 is a rear elevational view thereof; FIG. 14 is a left side elevational view thereof; FIG. 15 is a right side elevational view thereof; and FIG. 16 is a top plan view thereof.
































