[57] CLAIM

The ornamental design for a combined dog harness and packs, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined dog harness and packs showing my new design; FIG. 2 is another perspective view thereof showing the packs removed for illustration; FIG. 3 is a front elevational view thereof; FIG. 4 is a right side elevational view thereof, the left side being a mirror image of the right side shown; and FIG. 5 is a rear elevational view thereof. The broken line representation of a dog in FIGS. 1 and 2 is for illustrative purposes only and forms no part of the claimed design.










