(54) Title: NOVEL AZOLES HAVING AN INSECTICIDAL ACTION

(57) Abstract: The invention relates to novel heterocyclic compounds, to methods for the production thereof, and to their use as
pesticides, particularly for controlling animal pests.

(57) Zusammenfassung: Die vorliegende Anmeldung betrifft neue heterocyclische Verbindungen, Verfahren zu ihrer Herstellung
und ihre Verwendung als Pflanzenschutzmittel, insbesondere zur Bekämpfung von tierischen Schädlingen.

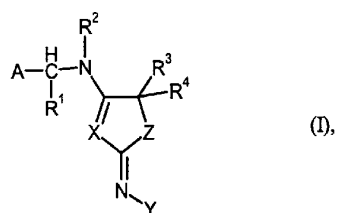
Novel azoles having an insecticidal action

5 The present invention relates to novel heterocyclic compounds, to processes for their preparation and to their use as crop protection agents, in particular for controlling animal pests.

10 Various amino-substituted iminoheterocycles, such as, for example, 2-imino-4-amino-thiazoline, are already known as intermediates for dyes and active compounds or else as substances having a radio-protective effect. However, a use as crop protection agents and in particular for controlling animal pests has hitherto not been disclosed (cf. DE-A 2 921 683; S.M. Abdelall et al. J. heterocyclic Chem. 25, 1849-1956, 1988; E.N. Goncharenko et al. Radiobiologiya 22(2), 252-255, 1982).

15 Other amino-substituted iminoheterocycles, such as, for example, 3-amino- and 3-alkylamino-5-imino-2,5-dihydrofurans are known (cf. S.R. Landor J. Chem. Eoc. Perkin Trans. 1201-1204, 1991; M. Yu. Skvortsov et al. Zh. Org. Khim. 27(3), 526-530, 1991; M. Yu. Skvortsov et al. Zh. Org. Khim. 22(2), 255-259, 1986; M. Yu. Skvortsov et al., Zh. Org. Khim. 21(1), 221-222, 1985). Certain iminoheterocycles of
20 this structural type, for example 2-imino-4-(2-hydroxyethylamino)-5,5-dimethyl-2,5-dihydrofuran, have anti-inflammatory and analgesic activity (cf. B.A. Trofimov et al. SU 1392872, 1998). However, nothing has been disclosed concerning the use as crop protection agents, in particular for controlling animal pests.

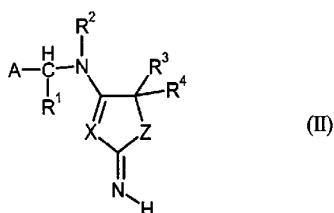
25 This invention now provides novel heterocyclic compounds of the formula (I)



in which

- A represents in each case optionally substituted aryl or hetaryl or heterocyclyl,
- 5 R¹ represents hydrogen or C₁-C₃-alkyl,
- R² represents hydrogen or C₁-C₃-alkyl,
- 10 R³ represents hydrogen or C₁-C₃-alkyl,
- R⁴ represents hydrogen or C₁-C₃-alkyl,
- X represents N or CH,
- 15 Y represents CN or NO₂,
- Z represents CH₂, O, S, SO, SO₂ or NR⁵ and
- 20 R⁵ represents hydrogen or C₁-C₃-alkyl.

Furthermore, it has been found that the compounds of the formula (I) are obtained when compounds of the formula (II)



are reacted with suitable cyanating agents (to obtain compounds of the formula (I) in which Y represents CN) or with suitable nitrating agents (to obtain compounds of the formula (I) in which Y represents NO₂).

Finally, it has been found that the novel compounds of the formula (I) have strongly pronounced biological properties and are suitable especially for controlling animal pests, in particular insects, arachnids and nematodes, encountered in agriculture, in forests, in the protection of stored products and materials and in the hygiene sector.

The formula (I) provides a general definition of the compounds according to the invention.

Preferred substituents or ranges of the radicals listed in the formulae mentioned above and below are illustrated below.

A preferably represents optionally halogen-, cyano-, nitro-, C₁-C₄-alkyl-, C₁-C₄-haloalkyl-, C₁-C₄-alkoxy- or C₁-C₄-haloalkoxy-substituted phenyl.

A preferably further represents pyrazolyl, 1,2,4-triazolyl, oxazolyl, isoxazolyl, thiazolyl, isothiazolyl, 1,2,5-thiadiazolyl, pyridyl, pyrazinyl or pyrimidinyl, which are optionally substituted by fluorine, chlorine, bromine, cyano, nitro, C₁-C₂-alkyl (which is optionally substituted by fluorine and/or chlorine), C₁-C₂-alkoxy (which is optionally substituted by fluorine and/or chlorine), C₁-C₂-alkylthio (which is optionally substituted by fluorine and/or chlorine)

or C₁-C₂-alkylsulfonyl (which is optionally substituted by fluorine and/or chlorine).

5 A furthermore preferably represents an optionally halogen- or C₁-C₃-alkyl-substituted saturated C₅-C₆-cycloalkyl radical in which one methylene group is replaced by O or S.

R¹ preferably represents hydrogen, methyl, ethyl, n-propyl or i-propyl.

10 R² preferably represents hydrogen, methyl, ethyl, n-propyl or i-propyl.

R³ preferably represents hydrogen, methyl, ethyl, n-propyl or i-propyl.

15 R⁴ preferably represents hydrogen, methyl, ethyl, n-propyl or i-propyl.

X preferably represents N or CH.

Y preferably represents CN or NO₂.

20 Z preferably represents CH₂, O, S or NR⁵.

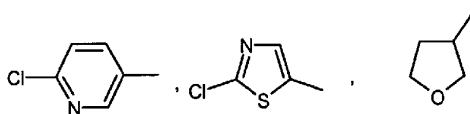

Using, for example, the starting materials 4-(N-(6-chloro-3-pyridylmethyl)-N-methylamino-2-imino-2,5-dihydro-[1,3]-thiazoline and cyanogen bromide, the course of the process according to the invention can be represented by the reaction scheme below:

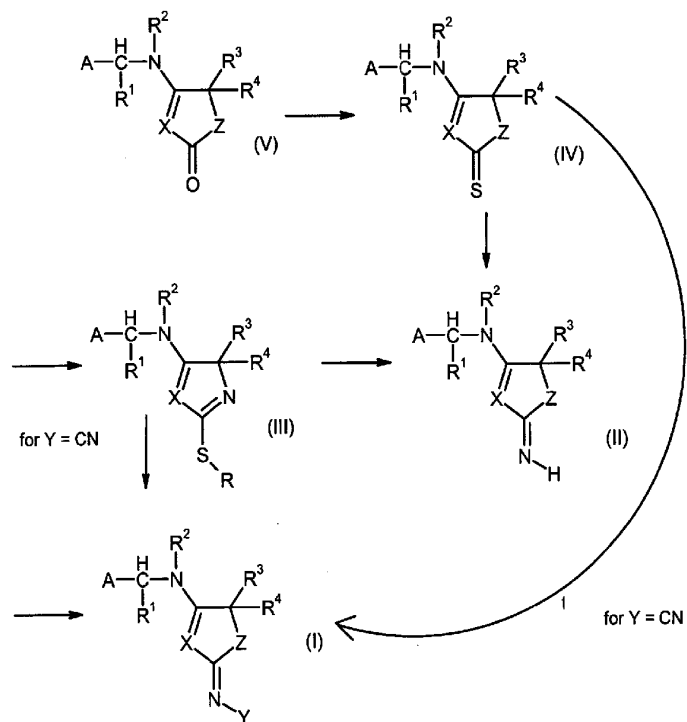


The compounds of the formula (II) are novel and also form part of the subject-matter of the present invention.

5 Depending in particular on the meaning of the variables X and Z, various methods may be considered for preparing the compounds of the formula (II). Some compounds of the formula (I), too, can be prepared by other methods.

This is illustrated initially by formula scheme I below.

- 5 The reactions described in Formula Scheme I can be carried out in a generally known manner.

The compounds of the formula (V) can be converted by reaction with sulfurising reagents into the compounds of the formula (IV).

In the literature, a large number of different sulfurising agents, such as, for example, hydrogen sulfide (H_2S), hydrogen sulfide/hydrogen chloride (H_2S/HCl), hydrogen persulfide/hydrogen chloride (H_2S_2/HCl), di(diethylaluminium) sulfide $[(Et_2Al)_2S]$, polymeric ethylaluminium sulfide $[(EtAlS)_n]$, silicon disulfide (SiS_2), diboron

trisulfide (B_2S_3), phosphorus pentachloride/dialuminium trisulfide/sodium sulfate ($PCl_5/Al_2S_3/Na_2SO_4$), sodium sulfide/sulfuric acid (Na_2S/H_2SO_4), diphosphorus pentasulfide (P_2S_5), diphosphorus pentasulfide/pyridine (P_2S_5/Py), diethylthiocarbonyl chloride, diphosphorus pentasulfide/triethylamine (P_2S_5/NEt_3),

Alternative possibilities are also reaction sequences such as, for example, O-alkylation with $R_3O^+BF_4^-$ (R: methyl, ethyl) (H. Meerwein et al., *Justus Liebigs Ann.*

Chem. 641, (1961) p. 1) and subsequent reaction of the intermediates with anhydrous NaSH (R. E. Eibeck, Anorg. Syn. 7, (1963) p. 128), the *in-situ* formation of chloroiminium salts and subsequent reaction with tetrathiomolybdates, in particular benzyltriethylammonium tetrathiomolybdate $[(\text{Ph-CH}_2\text{-NEt}_3)_2\text{MoS}_4]$ (Tetrahedron Lett. 36 (45), 1995, p. 8311) or hexamethyldisilathiane (TMS_2S) (TMS: trimethylsilyl; P. L. Fuchs et al., J. Org. Chem. 59, 1994, p. 348).

Preferred sulfurising agents are phosphorus reagents, such as, for example, diphosphorus pentasulfide (P_2S_5), diphosphorus pentasulfide/pyridine ($\text{P}_2\text{S}_5/\text{Py}$),
10 diphosphorus pentasulfide/triethylamine ($\text{P}_2\text{S}_5/\text{NEt}_3$), diphosphorus pentasulfide/sodium bicarbonate ($\text{P}_2\text{S}_5/\text{NaHCO}_3$ „Scheeren's Reagent“) or, particularly preferably, the racemisation-free 2,4-bis(4-methoxyphenyl)-2,4-dithioxo-1,3,2,4-dithiadiphosphetane (LR: Lawesson's Reagent) (K. Clausen, M. Thorsen, S.-O. Lawesson Tetrahedron 37, 1981, p. 3635), 2,4-bis-(4-phenoxyphenyl)-2,4-
15 dithioxo-1,3,2,4-dithiadiphosphetane „Belleau's Reagent (BR)“ or 2,4-bis-(4-phenylthiophenyl)-2,4-dithioxo-1,3,2,4-dithiadiphosphetane.

In general, it is advantageous to carry out this process in the presence of diluents. Diluents are advantageously employed in such an amount that during the entire
20 process the reaction mixture remains readily stirrable. Suitable diluents for carrying out the process according to the invention are all inert organic solvents.

Examples which may be mentioned are: halogenated hydrocarbons, in particular chlorinated hydrocarbons, such as tetrachloroethylene, tetrachloroethane,
25 dichloropropane, methylene chloride, dichlorobutane, chloroform, carbon tetrachloride, trichloroethane, trichloroethylene, pentachloroethane, difluorobenzene, 1,2-dichloroethane, chlorobenzene, bromobenzene, dichlorobenzene, chlorotoluene, trichlorobenzene; alcohols, such as methanol, ethanol, isopropanol, butanol; ethers, such as ethyl propyl ether, methyl tert-butyl ether, anisole, phenetol, cyclohexyl
30 methyl ether, dimethyl ether, diethyl ether, dipropyl ether, diisopropyl ether, di-n-butyl ether, diisobutyl ether, diisoamyl ether, ethyleneglycol dimethyl ether, tetrahydrofuran, dioxane, dichlorodiethyl ether and ethylene oxide and/or propylene

15 At certain concentrations or application rates, the compounds according to the
invention may, if appropriate, also be used as herbicides and microbicides, for
example as fungicides, antimycotics and bactericides. If appropriate, they may also
be used as intermediates or precursors for the synthesis of further active compounds.

20 All plants and plant parts can be treated in accordance with the invention. Plants are
to be understood as meaning in the present context all plants and plant populations
such as desired and undesired wild plants or crop plants (inclusive of naturally
occurring crop plants). Crop plants can be plants which can be obtained by
25 conventional plant breeding and optimization methods or by biotechnological and
recombinant methods or by combinations of these methods, inclusive of the
transgenic plants and inclusive of the plant cultivars protectable or not protectable by
plant breeders' rights. Plant parts are to be understood to mean all above-ground and
underground parts and organs of plants, such as shoot, leaf, flower and root,
30 examples which may be mentioned being leaves, needles, stalks, stems, flowers, fruit
bodies, fruits, seeds, roots, tubers and rhizomes. The plant parts also include

harvested material, and vegetative and generative propagation material, for example cuttings, tubers, rhizomes, offsets and seeds.

5 Treatment according to the invention of the plants and plant parts with the active compounds is carried out directly or by allowing the compounds to act on their surroundings, environment or storage space by the customary treatment methods, for example by immersion, spraying, evaporation, fogging, scattering, painting on and, in the case of propagation material, in particular in the case of seeds, also by applying one or more coats.

10 The active compounds can be converted into the customary formulations, such as solutions, emulsions, wettable powders, suspensions, powders, dusts, pastes, soluble powders, granules, suspension-emulsion concentrates, natural and synthetic materials impregnated with active compound, and microencapsulations in polymeric substances.

15 These formulations are produced in a known manner, for example by mixing the active compounds with extenders, that is liquid solvents and/or solid carriers, optionally with the use of surfactants, that is emulsifiers and/or dispersants, and/or foam-formers.

20 If the extender used is water, it is also possible to employ for example organic solvents as auxiliary solvents. Essentially, suitable liquid solvents are: aromatics such as xylene, toluene or alkylnaphthalenes, chlorinated aromatics and chlorinated aliphatic hydrocarbons such as chlorobenzenes, chloroethylenes or methylene chloride, aliphatic hydrocarbons such as cyclohexane or paraffins, for example petroleum fractions, mineral and vegetable oils, alcohols such as butanol or glycol and also their ethers and
25 esters, ketones such as acetone, methyl ethyl ketone, methyl isobutyl ketone or cyclohexanone, strongly polar solvents such as dimethylformamide and dimethyl sulphoxide, and also water.

30 Solid carriers are:
for example ammonium salts and ground natural minerals such as kaolins, clays, talc, chalk, quartz, attapulgite, montmorillonite or diatomaceous earth, and ground synthetic

minerals, such as highly disperse silica, alumina and silicates; suitable solid carriers for granules are: for example crushed and fractionated natural rocks such as calcite, marble, pumice, sepiolite and dolomite, and also synthetic granules of inorganic and organic meals, and granules of organic material such as sawdust, coconut shells, maize cobs and tobacco stalks; suitable emulsifiers and/or foam-formers are: for example nonionic and anionic emulsifiers, such as polyoxyethylene fatty acid esters, polyoxyethylene fatty alcohol ethers, for example alkylaryl polyglycol ethers, alkylsulphonates, alkyl sulphates, arylsulphonates and also protein hydrolysates; suitable dispersants are: for example ligno-sulphite waste liquors and methylcellulose.

Tackifiers such as carboxymethylcellulose and natural and synthetic polymers in the form of powders, granules or latices, such as gum arabic, polyvinyl alcohol and polyvinyl acetate, as well as natural phospholipids such as cephalins and lecithins, and synthetic phospholipids, can be used in the formulations. Other additives can be mineral and vegetable oils.

It is possible to use colorants such as inorganic pigments, for example iron oxide, titanium oxide and Prussian Blue, and organic dyes, such as alizarin dyes, azo dyes and metal phthalocyanine dyes, and trace nutrients such as salts of iron, manganese, boron, copper, cobalt, molybdenum and zinc.

The formulations generally comprise between 0.1 and 95% by weight of active compound, preferably between 0.5 and 90%.

The active compound according to the invention can be present in its commercially available formulations and in the use forms, prepared from these formulations, as a mixture with other active compounds, such as insecticides, attractants, sterilizing agents, bactericides, acaricides, nematocides, fungicides, growth-regulating substances or herbicides. The insecticides include, for example, phosphoric acid esters, carbamates, carboxylates, chlorinated hydrocarbons, phenylureas and substances produced by microorganisms, inter alia.

20 A mixture with other known active compounds, such as herbicides, or with fertilizers
and growth regulators is also possible.

The active compounds according to the invention can furthermore be present when
used as insecticides in their commercially available formulations and in the use
forms, prepared from these formulations, as a mixture with synergistic agents.

25 Synergistic agents are compounds which increase the action of the active compounds,
without it being necessary for the synergistic agent added to be active itself.

The active compound content of the use forms prepared from the commercially
available formulations can vary within wide limits. The active compound
concentration of the use forms can be from 0.0000001 to 95% by weight of active
30 compound, preferably between 0.0001 and 1% by weight.

The compounds are employed in a customary manner appropriate for the use forms.

When used against hygiene pests and pests of stored products, the active compound is distinguished by an excellent residual action on wood and clay as well as a good stability to alkali on limed substrates.

The active compounds according to the invention act not only against plant, hygiene and stored product pests, but also in the veterinary medicine sector against animal parasites (ectoparasites), such as hard ticks, soft ticks, mange mites, leaf mites, flies (biting and licking), parasitic fly larvae, lice, hair lice, feather lice and fleas. These parasites include:

From the order of the Anoplurida, for example, *Haematopinus* spp., *Linognathus* spp., *Pediculus* spp., *Phtirus* spp. and *Solenopotes* spp.

From the order of the Mallophagida and the suborders Amblycerina and Ischnocerina, for example, *Trimenopon* spp., *Menopon* spp., *Trinoton* spp., *Bovicola* spp., *Werneckiella* spp., *Lepikentron* spp., *Damalina* spp., *Trichodectes* spp. and *Felicola* spp.

From the order of the Siphonaptera, for example, *Pulex* spp., *Ctenocephalides* spp., *Xenopsylla* spp. and *Ceratophyllus* spp.

From the order of the Heteroptera, for example, *Cimex* spp., *Triatoma* spp.,
Rhodnius spp. and *Panstrongylus* spp.

5 From the order of the Blattaria, for example, *Blatta orientalis*, *Periplaneta*
americana, *Blattella germanica* and *Supella* spp.

10 From the subclass of the Acaria (Acarida) and the orders of the Meta- and

20 They have, for example, excellent activity against *Aphis* spp. and *Myzus* spp.

The active compounds of the formula (I) according to the invention are also suitable
for controlling arthropods which infest agricultural productive livestock, such as, for
example, cattle, sheep, goats, horses, pigs, donkeys, camels, buffalo, rabbits,
25 chickens, turkeys, ducks, geese and bees, other pets, such as, for example, dogs, cats,
caged birds and aquarium fish, and also so-called test animals, such as, for example,
hamsters, guinea pigs, rats and mice. By controlling these arthropods, cases of death
and reduction in productivity (for meat, milk, wool, hides, eggs, honey etc.) should
be diminished, so that more economic and easier animal husbandry is possible by use
30 of the active compounds according to the invention.

The active compounds according to the invention are used in the veterinary sector in a known manner by enteral administration in the form of, for example, tablets, capsules, potions, drenches, granules, pastes, boluses, the feed-through process and suppositories, by parenteral administration, such as, for example, by injection (intramuscular, subcutaneous, intravenous, intraperitoneal and the like), implants, by nasal administration, by dermal use in the form, for example, of dipping or bathing, spraying, pouring on and spotting on, washing and powdering, and also with the aid of moulded articles containing the active compound, such as collars, ear marks, tail marks, limb bands, halters, marking devices and the like.

When used for cattle, poultry, pets and the like, the active compounds of the formula (I) can be used as formulations (for example powders, emulsions, free-flowing compositions), which comprise the active compounds in an amount of 1 to 80% by weight, directly or after 100 to 10 000-fold dilution, or they can be used as a chemical bath.

It has furthermore been found that the compounds according to the invention also have a strong insecticidal action against insects which destroy industrial materials.

The following insects may be mentioned as examples and as being preferred - but without any limitation:

Beetles, such as

Hylotrupes bajulus, *Chlorophorus pilosis*, *Anobium punctatum*, *Xestobium rufovillosum*, *Ptilinus pecticornis*, *Dendrobium pertinex*, *Ernobius mollis*, *Priobium carpini*, *Lyctus brunneus*, *Lyctus africanus*, *Lyctus planicollis*, *Lyctus linearis*, *Lyctus pubescens*, *Trogoxylon aequale*, *Minthes rugicollis*, *Xyleborus spec.*, *Tryptodendron spec.*, *Apate monachus*, *Bostrychus capucins*, *Heterobostrychus brunneus*, *Sinoxylon spec.* and *Dinoderus minutus*.

Hymenopterons, such as

Sirex juvenecus, *Urocerus gigas*, *Urocerus gigas taignus* and *Urocerus augur*.

Termites, such as

- 5 Kaloterms flavicollis, Cryptoterms brevis, Heteroterms indicola, Reticulitermes
flavipes, Reticulitermes santonensis, Reticulitermes lucifugus, Mastoterms
darwiniensis, Zootermopsis nevadensis and Coptoterms formosanus.

Bristletails, such as Lepisma saccharina.

- 10 Industrial materials in the present context are to be understood as meaning non-living
materials, such as, preferably, plastics, adhesives, sizes, papers and cards, leather,
wood and processed wood products and coating compositions.

- 15 Wood and processed wood products are materials to be protected, especially
preferably, from insect infestation.

- Wood and processed wood products which can be protected by the agent according to
the invention or mixtures comprising this are to be understood as meaning, for
example:

- 20 building timber, wooden beams, railway sleepers, bridge components, boat jetties,
wooden vehicles, boxes, pallets, containers, telegraph poles, wood panelling, wooden
windows and doors, plywood, chipboard, joinery or wooden products which are used
quite generally in house-building or in building joinery.

- 25 The active compounds can be used as such, in the form of concentrates or in
generally customary formulations, such as powders, granules, solutions, suspensions,
emulsions or pastes.

- 30 The formulations mentioned can be prepared in a manner known per se, for example
by mixing the active compounds with at least one solvent or diluent, emulsifier,
dispersing agent and/or binder or fixing agent, a water repellent, if appropriate

siccatives and UV stabilizers and if appropriate dyes and pigments, and also other processing auxiliaries.

5 The insecticidal compositions or concentrates used for the preservation of wood and wood-derived timber products comprise the active compound according to the invention in a concentration of 0.0001 to 95% by weight, in particular 0.001 to 60% by weight.

10 The amount of the compositions or concentrates employed depends on the nature and occurrence of the insects and on the medium. The optimum amount employed can be determined for the use in each case by a series of tests. In general, however, it is sufficient to employ 0.0001 to 20% by weight, preferably 0.001 to 10% by weight, of the active compound, based on the material to be protected.

15 Solvents and/or diluents which are used are an organic chemical solvent or solvent mixture and/or an oily or oil-like organic chemical solvent or solvent mixture of low volatility and/or a polar organic chemical solvent or solvent mixture and/or water, and if appropriate an emulsifier and/or wetting agent.

20 Organic chemical solvents which are preferably used are oily or oil-like solvents having an evaporation number above 35 and a flashpoint above 30°C, preferably above 45°C. Substances which are used as such oily or oil-like water-insoluble solvents of low volatility are appropriate mineral oils or aromatic fractions thereof, or solvent mixtures containing mineral oils, preferably white spirit, petroleum and/or
25 alkylbenzene.

Mineral oils having a boiling range from 170 to 220°C, white spirit having a boiling range from 170 to 220°C, spindle oil having a boiling range from 250 to 350°C, petroleum and aromatics having a boiling range from 160 to 280°C, turpentine oil
30 and the like, are advantageously employed.

In a preferred embodiment, liquid aliphatic hydrocarbons having a boiling range from 180 to 210°C or high-boiling mixtures of aromatic and aliphatic hydrocarbons having a boiling range from 180 to 220°C and/or spindle oil and/or monochloronaphthalene, preferably α -monochloronaphthalene, are used.

5

The organic oily or oil-like solvents of low volatility which have an evaporation number above 35 and a flashpoint above 30°C, preferably above 45°C, can be replaced in part by organic chemical solvents of high or medium volatility, provided that the solvent mixture likewise has an evaporation number above 35 and a
10 flashpoint above 30°C, preferably above 45°C, and that the insecticide/fungicide mixture is soluble or emulsifiable in this solvent mixture.

15

According to a preferred embodiment, some of the organic chemical solvent or solvent mixture is replaced by an aliphatic polar organic chemical solvent or solvent mixture. Aliphatic organic chemical solvents containing hydroxyl and/or ester and/or ether groups, such as, for example, glycol ethers, esters or the like, are preferably used.

20

Organic chemical binders which are used in the context of the present invention are the synthetic resins and/or binding drying oils which are known per se, are water-dilutable and/or are soluble or dispersible or emulsifiable in the organic chemical solvents employed, in particular binders consisting of or comprising an acrylate resin, a vinyl resin, for example polyvinyl acetate, polyester resin, polycondensation or polyaddition resin, polyurethane resin, alkyd resin or modified alkyd resin, phenolic
25 resin, hydrocarbon resin, such as indene-coumarone resin, silicone resin, drying vegetable oils and/or drying oils and/or physically drying binders based on a natural and/or synthetic resin.

30

The synthetic resin used as the binder can be employed in the form of an emulsion, dispersion or solution. Bitumen or bituminous substances can also be used as binders in an amount of up to 10% by weight. Dyestuffs, pigments, water-repelling agents,

odour correctants and inhibitors or anticorrosive agents and the like which are known per se can additionally be employed.

5 It is preferred according to the invention for the composition or concentrate to comprise, as the organic chemical binder, at least one alkyd resin or modified alkyd resin and/or one drying vegetable oil. Alkyd resins having an oil content of more than 45% by weight, preferably 50 to 68% by weight, are preferably used according to the invention.

10 All or some of the binder mentioned can be replaced by a fixing agent (mixture) or a plasticizer (mixture). These additives are intended to prevent evaporation of the active compounds and crystallization or precipitation. They preferably replace 0.01 to 30% of the binder (based on 100% of the binder employed).

15 The plasticizers originate from the chemical classes of phthalic acid esters, such as dibutyl, dioctyl or benzyl butyl phthalate, phosphoric acid esters, such as tributyl phosphate, adipic acid esters, such as di-(2-ethylhexyl) adipate, stearates, such as butyl stearate or amyl stearate, oleates, such as butyl oleate, glycerol ethers or higher molecular weight glycol ethers, glycerol esters and p-toluenesulphonic acid esters.

20 Fixing agents are based chemically on polyvinyl alkyl ethers, such as, for example, polyvinyl methyl ether or ketones, such as benzophenone or ethylenebenzophenone.

25 Possible solvents or diluents are, in particular, also water, if appropriate as a mixture with one or more of the abovementioned organic chemical solvents or diluents, emulsifiers and dispersing agents.

Particularly effective preservation of wood is achieved by impregnation processes on a large industrial scale, for example vacuum, double vacuum or pressure processes.

30 The ready-to-use compositions can also comprise other insecticides, if appropriate, and also one or more fungicides, if appropriate.

Possible additional mixing partners are, preferably, the insecticides and fungicides mentioned in WO 94/29 268. The compounds mentioned in this document are an explicit constituent of the present application.

5

Especially preferred mixing partners which may be mentioned are insecticides, such as chlorpyrifos, phoxim, silafluofin, alphasmethrin, cyfluthrin, cypermethrin, deltamethrin, permethrin, imidacloprid, NI-25, flufenoxuron, hexaflumuron, transfluthrin, thiacloprid, methoxyphenoxide and triflumuron,

10

and also fungicides, such as epoxyconazole, hexaconazole, azaconazole, propiconazole, tebuconazole, cyproconazole, metconazole, imazalil, dichlorfuanid, tolylfluaniid, 3-iodo-2-propinyl-butyl carbamate, N-octyl-isothiazolin-3-one and 4,5-dichloro-N-octylisothiazolin-3-one.

15

The compounds according to the invention can at the same time be employed for protecting objects which come into contact with salt water or brackish water, such as hulls, screens, nets, buildings, moorings and signalling systems, against fouling.

20

Fouling by sessile Oligochaeta, such as Serpulidae, and by shells and species from the Lepadomorpha group (goose barnacles), such as various Lepas and Scalpellum species, or by species from the Balanomorpha group (acorn barnacles), such as Balanus or Pollicipes species, increases the frictional drag of ships and, as a consequence, leads to a marked increase in operation costs owing to higher energy consumption and additionally frequent residence in the dry dock.

25

Apart from fouling by algae, for example Ectocarpus sp. and Ceramium sp., fouling by sessile Entomostraka groups, which come under the generic term Cirripedia (cirriped crustaceans), is of particular importance.

30

Surprisingly, it has now been found that the compounds according to the invention, alone or in combination with other active compounds, have an outstanding antifouling action.

Using compounds according to the invention, alone or in combination with other active compounds, allows the use of heavy metals such as, for example, in bis-(trialkyltin) sulphides, tri-n-butyltin laurate, tri-n-butyltin chloride, copper(I) oxide, triethyltin chloride, tri-n-butyl(2-phenyl-4-chlorophenoxy)tin, tributyltin oxide, molybdenum disulphide, antimony oxide, polymeric butyl titanate, phenyl-(bispyridine)-bismuth chloride, tri-n-butyltin fluoride, manganese ethylenebisthiocarbamate, zinc dimethyldithiocarbamate, zinc ethylenebisthiocarbamate, zinc salts and copper salts of 2-pyridinethiol 1-oxide, bisdimethyldithiocarbamoylzinc ethylene-bisthiocarbamate, zinc oxide, copper(I) ethylene-bisdithiocarbamate, copper thiocyanate, copper naphthenate and tributyltin halides to be dispensed with, or the concentration of these compounds to be substantially reduced.

If appropriate, the ready-to-use antifouling paints can additionally comprise other active compounds, preferably algicides, fungicides, herbicides, molluscicides, or other antifouling active compounds.

Preferably suitable components in combination with the antifouling compositions according to the invention are:

algicides such as
2-tert-butylamino-4-cyclopropylamino-6-methylthio-1,3,5-triazine, dichlorophen, diuron, endothal, fentin acetate, isoproturon, methabenzthiazuron, oxyfluorfen, quinoclamine and terbutryn;

fungicides such as
benzo[b]thiophenecarboxylic acid cyclohexylamide S,S-dioxide, dichlofluanid, fluorfolpet, 3-iodo-2-propenyl butylcarbamate, tolylfluanid and azoles such as azaconazole, cyproconazole, epoxyconazole, hexaconazole, metconazole, propiconazole and tebuconazole;

molluscicides such as

fentin acetate, metaldehyde, methiocarb, niclosamid, thiodicarb and trimethacarb;

or conventional antifouling active compounds such as

4,5-dichloro-2-octyl-4-isothiazolin-3-one, diiodomethylparatryl sulphone, 2-(N,N-dimethylthiocarbamoylthio)-5-nitrothiazyl, potassium, copper, sodium and zinc salts of
5 2-pyridinethiol 1-oxide, pyridine-triphenylborane, tetrabutylstannoxane, 2,3,5,6-tetrachloro-4-(methylsulphonyl)-pyridine, 2,4,5,6-tetrachloroisophthalonitrile, tetramethylthiuram disulphide and 2,4,6-trichlorophenylmaleimide.

The antifouling compositions used comprise the active compound according to the
10 invention of the compounds according to the invention in a concentration of 0.001 to 50% by weight, in particular 0.01 to 20% by weight.

Moreover, the antifouling compositions according to the invention comprise the
15 customary components such as, for example, those described in Ungerer, *Chem. Ind.* 1985, 37, 730-732 and Williams, *Antifouling Marine Coatings*, Noyes, Park Ridge, 1973.

Besides the algicidal, fungicidal, molluscicidal active compounds and insecticidal
20 active compounds according to the invention, antifouling paints comprise, in particular, binders.

Examples of recognized binders are polyvinyl chloride in a solvent system, chlorinated rubber in a solvent system, acrylic resins in a solvent system, in particular
25 in an aqueous system, vinyl chloride/vinyl acetate copolymer systems in the form of aqueous dispersions or in the form of organic solvent systems, butadiene/styrene/acrylonitrile rubbers, drying oils such as linseed oil, resin esters or modified hardened resins in combination with tar or bitumens, asphalt and epoxy compounds, small amounts of chlorine rubber, chlorinated polypropylene and vinyl resins.

30 If appropriate, paints also comprise inorganic pigments, organic pigments or colorants which are preferably insoluble in salt water. Paints may furthermore

comprise materials such as colophonium to allow controlled release of the active compounds. Furthermore, the paints may comprise plasticizers, modifiers which affect the rheological properties and other conventional constituents. The compounds according to the invention or the abovementioned mixtures may also be incorporated
5 into self-polishing antifouling systems.

The active compounds are also suitable for controlling animal pests, in particular insects, arachnids and mites, which are found in enclosed spaces such as, for example, dwellings, factory halls, offices, vehicle cabins and the like. They can be
10 employed in domestic insecticide products for controlling these pests alone or in combination with other active compounds and auxiliaries. They are active against sensitive and resistant species and against all developmental stages. These pests include:

- 15 From the order of the Scorpionidea, for example, *Buthus occitanus*.

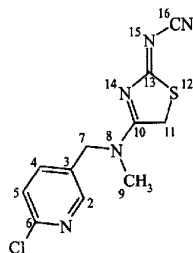

- 25 suitable active compounds such as phosphoric esters, carbamates, pyrethroids,
growth regulators or active compounds from other known classes of insecticides.
- They are used in aerosols, pressure-free spray products, for example pump and
atomizer sprays, automatic fogging systems, foggers, foams, gels, evaporator
- 30 products with evaporator tablets made of cellulose or polymer, liquid evaporators, gel
and membrane evaporators, propeller-driven evaporators, energy-free, or passive,

evaporation systems, moth papers, moth bags and moth gels, as granules or dusts, in baits for spreading or in bait stations.

Preparation Examples

Example I-1

- 5 4-(N-(6-chloro-3-pyridylmethyl)-N-methyl)amino-2-cyanimino-2,5-dihydro-[1,3]-thiazoline



- 10 0.75 g (10.0 mmol) of chloroacetonitrile is added dropwise to a solution, cooled to 5°C, of 0.03 g (1.3 mmol) of sodium in 20 ml of abs. methanol. After the addition has ended, the mixture is stirred at this temperature for 1 hour, with exclusion of moisture. 1.93 g (10.0 mmol) of N,N-methyl-(6-chloro-3-pyridylmethyl)amine hydrochloride in 60 ml of abs. methanol are added dropwise over a period of 1 hour to this solution and the reaction mixture is warmed to room temperature and stirred
- 15 for 20 hours. Under reduced pressure, the solvent is removed completely at room temperature using a rotary evaporator. The oily residue is, without further work-up, dissolved in 40 ml of acetone, 1.70 g (10.0 mmol) of potassium N-cyaniminomethyl-sulfanylmethanethiolate are added and the mixture is stirred at room temperature for five hours. The reaction mixture is concentrated using a rotary evaporator, resulting
- 20 in the crystallisation of the product. The residue is filtered and recrystallised from ethanol.

Potassium N-cyanoiminomethylsulphonylmethanethiolate (XI)

a) Preparation of the dipotassium salt of cyanoimidodithiocarbonic acid

Under an atmosphere of nitrogen, in a 500 ml four-necked flask fitted with overhead stirrer, dropping funnel, thermometer and reflux condenser, 21.0 g (0.50 mol) of

cyanamide in 40 ml of ethanol are cooled to 0°C. At this temperature, 41.9 g (0.55 mol) of carbon disulfide and then 56.1 g (1.00 mol) of potassium hydroxide in 180 ml of ethanol are successively added dropwise such that the internal temperature does not exceed 5°C (about 4 hours). After the addition has ended, the cooling bath is removed and the mixture is stirred at room temperature overnight. The resulting solid is filtered off, washed with ethanol and dried under reduced pressure. The resulting salt is hygroscopic and, during filtration, should only be in contact with the atmosphere/atmospheric humidity for a short time. For the next step, the salt is used as crude product. The yield is 75-80% of theory.

b) Potassium N-cyaniminomethylsulfanylmethanethiolate

77.7 g (0.40 mol) of the crude product are dissolved in a mixture of 270 ml of acetone and 300 ml of water and cooled to 0°C. At this temperature, with vigorous stirring, 56.8 g (0.40 mol) of methyl iodide in 150 ml of acetone are slowly added dropwise over a period of three hours. After the addition has ended, the reaction mixture is stirred at 0°C for one hour and then at room temperature for another three hours. On a rotary evaporator, all solvents are removed to dryness. The residue is taken up in 250 ml of abs. acetone and, using a rotary evaporator, concentrated to half of its original volume. For crystallisation of the resulting potassium iodide, the reaction mixture is kept in a fridge overnight. The resulting solid is filtered off and the filtrate is concentrated further, almost to dryness. In the cold, the desired product precipitates out. The last step can now be repeated to complete remove the potassium iodide. The yield is 75-80% of theory. The analytical data are consistent with the literature.

Use Examples

Example A

5 **Meloidogyne Test**

Solvent: 7 parts by weight of dimethylformamide

Emulsifier: 2 parts by weight of alkylaryl polyglycol ether

10 To produce a suitable preparation of active compound, 1 part by weight of active compound is mixed with the stated amounts of solvent and emulsifier, and the concentrate is diluted with water to the desired concentration.

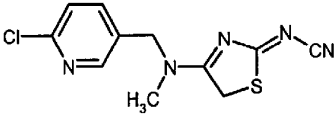
15 Containers are filled with sand, solution of active compound, *Meloidogyne incognita* egg larvae suspension and lettuce seeds. The lettuce seeds germinate and the plants develop. On the roots, galls are formed.

20 After the desired period of time, the nematocidal action is determined in % using gall formation as a measure. 100% means that no galls were found; 0% means that the number of galls on the treated plants corresponds to that of the untreated control.

20 unfed adult fleas (*Ctenocephalides felis*, strain „Georgi“) are placed into a chamber (Ø 5 cm) whose top and bottom are closed with gauze. A metal cylinder whose underside is covered with parafilm is placed onto the chamber. The cylinder contains the 4 ml of blood/active compound formulation which can be taken up by the fleas through the parafilm membrane. Whereas the blood is warmed to 37°C, the temperature in the area of the flea chambers is adjusted to 25°C. Controls are mixed with the same volume of DMSO, without addition of a compound. The determinations are carried out triplicate.

After 24 h, the mortality in % is determined.

Compounds which effect an at least 25% kill of the fleas within 24 h are judged to be effective.
