(57) **CLAIM**

The ornamental design for a wrist band data storage device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a clasped wrist band data storage device illustrating the new design;

FIG. 2 is a right side view thereof; where a left side view is not presented, as it is a mirror image of the right side view;

FIG. 3 is a top side view thereof;

FIG. 4 is a bottom side view thereof;



FIG. 5 is a front view thereof;














