 FIG. 9 is a top, front, and right side perspective view thereof, shown in an open condition.

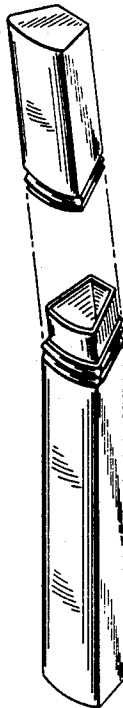

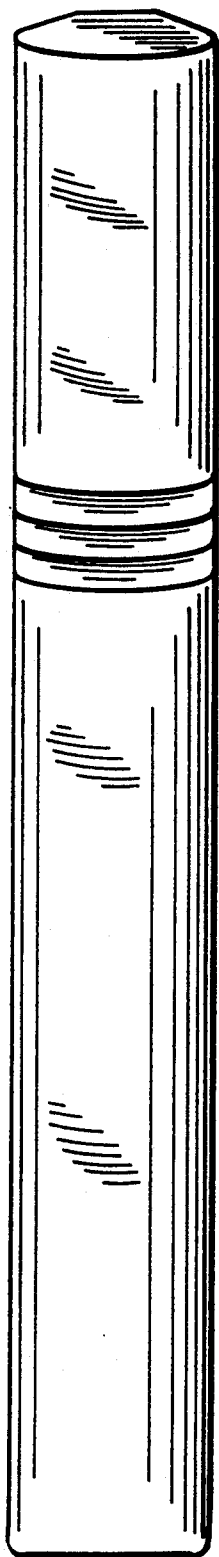

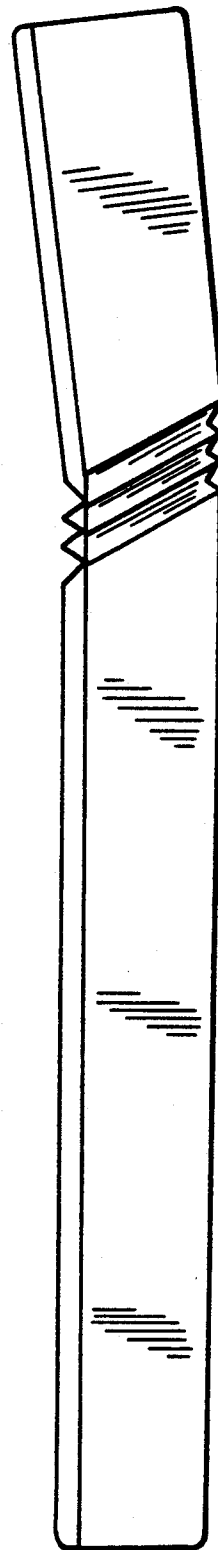

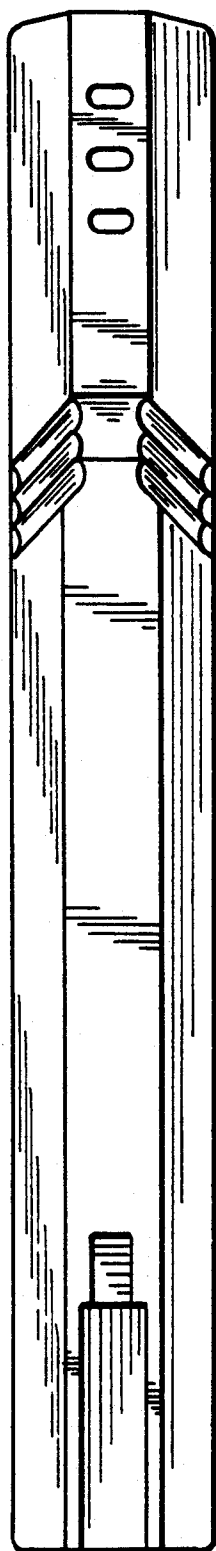

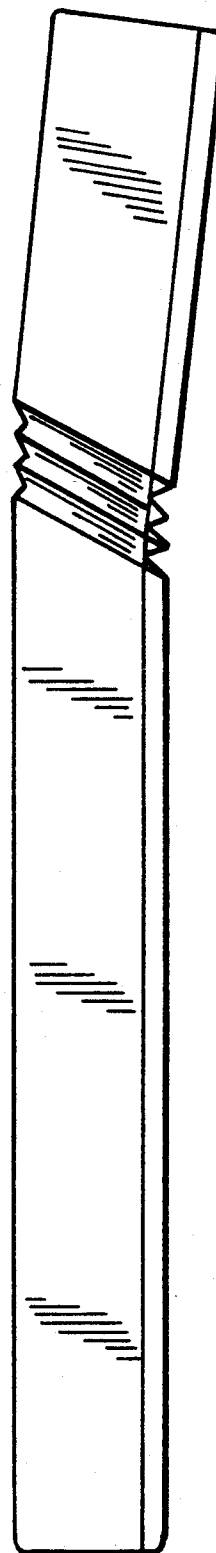

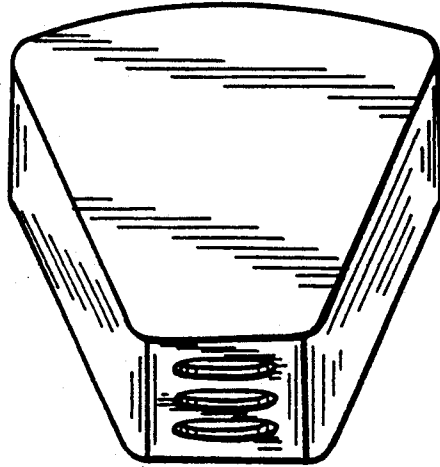

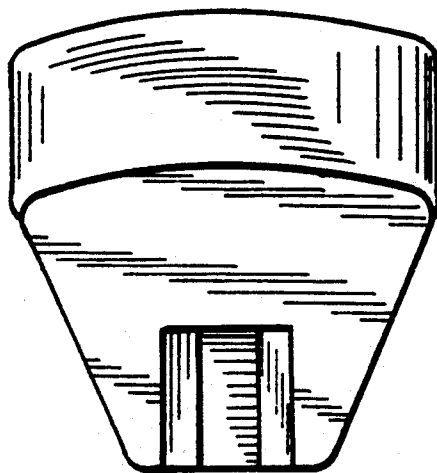

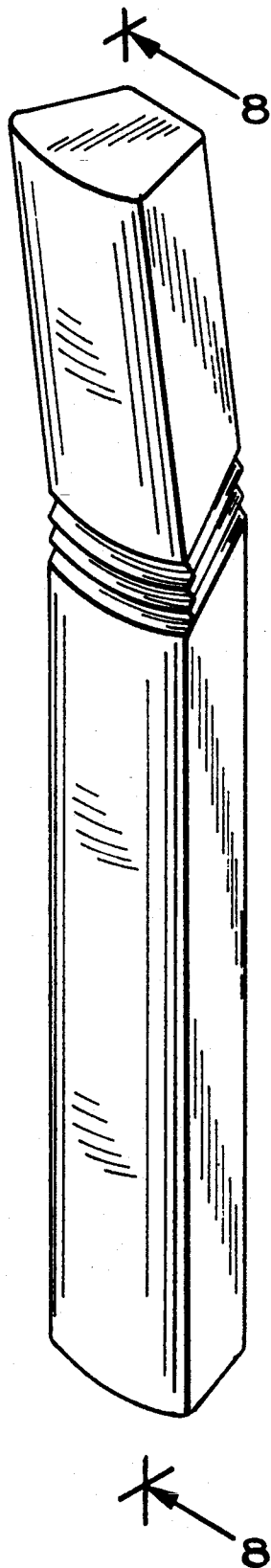
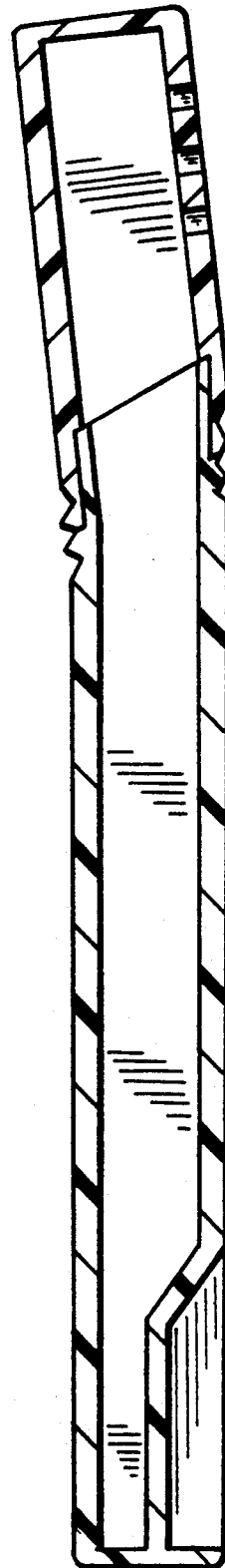

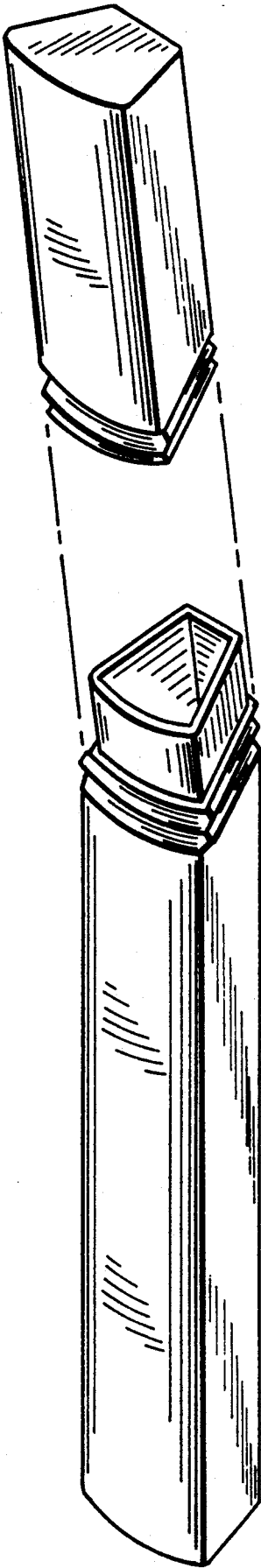
