The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a bottle showing our new design;

FIG. 2 is a bottom perspective view thereof;

FIG. 3 is a front elevation view thereof, the rear elevation view being identical except from the unclaimed thread details;


FIG. 4 is a left side elevation view thereof, the right side elevation view being identical except from the unclaimed thread details;

FIG. 5 is a top plan view thereof; and,

FIG. 6 is a bottom plan view thereof.












