I claim the ornamental design for a bed, as shown and described.

DESCRIPTION

FIG. 1 is a top isometric view of a mattress of the present invention.

FIG. 2 is a right side plan view of the mattress of FIG. 1.

FIG. 3 is a front end plan view of the mattress of FIG. 1.


FIG. 4 is a left side plan view of the mattress of FIG. 1.










