(57) **CLAIM**

The ornamental design for a clasp, as shown and described.

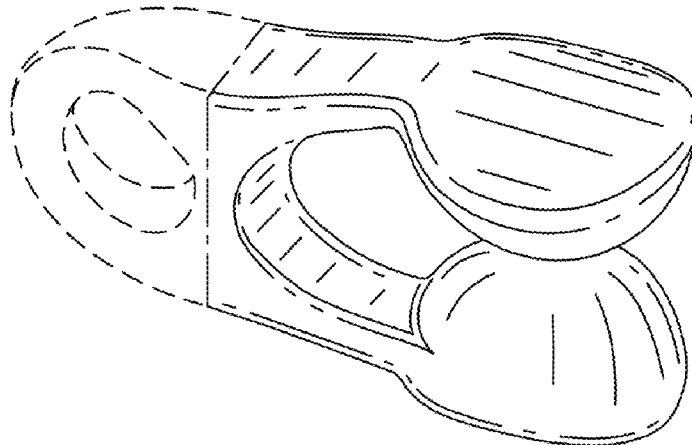
DESCRIPTION

FIG. 1 is a front, right perspective view of a clasp according to the present design;
 FIG. 2 is a right side view thereof, the left side view being a mirror image;
 FIG. 3 is a top-down view thereof, the bottom-up view being a mirror image;
 FIG. 4 is a front side view thereof;
 FIG. 5 is a rear side view thereof;
 FIG. 6 is a left, rear perspective thereof coupled to a second clasp;
 FIG. 7 is a top-down view thereof, the bottom-up view being a mirror image;
 FIG. 8 is a left side view thereof, the right side view being a mirror image;
 FIG. 9 is a front side view thereof;
 FIG. 10 is a rear side view thereof; and,
 FIG. 11 is a left, rear perspective view thereof and a necklace strand.

The surface shading indicates the character and contour of the claimed design and does not represent surface ornamentation.

The dash-dash broken lines showing a second clasp and necklace strand in FIGS. 6-10 illustrate environmental structure. All other dash-dash broken lines shown in FIGS. 1-10 illustrate portions of the clasp. The dash-dot broken lines represent the bounds of the claim. The broken lines form no part of the claimed design.

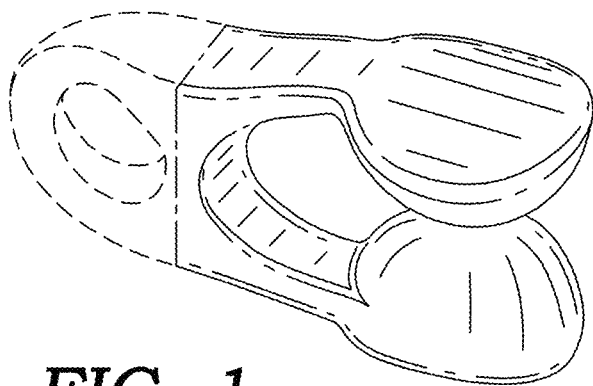

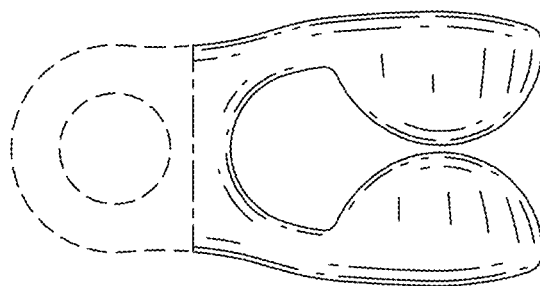

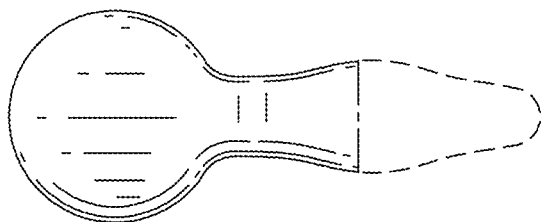

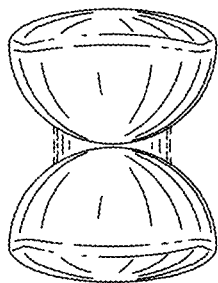

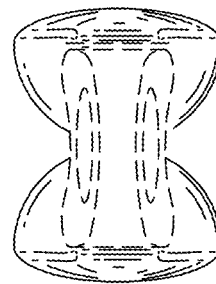

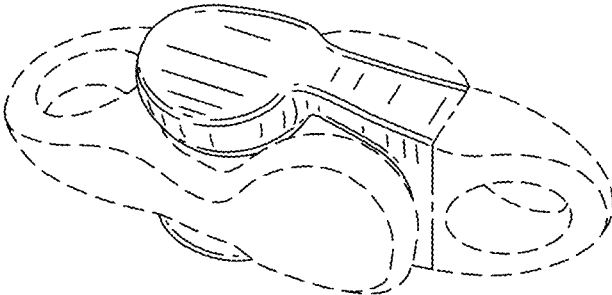

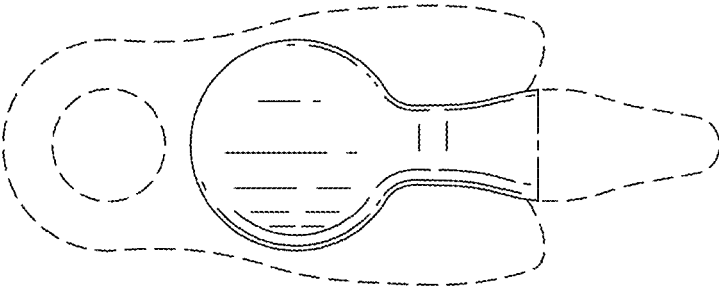

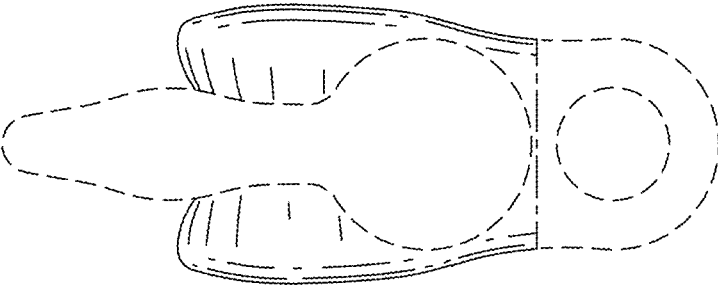

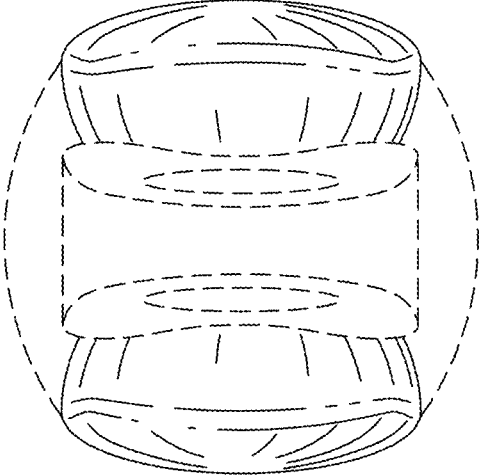

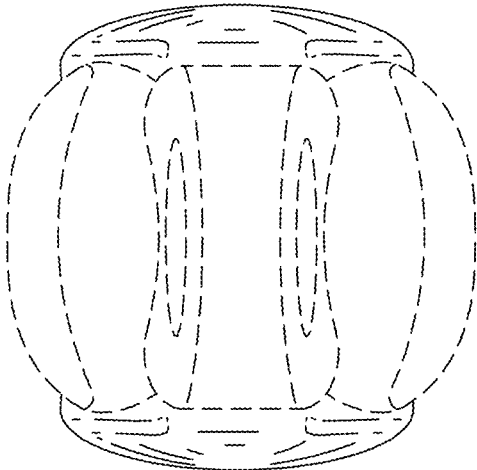

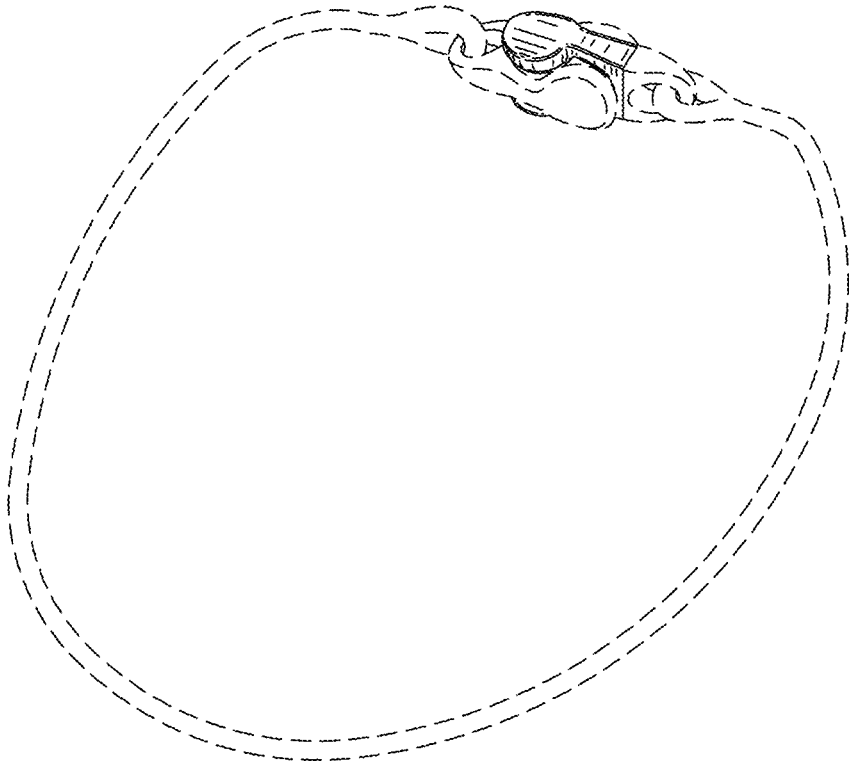
