(57) **CLAIM**

The ornamental design for a strap overlay for an article of headwear, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the strap overlay for an article of headwear.

FIG. 6 is a top view thereof.

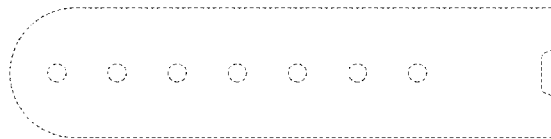
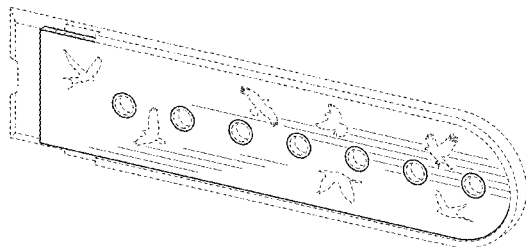
FIG. 7 is a bottom view thereof; and,

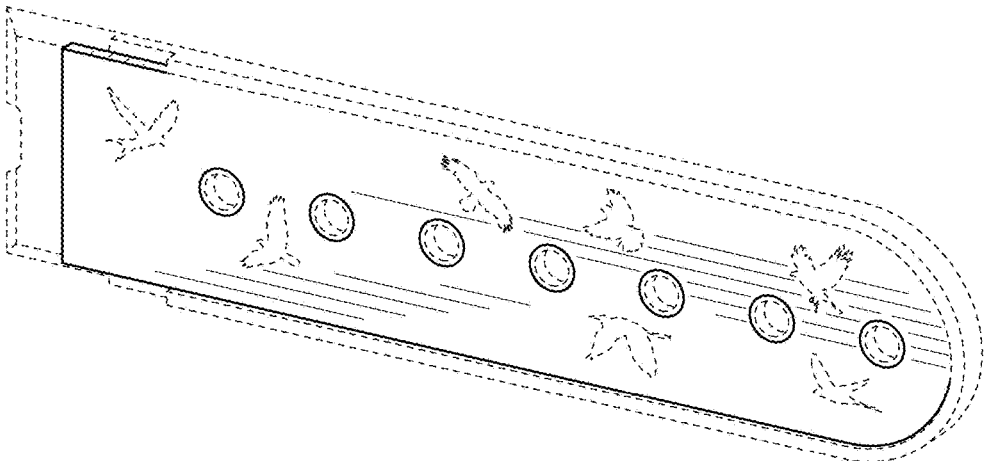

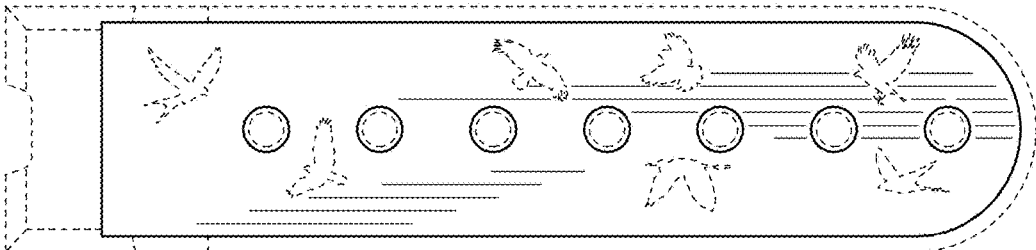

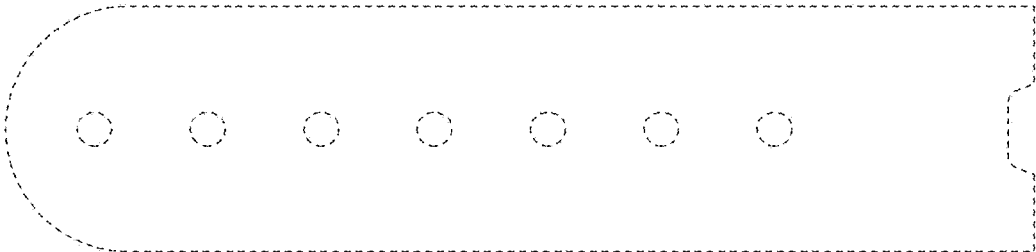

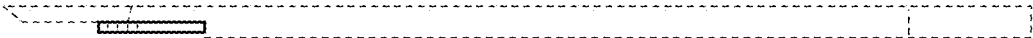

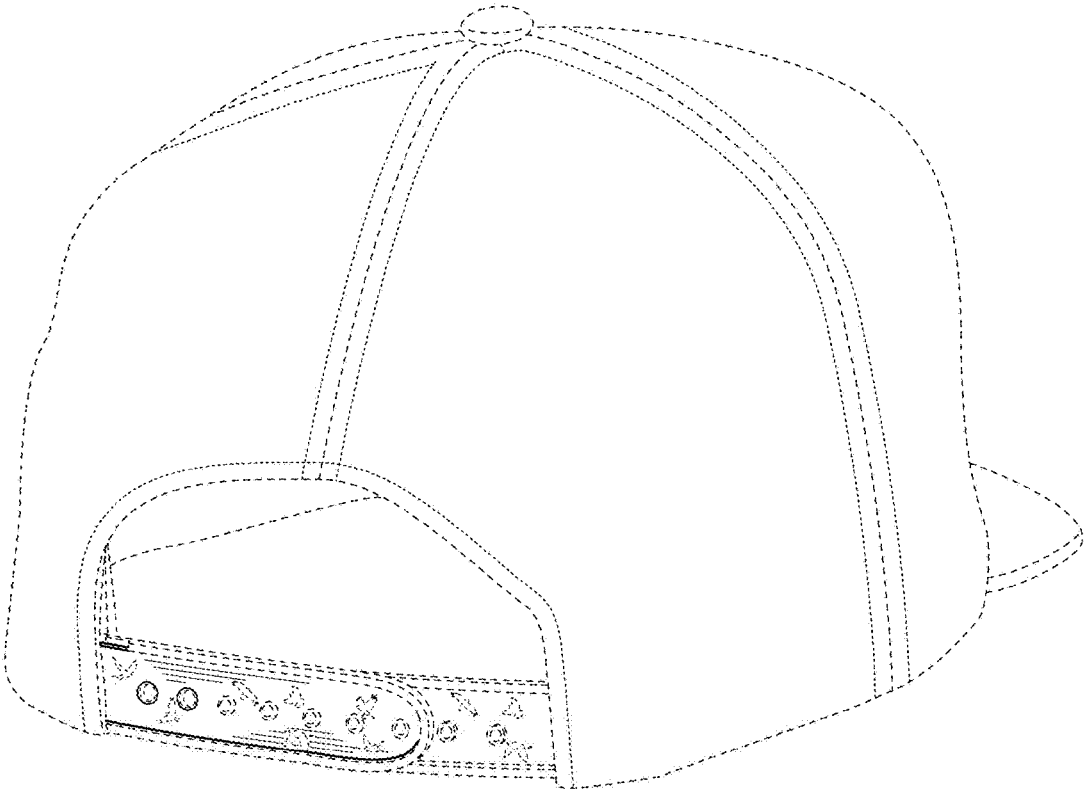
