(57) **CLAIM**

The ornamental design for a drum for washing machine, as shown and described.

DESCRIPTION

FIG. 1 is the front/right-side/top perspective view of a drum for washing machine showing our new design; FIG. 2 is the front elevational view thereof; FIG. 3 is the rear elevational view thereof; FIG. 4 is the left-side elevational view thereof; FIG. 5 is the right-side elevational view thereof; FIG. 6 is the top plan view thereof; FIG. 7 is the bottom plan view thereof; and, FIG. 8 is the enlarged partial view of a cut-away portion with the cross-sectional view of FIG. 1. The dashed broken lines are for environmental purposes only and form no part of the claimed design.
















