FIG. 4 is a left side view of the bottle closure;

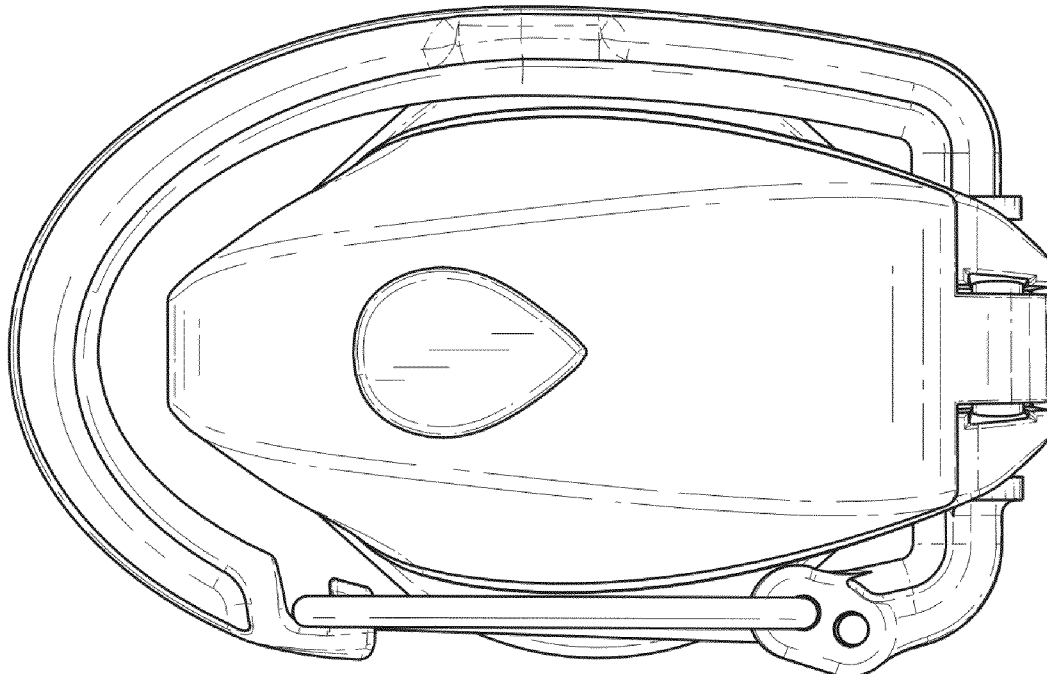
FIG. 5 is a rear view of the bottle closure;

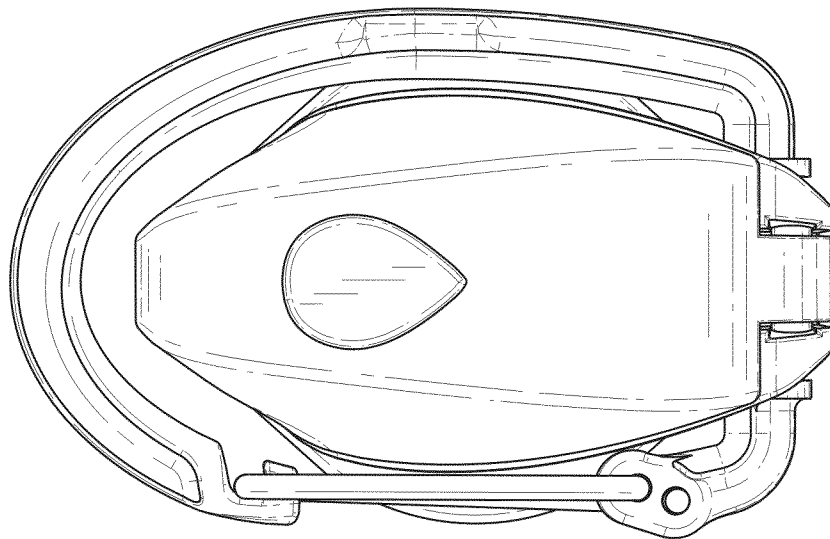

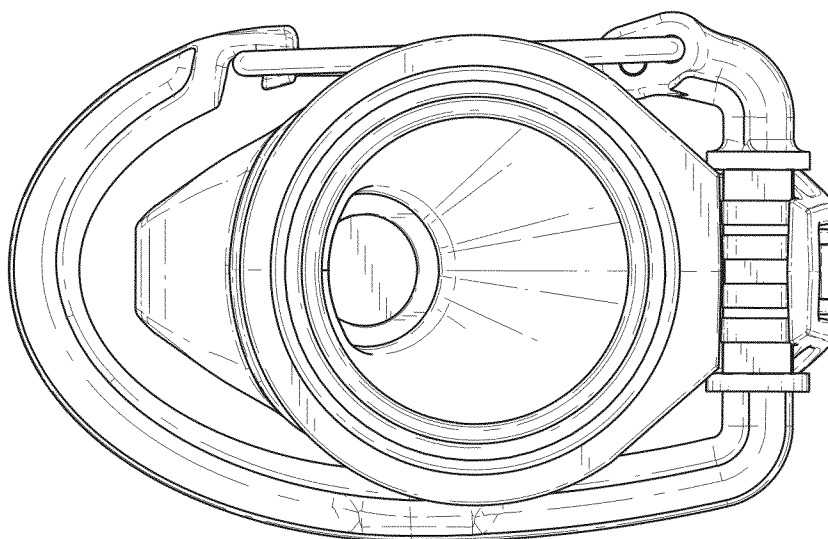

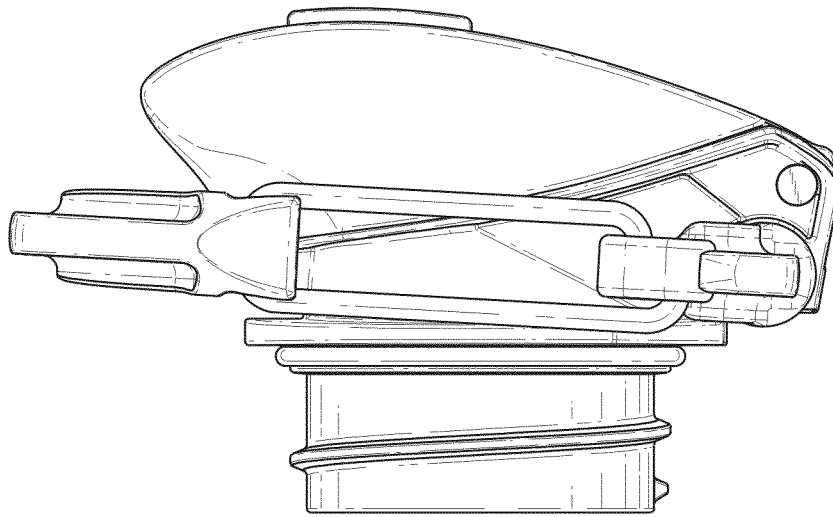

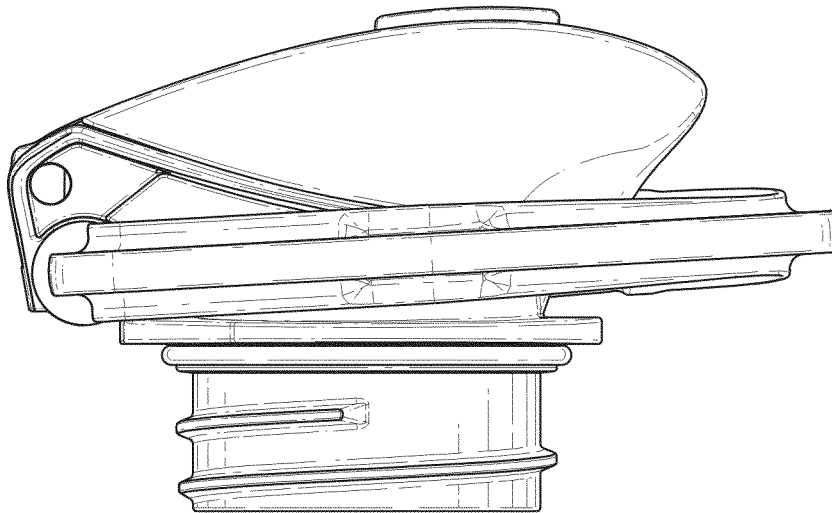

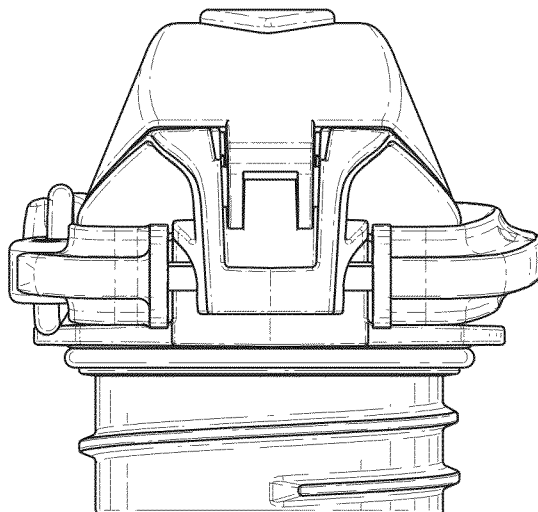

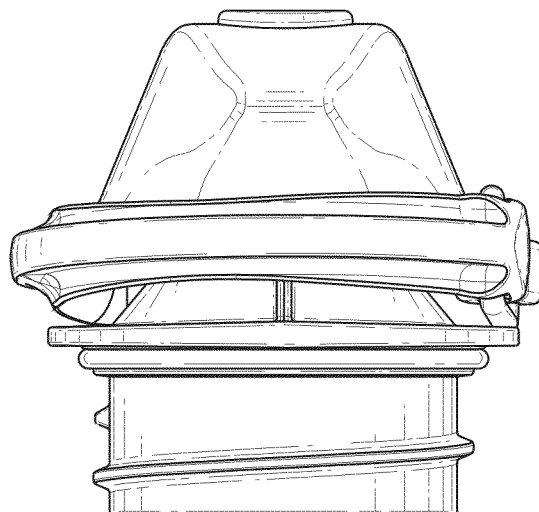

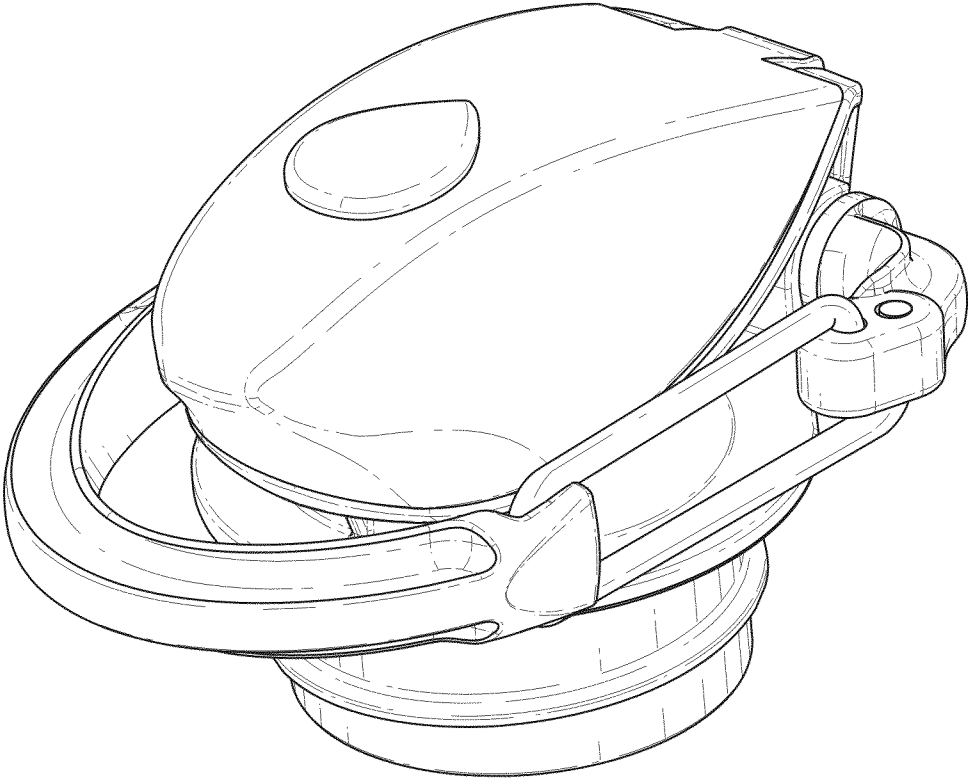

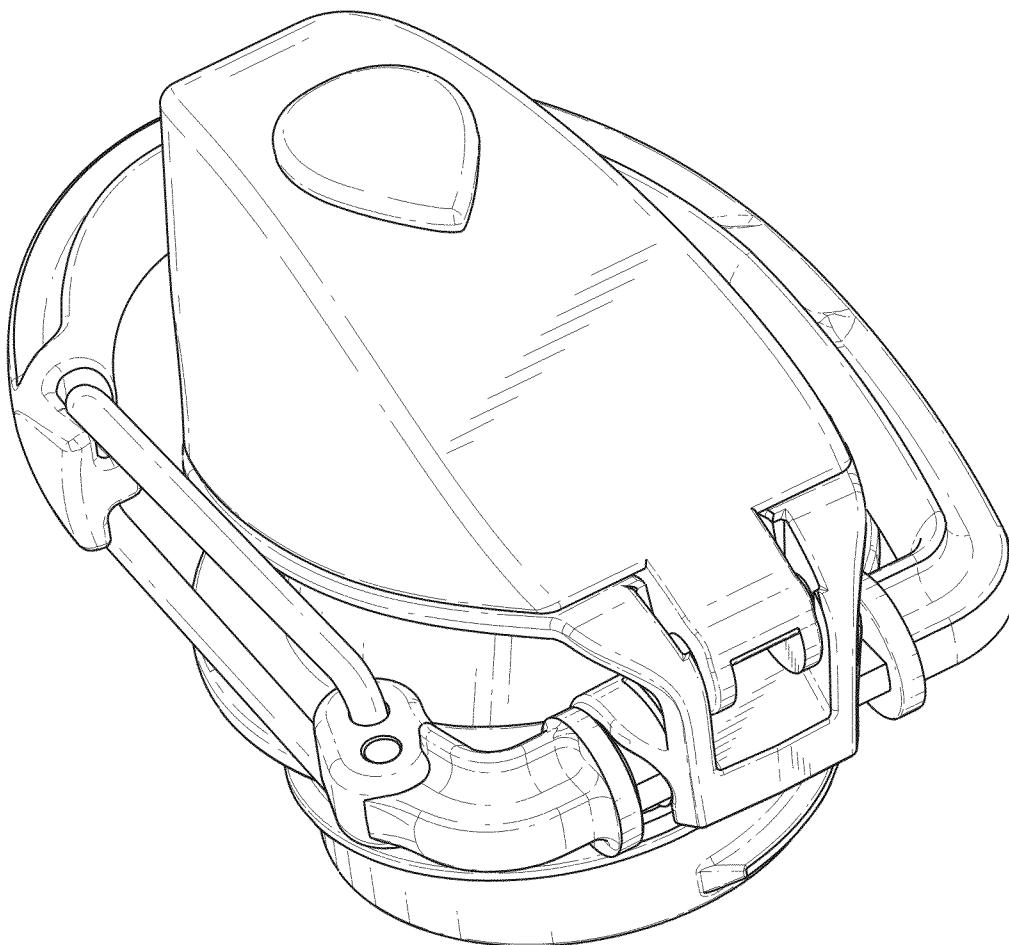
