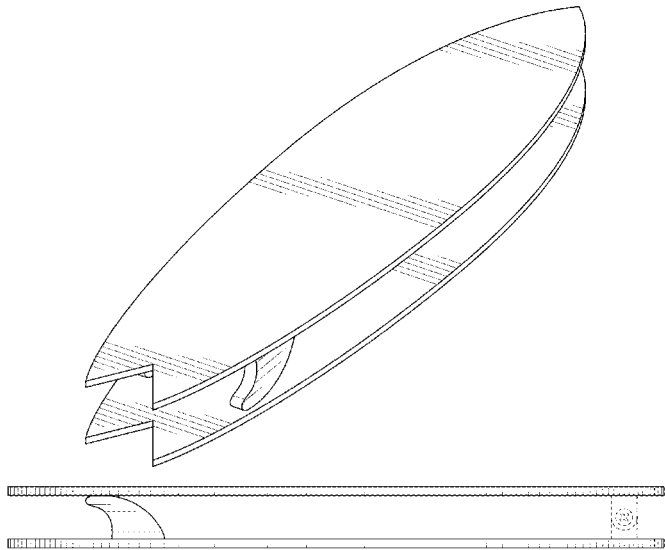

 The ornamental design for a door knocker, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a door knocker showing my new design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a left elevational view thereof;
 FIG. 5 is a right elevational view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a bottom perspective view thereof; and,
 FIG. 9 is a left, perspective view thereof.
 FIGS. 1 through 9 illustrate a door knocker. The broken lines shown in the figures depict portions of the door knocker that form no part of the claimed design.

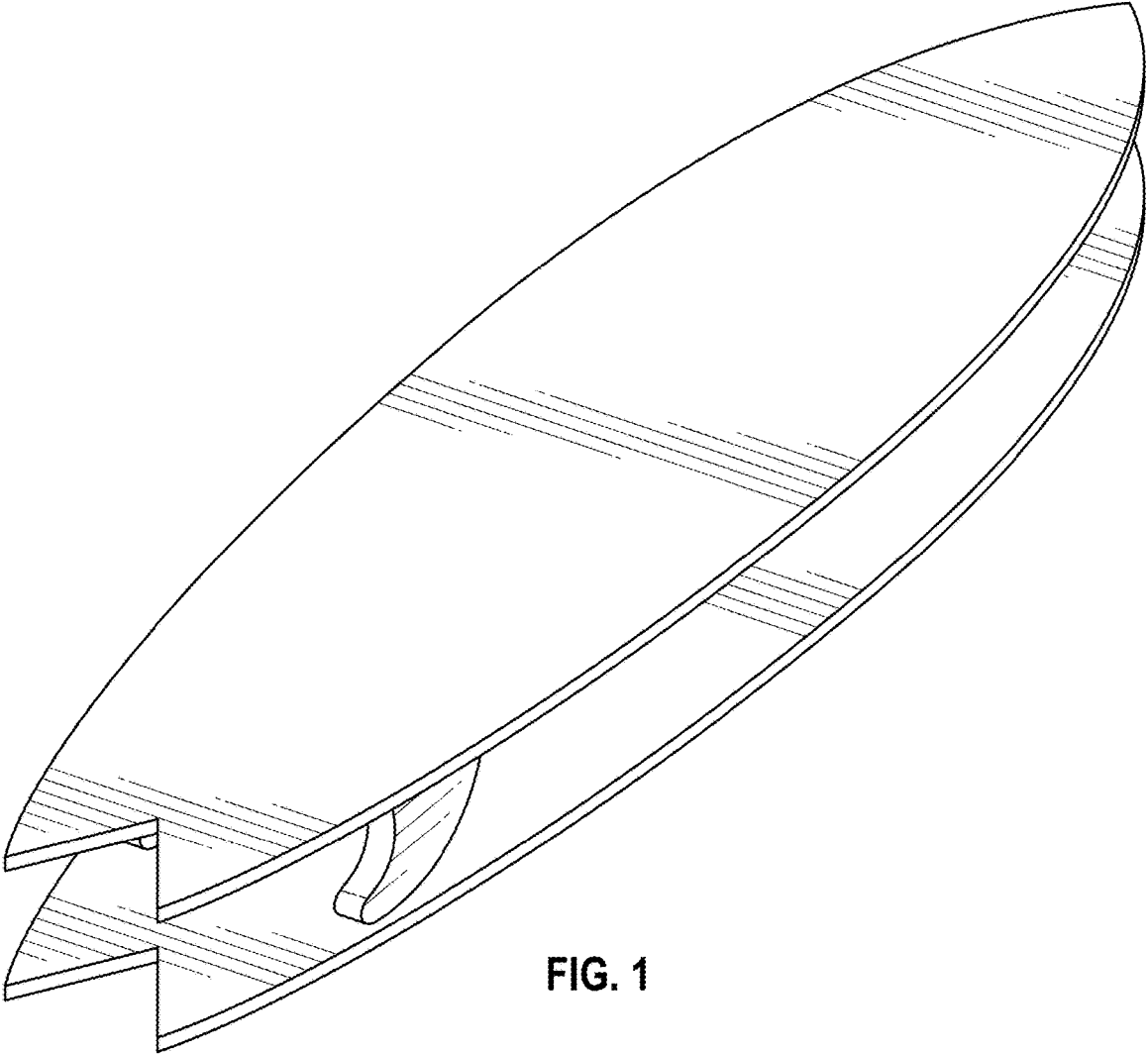

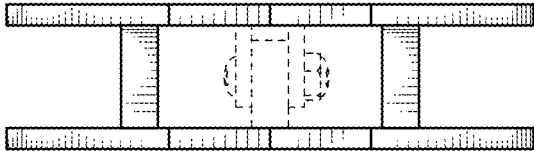

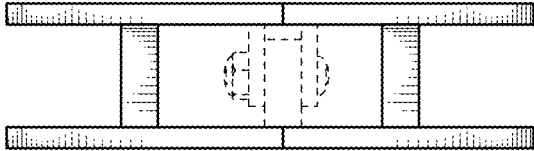

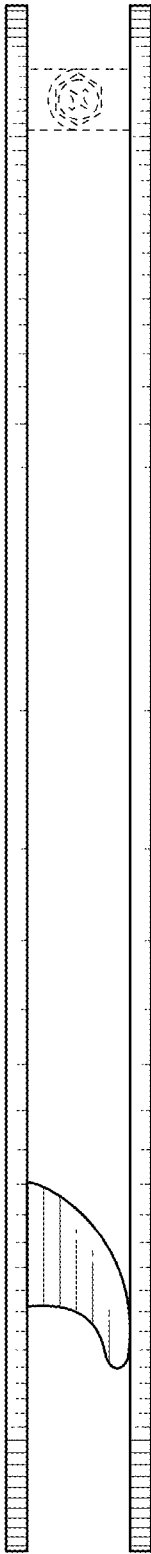

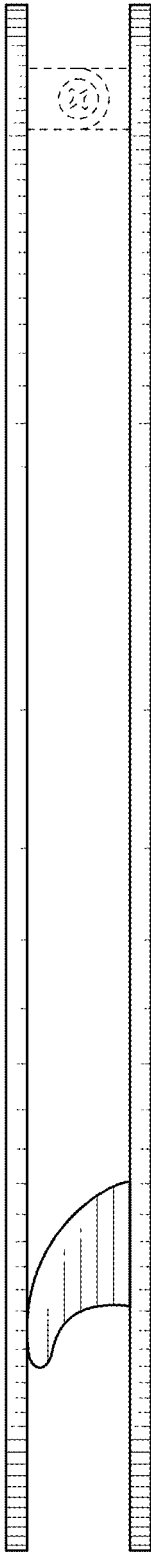

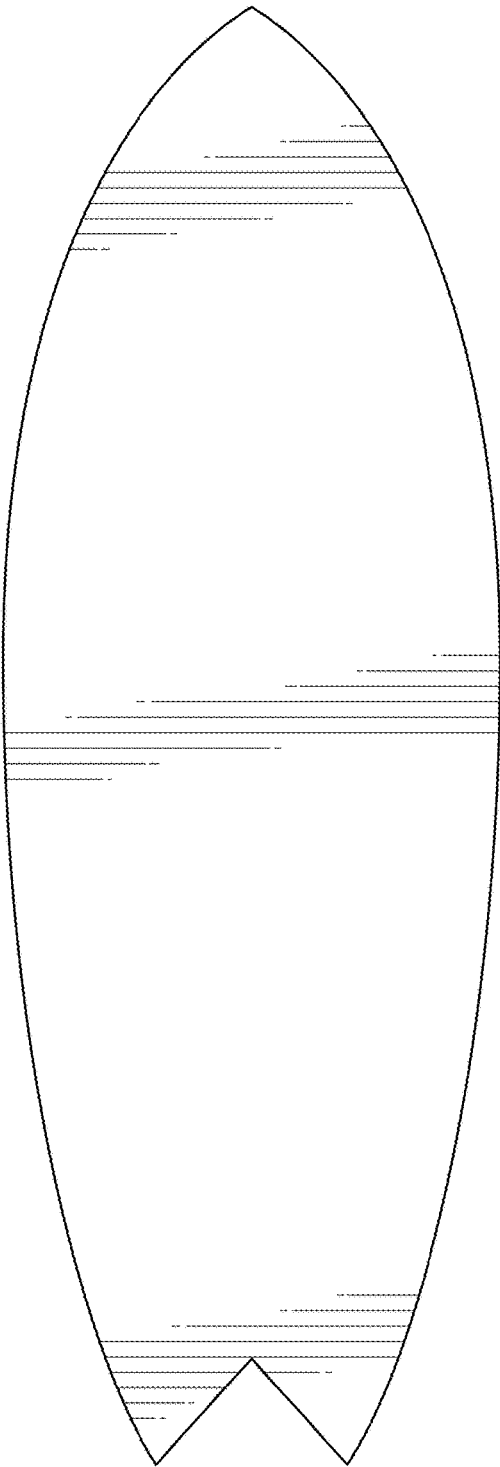

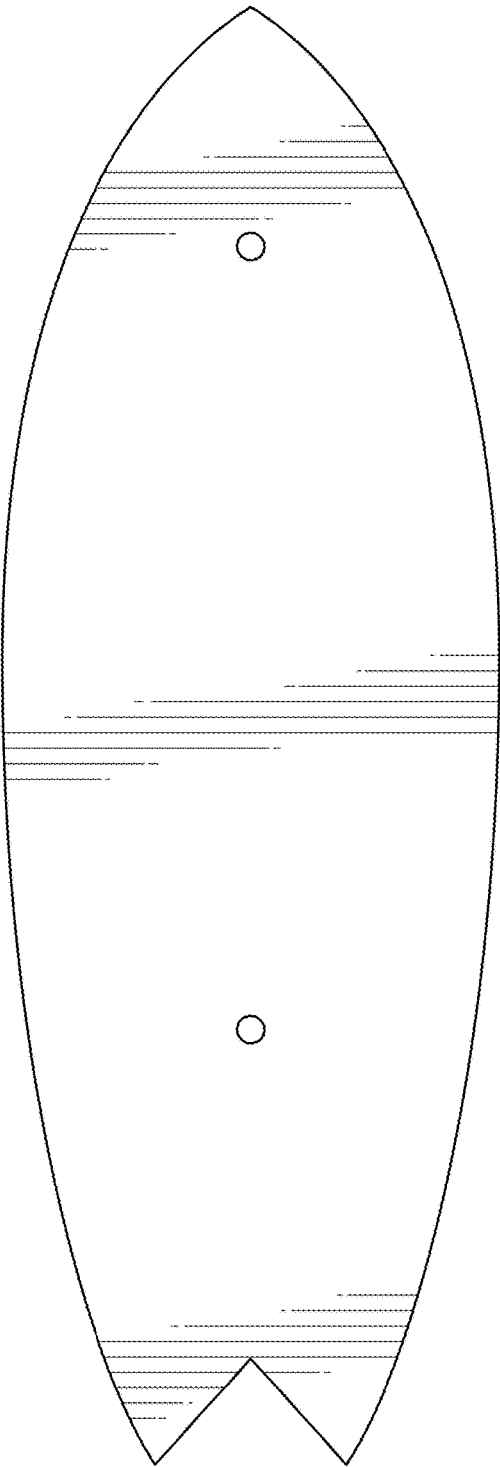

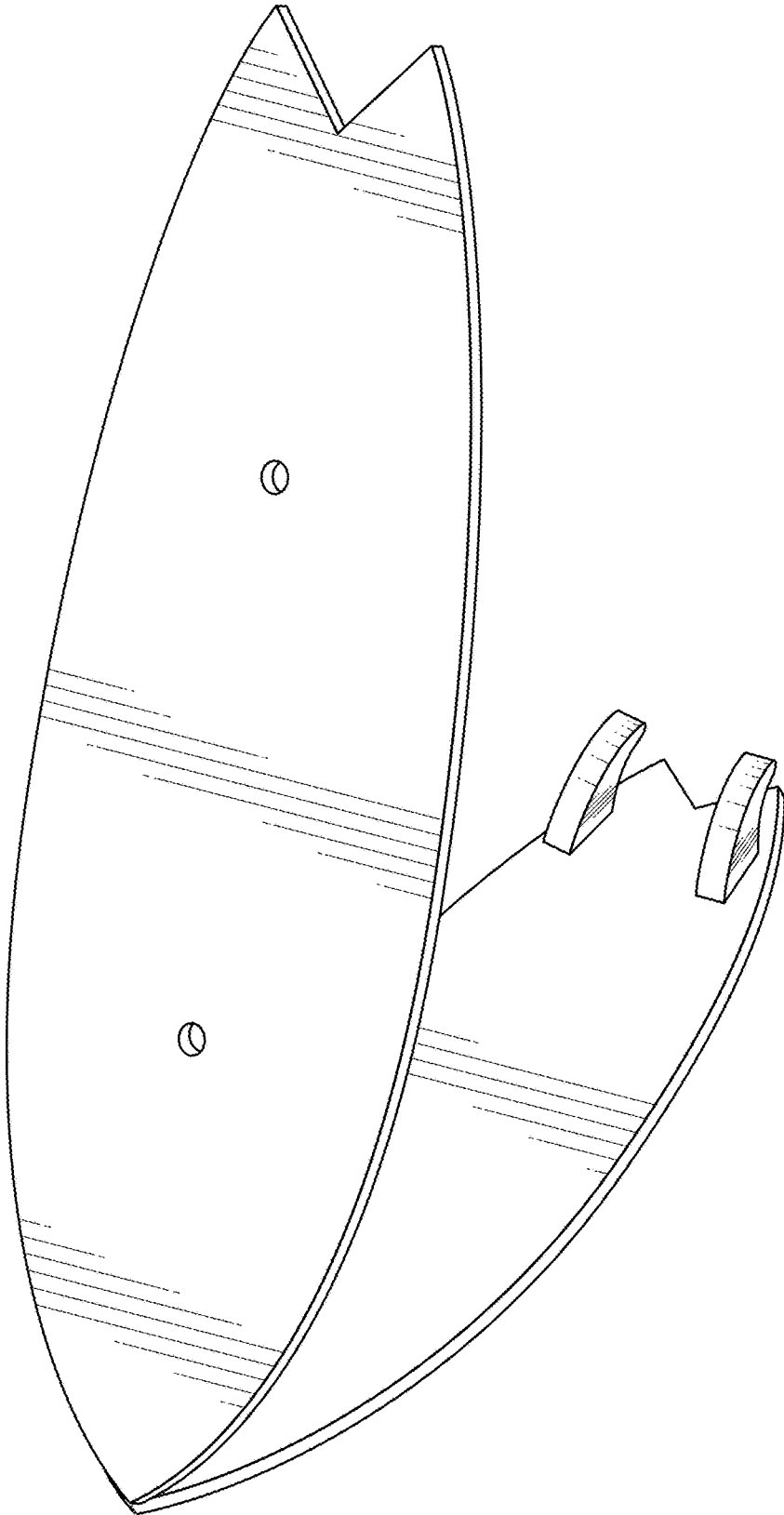

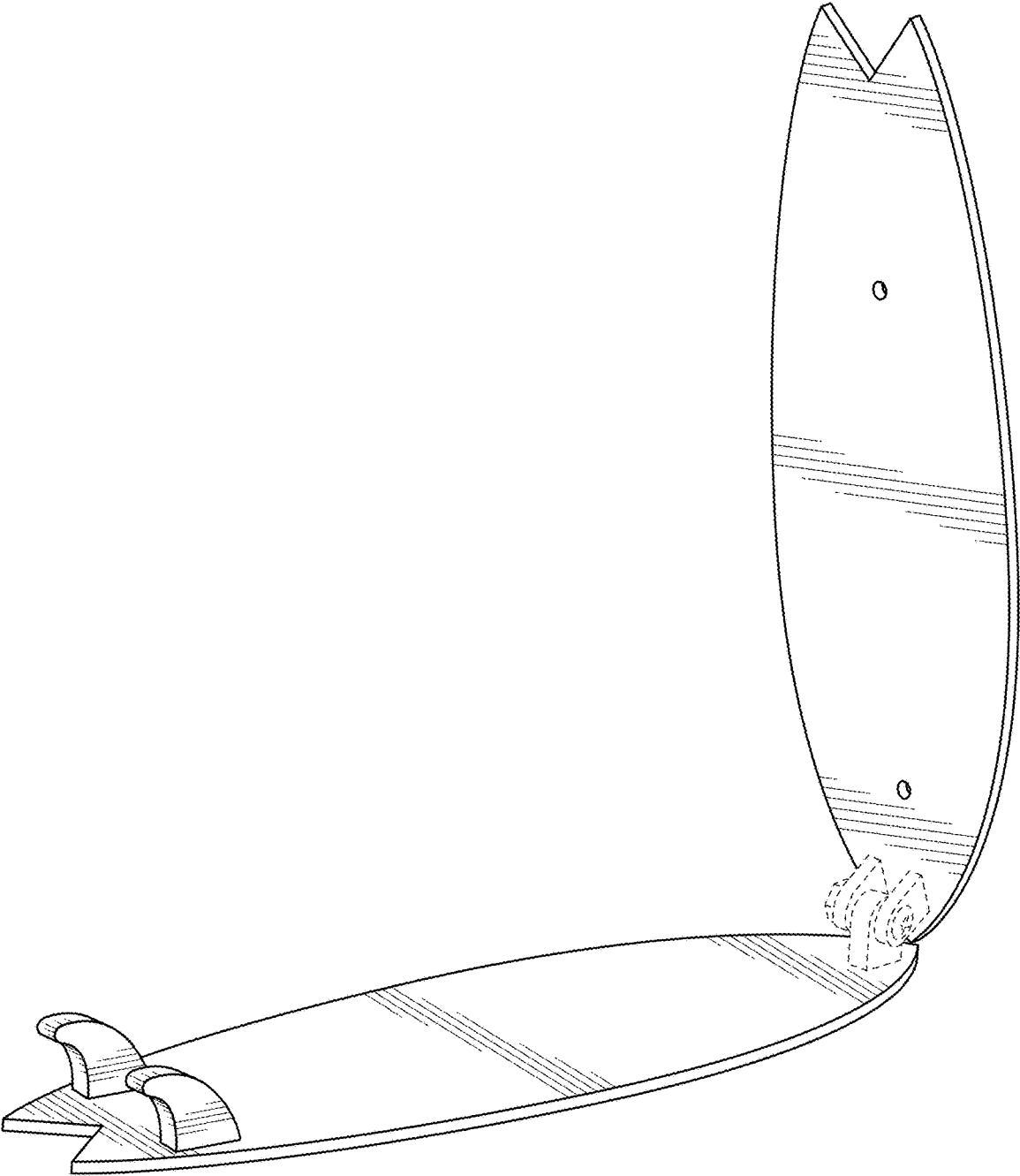
