The ornamental design for a pet toy, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a pet toy, showing my new design;

FIG. 2 is a bottom perspective view thereof, illustrated in a condition of use;

FIG. 3 is a left-side elevational view thereof, the right-side elevational view, front elevational view, and rear elevational view all being identical thereto;

FIG. 4 is a top plan view thereof;



FIG. 5 is a bottom plan view thereof;














