DESCRIPTION

FIG. 1 is a perspective view of a solar roadway luminaire according to an embodiment of the present invention.

FIG. 2 is front elevation view of the solar roadway luminaire of FIG. 1.

FIG. 3 is rear elevation view of the solar roadway luminaire of FIG. 1.

FIG. 4 is right side elevation view of the solar roadway luminaire of FIG. 1.


FIG. 5 is left side elevation view of the solar roadway luminaire of FIG. 1.














