(57) **CLAIM**

I claim the ornamental design for a crescent-shaped pillow, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a crescent-shaped pillow, according to an embodiment of the invention;

FIG. 2 is a top view of the crescent-shaped pillow of FIG. 1;

FIG. 3 is bottom view of the crescent-shaped pillow of FIG. 1;

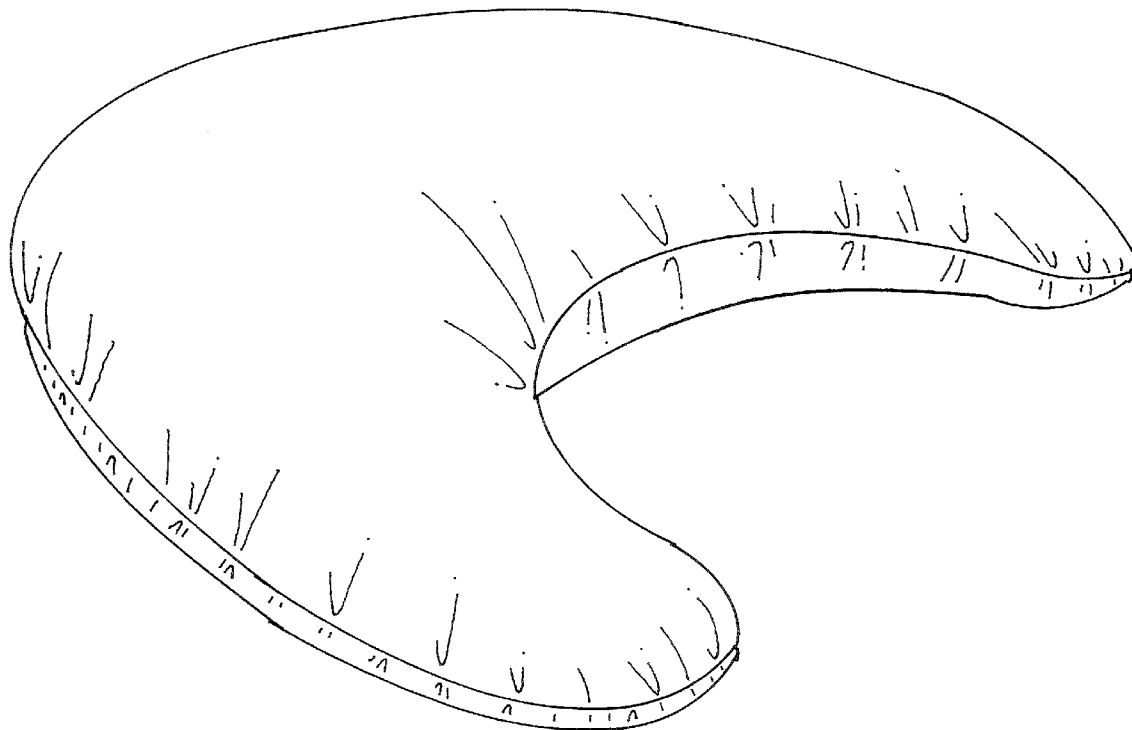
FIG. 4 is a front view of the crescent-shaped pillow of FIG. 1;

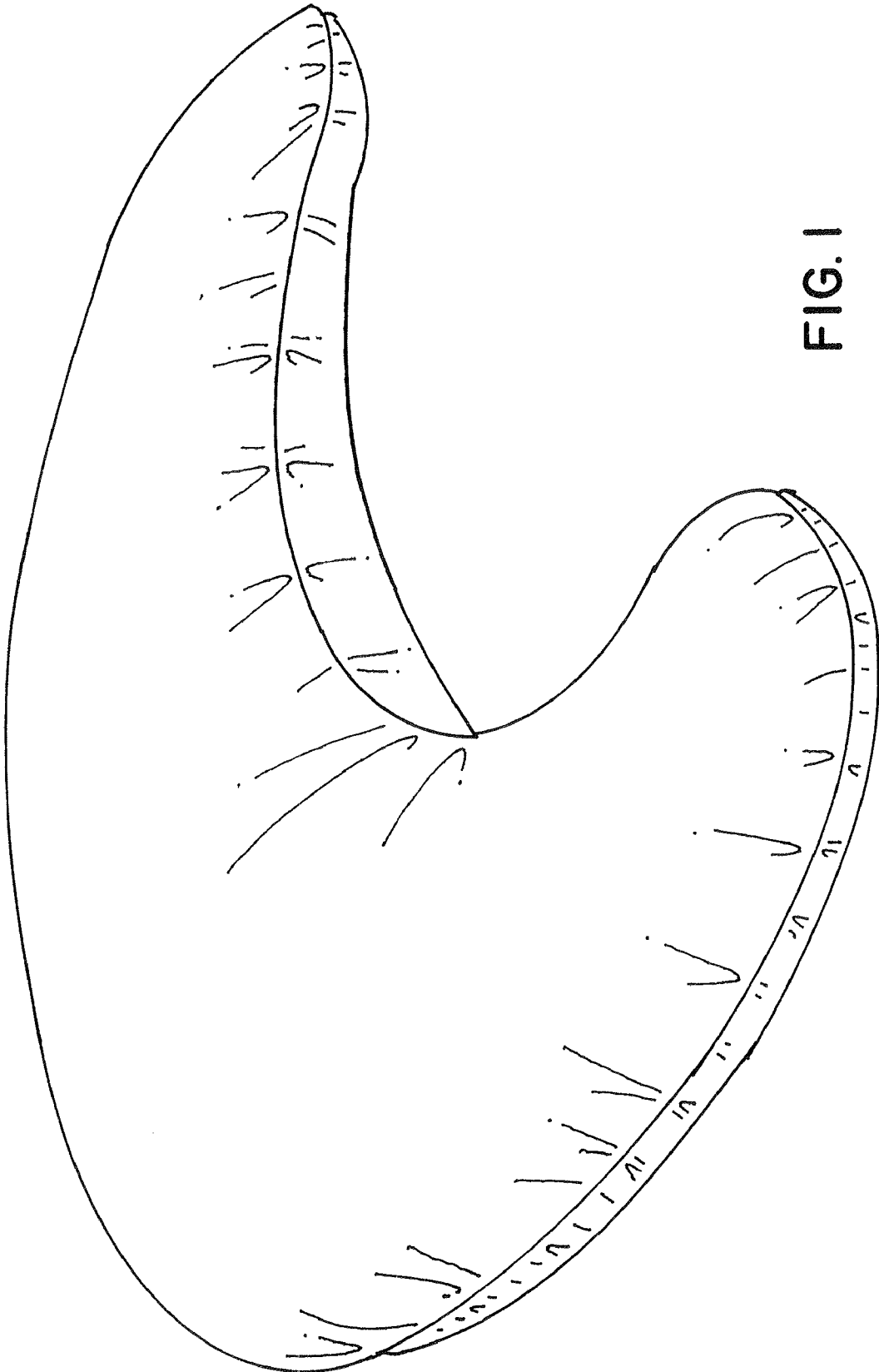

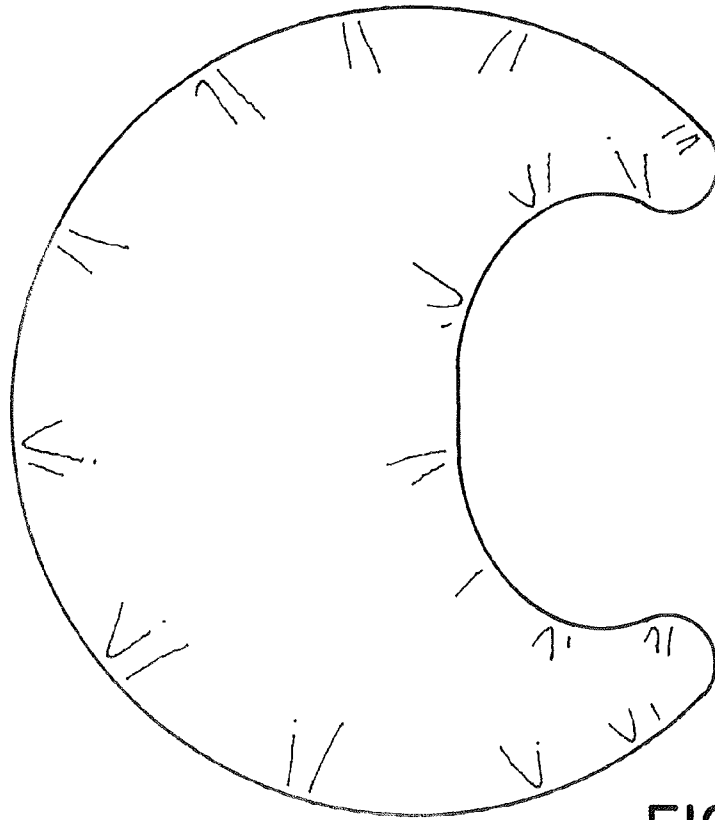

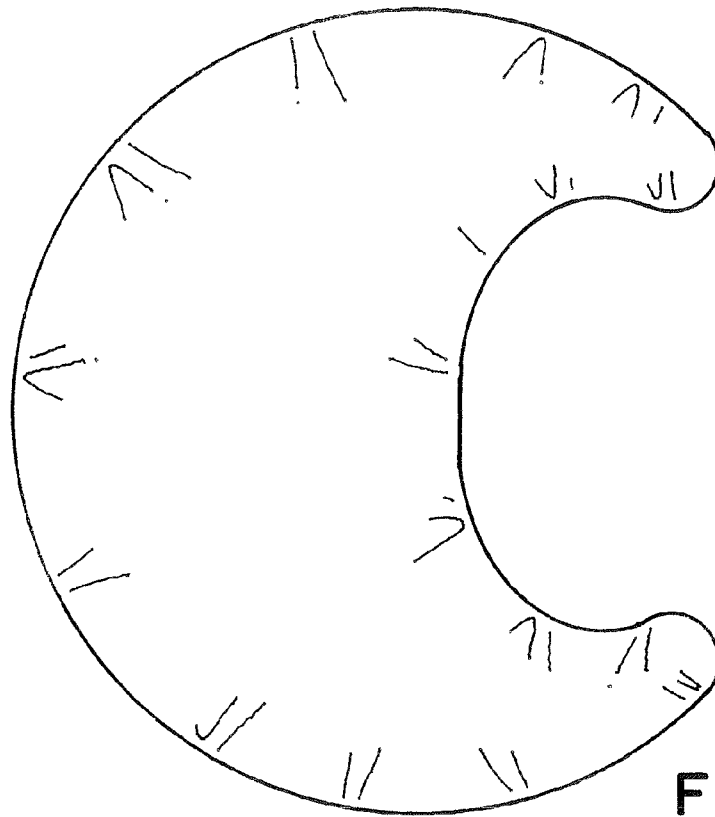

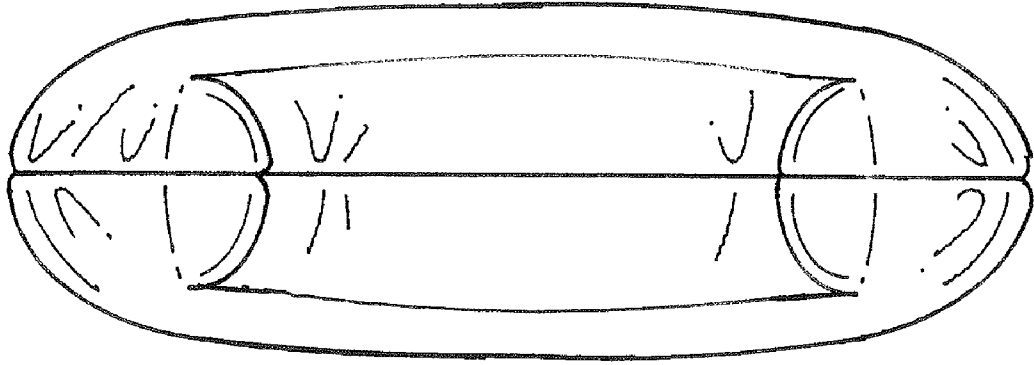

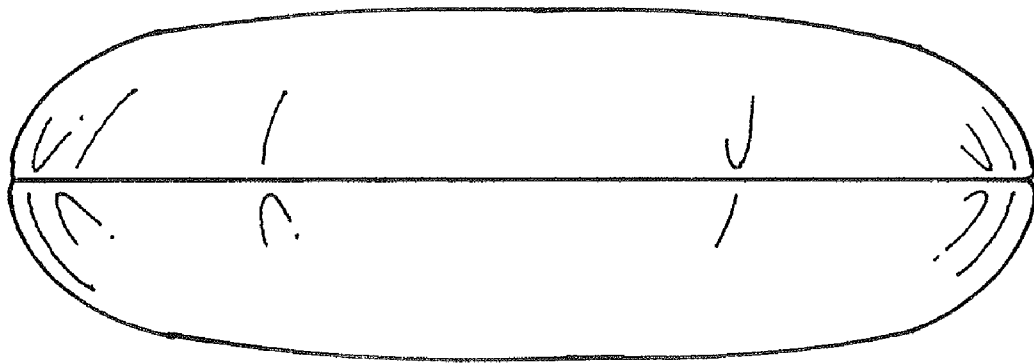

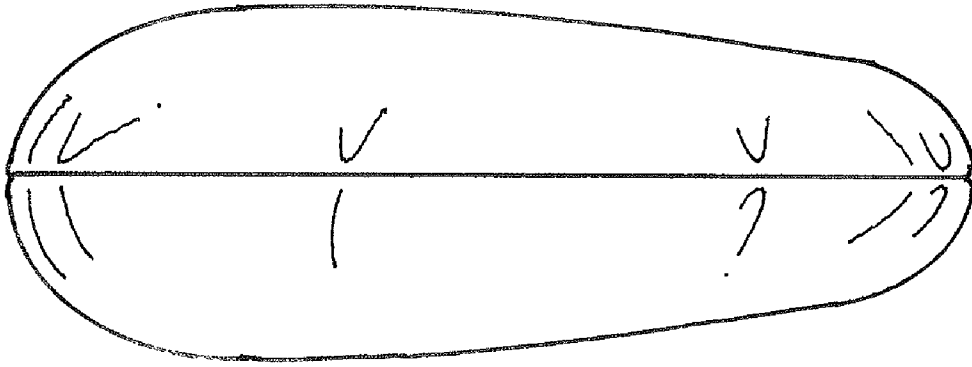

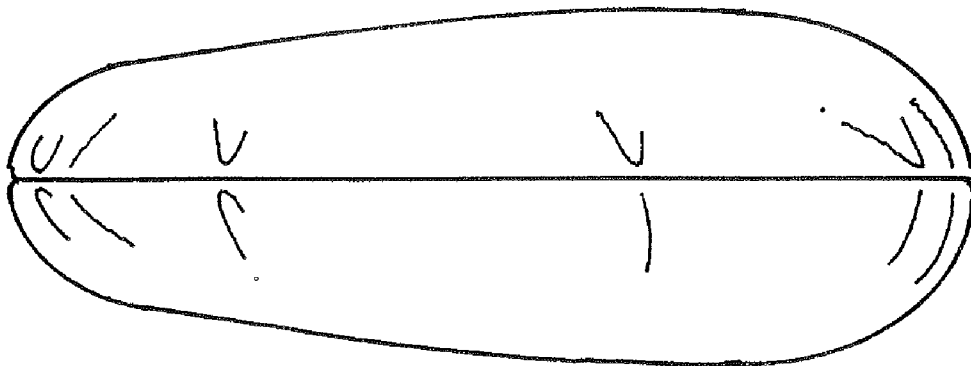
