
(57) **CLAIM**

The ornamental design for a shipping label holder, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of a shipping label holder showing my new design;
FIG. 2 is a front plan view thereof;
FIG. 3 is a back plan view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top elevation view thereof; and,
FIG. 7 is a bottom elevation view thereof.












