
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a bottle with label showing our new design;  
 FIG. 2 is a front elevation view thereof  
 FIG. 3 is a left side elevation view thereof;  
 FIG. 4 is a right side elevation view thereof;  
 FIG. 5 is a rear elevation view thereof;  
 FIG. 6 is a top plan view thereof;  
 FIG. 7 is a bottom plan view thereof;  
 FIG. 8 is a front perspective view of a second embodiment of a bottle with label showing our new design;  
 FIG. 9 is a front elevation view thereof  
 FIG. 10 is a left side elevation view thereof;  
 FIG. 11 is a right side elevation view thereof;  
 FIG. 12 is a rear elevation view thereof;  
 FIG. 13 is a top plan view thereof; and,  
 FIG. 14 is a bottom plan view thereof.




























