(57) **CLAIM**

The ornamental design for a neck portion of a bottle, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front, left side, and top perspective view of a neck portion of a bottle showing my new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a top plan view thereof; and,














