
(57) **CLAIM**
What is claimed is the ornamental design for the sliding door dresser, as shown and described herein.

DESCRIPTION

FIG. 1 depicts a perspective view of the sliding door dresser; FIG. 2 depicts a front view of the sliding door dresser of FIG. 1; FIG. 3 depicts a bottom view of the sliding door dresser of FIG. 1; FIG. 4 depicts a top view of the sliding door dresser of FIG. 1; FIG. 5 depicts a back view of the sliding door dresser of FIG. 1; FIG. 6 depicts a left side view of the sliding door dresser of FIG. 1; and, FIG. 7 depicts a right side view of the sliding door dresser of FIG. 1. The broken lines in FIGS. 1-7 form no part of the claimed design.










